Trustees' Report for the Year Ended 5 April 2025

The trustees present their report with the financial statements of the charity for the year ended 5 April 2025. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102).

Objectives and activities

Main Activities

Our main objective is to build an adaptive sports hub which we will then manage for the benefit of a variety of local organisation and groups especially those that are under-represented such as those with learning and physical difficulties.

Planning permission for the building of the hub was obtained on 24th June 2024. We were then in a position to be able to focus on obtaining a lease of land at Greenpark Avenue King's Lynn (opposite Lynnsport and next to the tennis courts) owned by the Borough Council of Kings Lynn and West Norfolk. Unfortunately this has taken rather longer than we anticipated although the lease is expected to be signed within the next few weeks.

Without planning permission and a lease it has proved difficult to obtain significant capital funding from grants. We have relied on fund raising from generous local supporters to cover operational costs and some capital costs plus we did receive a grant of £50,000 from the Norfolk Community Foundation to support the costs associated with the first phase of progressing the building plans for a fully adapted sports hub. This has allowed us to instruct an architect and structural engineer.

We have visited and sought best practice ideas from other similar charities and continue to have close contact with these charities.

The delays with regard to planning permission and the lease led us to consider how we might provide some type of sports facility that was fully accessible without the need for a building. We were offered some adapted cycles that needed repair and a new container to store the bikes. We are grateful to both the donor of the adapted cycles and the donor of the container as well as to Lynnsport for allowing the container to be housed on their premises. Since the year end we have set up Ride United which provides adapted cycling sessions suitable for all ages, abilities and disabilities.

Achievements and performance

Charitable activities

As detailed above building work has not yet commenced as we needed to obtain a lease on the land as well as planning permission in order to be able to move forward. This has taken far longer than expected but we do now have Heads of Terms agreed and anticipate that the lease will be signed within the next few weeks.

Only when we have successfully secured funding can building work commence and so we will only be able to start building when we have the funds in place to complete the project and so the next phase is fund raising from local business and the community and grant applications.

Our website is now established and apart from highlighting what we are doing it offers links to other organisations providing facilities for the disabled.

The work to set up Ride United commenced March 2025 and culminated in the club starting weekly adapted cycling sessions in September 2025.

Financial review

Principal funding sources

The charity managed to obtain generous unrestricted donations from local charities, businesses and individuals plus there was the grant of £50,000 from the Norfolk Community Foundation. This gave us sufficient funding to be sure we could cover our operational costs and progress the building plans. It has also allowed us to work to set up Ride United which means we can provide a sports facility for the disabled now.

- Agree the lease
- Apply for capital funding - grants and donations
- Work with professional advisers to ensure we have the structure in place to deliver the project.
- Continue to raise the profile of the charity so that we can find committed volunteers and obtain donations
- Showcase the work of Ride United so that more people use and are aware of the facility

1. Accounting policies

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Income

2. Structure, Governance and Management

Governing Document:

The Adapted Sports Hub Trust is governed by its Constitution adopted on 03 October 2022.

Trustee Recruitment and Appointment:

Trustees are appointed in accordance with the charity's governing document. New trustees are elected by the existing board members and are provided with an induction program to understand their responsibilities and the charity's operations.

3. Objectives and Activities

Charitable Objectives:

The primary objectives of The Adapted Sports Hub Trust are to further or benefit the residents of King's Lynn and the neighbourhood, without distinction of sex, sexual orientation, race or of political, religious or other opinions by associating together the said residents and the local authorities, voluntary and other organisations in a common effort to advance education and to provide facilities in the interests of social welfare for recreation and leisure time occupation with the objective of improving the conditions of life for the residents. In furtherance of these objects but not otherwise, the trustees shall have power: to establish or secure the establishment of a community centre and to maintain or manage or co-operate with any statutory authority in the maintenance and management of such a centre for activities promoted by the charity in furtherance of the above objects.

Main Activities:

In the year ending 5th April 2024 the focus was on obtaining planning permission for the building of the hub. This was achieved on 25th June 2024. Until planning permission was received we were restricted in that it was not appropriate to try and raise funds for the building. The £10,000 income for the year was a single donation received on 26th March 2024 and was not utilized until after planning permission had been obtained.

The Adapted Sports Hub Trust is not yet operational, the planned activities will include the completion of the build and the operation of the Sports Hub for the benefit of groups or individuals with learning or physical disabilities.

4. Achievements and Performance

As detailed above The Adapted Sports Hub Trust has not yet commenced operations. Planning permission has been obtained and negotiations regarding a lease are expected to be completed shortly. We need the lease in order to be able to obtain grant funding as well as donations from local companies and individuals and only once we have successfully raised the funds can the building work commence. We are looking to see how we can work with Lynnsport to provide facilities and activities prior to the completion of building work and we are creating a website that will include details of activities for those with learning or physical disabilities provided by other organisations. Future reports will detail the achievements and impact of our activities once they are underway.

5. Financial Review

Principal Funding Sources:

The charity was funded through initial donations from trustees and supporters until the £10,000 donation from another charity was received at the end of March 2024. This has allowed us to commit to a website and commence work on implementing our strategy for raising the funds needed to start the building.

Investment Policy:

All funds not immediately required for the charity's activities are held on deposit with a bank.

6. Plans for the Future

- Agree the lease and contact / visit other similar charities for best practice ideas
- Apply for appropriate grants – from marketing to build costs to training
- Raise the profile of the charity to obtain commitment and donations from the local community – business, charities and individuals
- Establish activities that do not require the planned facilities of the building in liaison with other organisations and charities e.g. cycling.
