The information stand and wooden replica LVT4 have also attended Moulton Chapel Tulip Parade, Malvern Militaria Show, Bovington Tank Festival and various 1940s weekends in Lincolnshire and Cambridgeshire.

This year also saw us taking over the organising and running of the Crowland and Thorney 1940s weekend. We are working with a small sub-committee to present a well respected new event. This presents new opportunities for us to grow the association.
