

Our church is located at Sidwell Street Methodist Church, Exeter, EX4 6PH. Under the leadership of Pr. Johnson Babykutti, the church is committed to growing spiritually, in fellowship and service.

Our weekly schedule is packed with many activities that strengthen our faith and enable us to foster a sense of community:

- **Sunday Service:** Our main service is held every Sunday from 10:30am where we gather together for worship and learn from God's Word.
- **English Service:** A service held for youths from 09:00am to 09:30am to worship, pray and hear God's Word.
- **Sunday School:** Held every Sunday before our main service from 09:30am where we focus on teaching the younger generation and bringing them up with Bible teachings.
- **Cottage Meeting:** These gatherings are held in homes of our church families on a day of their choosing from 06:00pm.
- **Chain Prayer:** Starting from 8am every Saturday to 8am Sunday, our congregation takes part with each person choosing a time slot to pray our church and the city of Exeter.

Our monthly schedule also includes few programs such as:

- **Fasting Prayer:** Occurring on the last weekend of every month, from Friday to Sunday, we dedicate this time to fasting, praying and seeking the presence of God.
- **Youth Meeting:** Held every third Sunday of each month, our youth are encouraged to showcase their talents and engage in programs that enable them to spiritually grow.
- **Street Evangelism:** Once a month, we take the Gospel to different places near Exeter sharing the message and love of Christ to those who may not know Him.

In addition to our weekly and monthly activities, we also have events that occur annually such as:

- **PYPA Anniversary:** A special day where both children and adults present a variety of programs, demonstrating their talents and skills.
- **Year End Meeting:** We hold a service on New Years Eve where we pray and welcome the new year that God has granted to us.

Our help and service also goes beyond the local community. Hebron Pentecostal Church is actively involved in Charity work, donating and funding ministry work in remote parts of North India. 
