The Trustees are pleased to present their report with audited financial statements for Atmosphere of Love (Charity Registration No **1200693**) for the year ended . Below is an outline of our achievements and finances.

Purpose and Achievements

The primary purpose of Atmosphere of Love is to advance the Christian Faith in accordance with the Statement of Beliefs in such ways as the trustees from time to time may think fit.

The Organisation is a church organization that holds regular services which consist of regular teaching of making attendants aware and knowledgeable about the principles, beliefs of the Christian faith. Prayers are offered to interested parties. This involves teaching on the principles of the Christian faith based on the statement of beliefs, corporate singing, and prayers that are offered to interested participants.

The worship experience takes place once a year and the name may be subject to change as the leadership may see fit depending on the theme.

Night of Spiritual Emphasis

These are congregational gatherings that bring the youth together for a time of worship and prayer. It takes place once a month or may vary. This event focuses on delving into various topics when it comes to purpose in order to motivate and equip young people
