1. Introduction

1.1 Charitable Objects

1.2 Overview (Executive Summary)

In our second year of operation we have made progress in all our areas of activity. To raise our public profile we have hosted several events and participated in many more. To disseminate information we have continued the rollout of our information leaflets and worked on revamping our website with professional help. We have made connections with other groups and organisations in the local area, and we have embarked on a number of long-term projects which will make a difference on the ground.

2. Activities & Achievements

2.1 Outputs & Outcomes

Events

This year we opted for a scaled-down offering for Great Big Green Week, feeling that the effort put in last year did not yield the results we were looking for in terms of public engagement. Once again the event itself was a success but attendance was patchy.

In March we organised and hosted a People's Assembly for a large group of students visiting Weymouth from Kingston University. We had a good panel of experts for the students to feed from and the assembly was appreciated by all.

We had a presence in one form or another at the Love Your Weymouth event, Weymouth College Environment Week, Summerfest at Redlands, a Park Community Centre public event and the Council for Nature demonstration at County Hall. We also conducted a talk for the local LETS group.

Information

We continued the distribution of our leaflets at all the events above, created some new ones and installed a leaflet spinner at Top Club. We also engaged a website professional to help redesign our homemade website.

Hub

Over the course of this year we have forged new connections with other local groups and organisations, and strengthened some existing relationships. We provided the use of our bank account for the Restore Nature Now coach to London and continue to do the same for the Friends of Weymouth Station, receiving the grants and repaying the expenses to this community project to install and maintain planting at the station.

We have developed our relationship with the town council such that we now have an acknowledged presence on the CEE working group.

In the early part of the year we explored the possibility of sharing a space with several other local groups at the "Triangle" in the Park District, although ultimately it was agreed the space wasn't quite suitable. Towards the end of the year we entered into a partnership with The Circular Shop and Transition Towns Weymouth and Portland, to expand the offering at the shop into organic food, reusable paint, fresh produce and preloved clothing, and to improve the existing tool hire service.

Projects

Climate Club is now an established listening circle taking place every Tuesday with a moderate but committed group of attendees.

Our *SpeakEasy* spoken word night has grown in popularity and has found a more natural home at Sticks and Bones gaming bar.

We have received some funding to finance the initial stages of our *Signposting the Future* project, which aims to create reuseable signposts addressing positive and negative possible futures.

Our *Community Resilience* project has made a start in finding out what state local emergency planning is in, with a view to initiating the creation of community emergency groups and plans.

We have also made a foray into *climate engagement with children*, having been invited to host a session at a local primary school.

Unfortunately our Retrofit/Community Energy project has been put on hold indefinitely because there just aren't enough public funds to make a real difference. Our Growing Connections project has been slowed due to problems with allotment officers and rules but continues nonetheless.

2.2 The Roles & Contributions of Volunteers

We are grateful for the many hours volunteers have spent helping to plan, organise and execute our events and activities. Without this valuable contribution of time, energy and expertise we would not have been able to achieve so much.

2.3 How the Public Have Benefitted

Although our reach is still smaller than we'd like, nonetheless we have had a significant number of informative interactions with the public either in person or via printed or electronic means. Our regular listening circle provides a forum for relieving climate anxiety and discussing possible actions, and *SpeakEasy* has provided a safe, welcoming space for the public to share their written work. The *Circular Shop* project has introduced a small number of people to organic, vegan food and the circular economy.

2.4 Looking Ahead

In the months ahead we hope to build on the work with the *Circular Shop* and take steps towards creating a large "Re-Use Centre", in conjunction with other groups and the local councils.

We aim to convert some of the positive energy at *SpeakEasy* and *Climate Club* into real-world action, and we hope to progress our *Community Resilience* project.

Hopefully our new website will be ready soon and we can work on improving our online and social media presence.

3. Financial Review

3.1 Financial Position

Leaving aside funds held for external projects, our income this year has been very small at just £244 with £610 in unreserved funds. Outgoings have also been quite low but more fundraising in the coming year would be prudent.

3.2 Details of Any Funds Materially in Deficit

The Charity has no funds which are materially in deficit.

3.3 Policy on Reserves

As our income and outgoings are very small, and as we have no overheads, the Trustees do not currently consider it necessary to have a reserves policy. However this stance will be reviewed

regularly to ensure there is a balance between holding sufficient contingency funds, and ensuring that donations and funding are spent in a timely manner on the objectives of the charity.

3.4 Principal Sources of Funding

3.5 Remuneration of Trustees

All Trustees act in a voluntary capacity and receive no remuneration or other material benefits from their services to the Charity.

5.2 Statutory Declaration



1.2 Overview (Executive Summary)

In our first year we have begun the work of building the profile of the charity so that it becomes a trusted source of information, and we have started on the path of educating the public (in various ways) about some of the issues surrounding climate change and nature loss.

Our reach might be said to have been fairly limited but we have laid the foundations for greater success next year, when several of our plans will come to fruition.

2. Activities & Achievements

2.1 Outputs & Outcomes

Our first year has seen steady progress towards some of our objectives. The first half of the year was dedicated to preparing for Great Big Green Week, for which we were generously granted the use of St Nic's Gallery. We put on an entire week of events including parties, a spoken word night, talks, film nights and workshops. Although hard work for the trustees and volunteers the week was a success in terms of disseminating information, raising the profile of the charity and raising money (the donations during this week provided about 1/3 of the total donations for the year).

Great Big Green Week also saw the first outing for our set of information leaflets on various topics relating to the climate and ecological emergency. These seem to have been well-received with positive feedback from all those who have commented. We obtained funding from Weymouth Town Council for printing costs and purchasing suitable display units, and have an ongoing display at the Palm House café, with other sites in the pipeline.

In September we had a stall and gave a talk at the inaugural Dorset Conference of Parties. We also helped with the Let Music Unite festival in support of refugees. Both events helped to raise our profile.

Although outside of the current reporting period, in October we held a Toy Swap at the Palm House café which helped to demonstrate an alternative approach to consumerism. We also held our first Speakeasy spoken word night which was a great success, providing an opportunity to distribute our information leaflets and tell people about our mission. In November we ran a stall at Weymouth College as part of their environment week, where we had the opportunity to engage with students.

Throughout the year we have been fostering a relationship with the town council CEE working group, and we have been working on our website which we think will prove a great resource in time.

In the main our activities have been of a type for which it is difficult to quantify outcomes, though we now have a mailing list of over 200 people and can say that approximately the same number attended our various events.

2.2 The Roles & Contributions of Volunteers

We are grateful for the many hours volunteers have spent helping to plan, organise and execute our events and activities. Without this valuable contribution of time, energy and expertise we would not have been able to achieve so much.

2.3 How the Public Have Benefitted

Our information leaflets have had an impact beyond the local area. A group in the Blandford area are interested in replicating the idea, and the Trainline company have asked if they can be included in future versions. Once the website has been professionally redesigned we hope this influence will spread further still, with the online versions being available for anyone to read.

2.4 Looking Ahead

In the coming year we hope to see some real-world progress on our Retrofit, Community Resilience and Growing Connections projects. The website content should become more complete, providing valuable resources for everyone in the local community and beyond. We will be completing the rollout of our information stands and putting on more pop-up events throughout the year.

3. Financial Review

3.1 Financial Position

Our income this year has been quite small (£1366 in donations and £2990 in grant funding) but as we have no overheads (such as rent, utility bills and salaries) we are in a sound financial position. Our main expenditure has been on printing (£810) and we would expect to spend at least as much again in the coming year.

3.2 Details of Any Funds Materially in Deficit

The Charity has no funds which are materially in deficit.

3.3 Policy on Reserves

As our income and outgoings are very small, and as we have no overheads, the Trustees do not currently consider it necessary to have a reserves policy. However this stance will be reviewed regularly to ensure there is a balance between holding sufficient contingency funds, and ensuring that donations and funding are spent in a timely manner on the objectives of the charity.

3.4 Principal Sources of Funding

By far our biggest source of income was the grant from Weymouth Town Council, which is restricted in its use to funding the printing of leaflets and purchasing leaflet stands. Great Big Green Week saw us generate nearly £500 in donations. In the coming year we plan to apply for more substantial funding and to find ways to generate more donations.

3.5 Remuneration of Trustees

All Trustees act in a voluntary capacity and receive no remuneration or other material benefits from their services to the Charity.

Out-of-pocket expenses necessarily and reasonably incurred by Trustees in promoting the purposes of the Charity are reimbursed at cost.
