Easter and Christmas provided opportunities for events and services to engage the community, including activities for children and families.</p> <p>We continued to developed our online presence with church services being broadcast on a dedicated YouTube channel each week. This has been a great benefit to those in our community who are housebound, unwell or away travelling.</p> <p>We launched a significant new initiative at the end of the period, in planting a new congregation in the town of Ventnor, which involved us appointing a further member of the pastoral team and providing weekly Sunday afternoon services and midweek activities in a second location. We look forward to expanding on this in the current period.</p> <p>We provided ongoing support and training to our staff team through a leaders conference.
