TRUSTEES' REPORT

The trustees present their annual report and financial statements for the year ending 31 July 2025. The financial statements have been prepared in accordance with the Charities Act 2011, the Statement of Recommended Practice for charities preparing their accounts in accordance with FRS 102, as well as the accounting policies set out in the notes to the financial statements below.

OBJECTS AND CONSTITUTION

The constitution of the charity was established by its trustees on 18 September 2022 and its objects are to advance, improve, develop and maintain public education in, and appreciation of, the art and science of music in all its aspects by any means the trustees see fit, including through the presentation of public events such as concerts. The trustees applied for formal registration as a charity on 31 October 2022 and The Aubrey Singers was formally registered as a charity on 7 November 2022 with the registered charity number 1200924.

ACTIVITIES AND PUBLIC BENEFIT

Since registration of the choir, The Aubrey Singers, as a charity, the trustees have continued to pay due regard to the guidance issued by the Charity Commissioners in deciding what activities the charity should undertake. These activities include promoting fellowship amongst the members of the choir, endeavouring to achieve the highest standards in musical performance, and encouraging as many members of the public as possible both to join the choir and to attend concerts from time to time. Where appropriate, subscriptions are waived or reduced to support singers who would otherwise not be able to join the choir, and subscriptions for those under 27 years of age are substantially reduced. Tickets to concerts are offered at a reduced rate for younger persons in order that as many as possible are able to attend. During the period the trustees instituted choral scholarships to encourage and allow younger singers to rehearse and sing with the choir.

Over the past year the choir has grown both in membership and artistic ambition, performing to increasingly demanding standards both new works like Martin Palmeri's *Misatango*, which was a sell-out concert in November 2024, as well as more established repertoire, like Brahms' *Ein Deutsche Requiem* where our audience attendance exceeded expectations. On both occasions

we recruited young professionals in the early stages of their careers to sign solos. In June 2025, we held our first Come and Sing Day (Mozart Requiem) and this attracted singers from our local community, many of whom have now subsequently joined the choir, thereby increasing our membership to 55 members at the end of this reporting year. For this Come and Sing Day we invited our young scholars to sing solos, duets and quartets, thereby showcasing their talent in a friendly informal environment.

During the period we were very fortunate to be able to attract donations towards our activities in the sum of £15,000 and this forms part of our Income and Expenditure Account set out below. Naturally we are delighted to have been able to attract this level of funding and we will report in due course on the activities we have been able to pursue as a direct result of this level of funding.

#### RESERVES AND GOING CONCERN

The trustees are acutely aware of the need to maintain financial discipline and at any one time endeavour to have available cash reserves of sufficient amount to allow the trustees to confirm that The Aubrey Singers is in a position to meet all its financial obligations for the 12 month period following the date of approval of these financial statements. The trustees therefore consider the charity to be a going concern.



The charity has taken advantage of the provisions in the SORP not to prepare a Statement of Cash Flows. The financial statements are prepared in UK sterling, the functional currency of the charity, under the historical cost convention, and adopting the accounting policies set out below. The financial statements are prepared on a going concern basis, the trustees having reasonable grounds to expect the charity to continue for the foreseeable future.

#### INCOME AND EXPENSE

Income is recognised on receipt of monies in the bank account of the charity, whether it be membership subscriptions, donations or sales of concert tickets. Expenses are accrued as invoiced and paid promptly.


