All activities were designed to advance emotional wellbeing, confidence, and recovery, and were carried out with a clear commitment to public benefit.</p> <p>We delivered a range of creative wellbeing sessions that provided women with safe, supportive spaces to rebuild confidence, express themselves, and develop emotional resilience. These sessions included arts-based activities, journaling, gentle group work, and confidence-building exercises.</p> <p>The programmes were designed to reduce isolation, improve mental wellbeing, and support recovery after trauma. We facilitated peer-led and staff-supported group activities that helped women connect with others who share similar experiences.</p> <p>These groups promoted belonging, reduced loneliness, and encouraged mutual support. They also offered opportunities for women to develop new</p>

		skills, share coping strategies, and build positive social networks.




