## Report on the activities of the charity

### Charity Objectives:

1. Create and improve habitats within the village of Swanwick, Swanwick parish council boundary, in Derbyshire and the immediate surrounding area, neighbouring villages and towns, Ripley, Alfreton, Pentrich, Leabrooks, Riddings, Somercotes, for biodiversity. 2. Engage residents of Swanwick with nature and provide educational opportunities about local and national ecology.

### Charity Achievements During The Year:

#### *Purchase of a small woodland*

We put together a business case to Derbyshire County Council who were disposing of a small woodland in Swanwick. We were concerned that should the woodland fall into the wrong hands it would be damaged or lost. We fund raised and were successful in purchasing the woodland. The woodland will be managed to benefit wildlife, help alleviate flooding in the local area and benefit of local residents.

#### *Wildlife Meadow*

A wildlife meadow was maintained within the local recreational ground. This was a Swanwick Parish Council project, but Swanwick Wildlife Group provides voluntary time and expertise to assist with this, and in line with the charity objectives of education, has involved local scout and brownie groups.

#### *Minster Way*

Funding was provided to Swanwick Wildlife Group to manage a public area within a private estate owned by Hallam Homes. This included money for planting and decorating of troughs. The public was involved with the planting and upkeep of the troughs and the surrounding pebbled area including planting of shrubs.

#### *Wildlife Exhibition*

A fundraising event was held in February 2024 with local exhibitors and the primary school to raise awareness of local wildlife through art. A local artisan baker provided cakes which were provided along with tea and coffee in exchange for donations.

### Volunteer Help:

The charity has an active FaceBook group which offers volunteer days to help create and maintain the wildlife meadow and troughs, for example. For those not on FaceBook, emails are sent to those who have provided an email address subscribing to information on volunteering opportunities.

The treasurer trustee is a chartered accountant and prepares the accounts on a voluntary basis.



## Report on the activities of the charity

### Charity Objectives:

1. Create and improve habitats within the village of Swanwick, Swanwick parish council boundary, in Derbyshire and the immediate surrounding area, neighbouring villages and towns, Ripley, Alfreton, Pentrich, Leabrooks, Riddings, Somercotes, for biodiversity. 2. Engage residents of Swanwick with nature and provide educational opportunities about local and national ecology.

### Charity Achievements During The Year:

#### *Garden Wildlife Award*

A project was started to encourage local residents to garden for wildlife. This included providing criteria to meet, which would result in residents being awarded with a plaque to put on their property to show they were gardening for wildlife. Funding was obtained from Swanwick Parish Council through a S137 Grant.

#### *Wildlife Meadow*

A wildlife meadow was created within the local recreational ground. This was a Swanwick Parish Council project, but Swanwick Wildlife Group provided voluntary time and expertise to assist with this.

#### *Minster Way*

Funding was provided to Swanwick Wildlife Group to manage a public area within a private estate owned by Hallam Homes. This included money for planting wildflowers, and decorating of troughs. The public was involved with the planting of wildflowers and upkeep of the troughs.

#### *Wildlife Exhibition*

A fundraising event was held in January 2023 with local exhibitors and the primary school to raise awareness of local wildlife through art.

### Volunteer Help:

The charity has an active FaceBook group which offers volunteer days to help create and maintain the wildlife meadow and troughs, for example.


