In Nigeria, we developed a partnership with Jago Community, which is in the South-Western region of the country.

Our Nigerian Representatives held meetings with the Chief of the Community, alongside his Board and staff members of the only school (primary and secondary) in the community, gaining understanding of their urgent needs.

In the UK, we have an existing relationship with a Home Education network, which we are looking to build on with the view to create a mutually-benefitting partnership which improves our work in Nigeria.

At this initial phase, our focus has been on devising strategies which will help us achieve the objects of the charity.

- supporting existing schools in Africa, including building new structures, if required, **improving standards and supporting teacher training**
- providing basic supplies, such as children's clothes and shoes, books and other personal or educational supplies to help families, children and schools in Nigeria that are unable to afford them.
- providing payments of fees for instruction, examination, or other expenses connected with formal education, vocational training, language, literacy, numerical or technical skills
