In the prior year there were exceptional donations in the year of £62,816 relating to the merger of the HCR Charity and the Hewitsons Charity into the current CIO. HCR LLP donated £3,204 (2024: £2,998) of client residual balances to the trust in the year. During the year the trust did not give any individual grants in excess of £6,000. The HCR Hewitsons Charity raised £55,879.
