Financial Review

Review of the charity's financial position at the end of the period	Para 1.21	The charity has achieved a strong financial recovery during the reporting period, with income doubling to £248,078 compared to the prior year (£121,648). This growth was driven primarily by donations and legacies (£222,539), highlighting successful fundraising efforts. Expenditure was significantly reduced to £51,038 from £152,079 in the previous year, reflecting improved cost management. The charity posted a surplus of £197,040, a significant turnaround from the prior year's deficit of £30,431, leading to total funds carried forward of £166,609. Restricted funds make up the majority (£155,227), while unrestricted funds stand at £11,382. Despite this success, income remains heavily reliant on donations, and programmatic spending on charitable activities (£2,996) is relatively low. In conclusion, the charity is in a much stronger financial position, but diversifying income streams and increasing spending on mission-related activities could further enhance sustainability and impact
