My examination was carried out in accordance with the General Directions given by the Charity Commission.



1.0 Introduction

- 1.1 The Parochial Church Council (PCC) of the Ecclesiastical Parish of St Ia, St Ives (Diocese of Truro) is a registered charity (number 1201438). It is known as St Ia or St Ives PCC and manages the day to day working of St Ia Parish Church in St Ives.
- 1.2 St Ia is one of two churches in the St Ives Anglican Benefice and works closely with its sister church, St John's in-the-fields, to fulfil its aims and purposes.

2.0 Aims and Purposes

- 2.1 Our primary purpose as a church is the promotion of the Gospel of our Lord Jesus Christ, according to the doctrines and practices of the Church of England. Our main charitable purpose is therefore the advancement of religion. The PCC is required by the Parochial Church (Powers) Measure 1956 to co-operate with the parish priest (vicar) in promoting in the parish the whole mission of the church, pastoral, evangelistic, social and ecumenical.
- 2.2 The parish church of St Ives is dedicated to St Ia, and is part of the Diocese of Truro within the Church of England. It is a grade I listed Medieval church with a capacity of 300. The PCC has maintenance responsibilities for this church and thereby preserves this historic building for future generations.
- 2.3 The PCC is also specifically responsible for the maintenance of number 5 and 6 Redfern Court, St Andrew's Street, St Ives.

3.0 Objectives and Activities

- 3.1 In carrying out their responsibilities, the members of the PCC have had regard to the Charity Commission's guidance on public benefit. As well as having an active church membership, St Ia is used by the community for key events, with special services held throughout the year, such as the annual Feast Service, and the Remembrance Day service. Special services are also held at Easter and Christmas, which many extra visitors and locals attend. The church also provides a focus for local people at key times in their lives, including baptisms, weddings and funerals.
 - 3.2 The worship at St Ia is primarily in the Anglo-Catholic tradition. This complements the worship on offer at our sister church, St John's in-the-fields, which offers contemporary services in the low-church, Evangelical tradition. The regular services include said and sung weekly communion services and regular evening services. There are also services on the occasion of major Christian festivals and these are often well-attended by a wide range of people.
 - 3.3 We seek to ensure that the church building is open and staffed for as much of the week as possible. This is made possible by both a committed core of volunteers and through the café that we run in the garden or inside the church. We also provide regular midweek groups such as Christian Meditation, Art and Spirituality, Choir Rehearsals, and more informal worship evenings. Alongside our spiritual activities the church runs a programme of events enjoyed by many of our local community and by visitors to St Ives. These events include live music, live theatre, and our annual Christmas Market, 'Fair Mo'.
 - 3.4 The PCC has decided to make grants to other organisations from income across the year. These organisations should align with our own objectives but normally will be working in a different or across a wider geographical area. They will often be involved in providing relief in situations of extreme poverty or disaster. The PCC aims to make grants amounting to a minimum of £1,000 each year.
-

4.0 Achievements and Performance

- 4.1 The Sunday worship at St Ia continues to attract a committed core of regular members, augmented by regular and occasional visitors, especially during the summer months. There are challenges for the church by virtue of its placement in the middle of a parish with few permanent residents and with limited and expensive parking locally. However, its heritage and setting compensate for some of these disadvantages and the church remains very popular with visitors. Recent growth of the regular congregation has come primarily through the choir and the musical tradition of the church is of a high standard. The voluntary teams on a Sunday morning (the choir, the servers, the sidespeople, and the churchwardens) make the services possible but also provide meaningful opportunities for service for our congregants.
- 4.2 Our other events, café, and large services see many thousands of people coming through the church each year for reasons other than worship. This allows many to make use of the beautiful building and fosters a deeper connection between St Ia and the wider community.
- 4.3 By keeping the church open throughout the year there has been opportunity for local residents and visitors to St Ives to come into the building and to appreciate it as a place of peace, quiet prayer, and rich history.

5.0 Financial Review

- 5.1 The financial performance for the year is outlined in the attached accounts and has been subject to a review by the Independent Examiner.

Total unrestricted receipts were £134,654 (2023 - £178,627) and total unrestricted payments were £131,844 (2023 - £171,525). The main reason for the drop in both receipts and payments was that the income and expenses from the Café up to 31 July 2023 were included in the unrestricted receipts and payments, but after that date the trading activities have been carried out by St Ia Trading Limited. The surplus made by St Ia Trading Ltd which was donated to PCC funds is shown in the unrestricted receipts.

There was a surplus of unrestricted receipts over payments of £2,810, down from £7,102 in 2023.

A breakdown of the designated and restricted funds are shown in the accounts.

The overall operating position continues to be considered to be acceptable and viable.

- 5.2 The level of reserves currently held by St Ia remains at a high level due to the sale of the former Parish Rooms (the Sunday School building) and donations for salaried posts. The active project to invest some of this money into the maintenance and development of the church building to better allow us to continue and grow our mission and ministry including works to make the church more accessible is now underway and will see expenditure during 2025/2026. The minimum level of reserves will be reviewed when a final decision is made on the scope and cost of this project.
- 5.3 The PCC operates as a going concern.

6.0 Structure, Governance and Management

- 6.1 St Ia PCC is an unincorporated charity. The method of appointment of PCC members (who are the trustees of the charity) is set out in the Church Representation Rules. All Church attendees are encouraged to register on the electoral roll and stand for election to the PCC. PCC members are required to attend safeguarding training and to undergo a DBS check. They are also encouraged to attend relevant training days offered by the Diocese of Truro.
- 6.2 In 2024 the PCC had several employees; a Pioneer Minister (full-time until June and then part-time), a café manager (full-time), and assistant café-manager (part-time) as well as some temporary café staff, a Youth and Children's Worker (part-time), and administrator (part-time). In addition there was a Deanery Administrator (part-time) and three Deanery Youth and Children's workers employed from June (two part-time workers) and August (one full-time worker). These deanery employees were all employed on behalf of Penwith Deanery. There was also a regular cleaner and gardener (self-employed). The Reverend Keiren Marwood continued to work during the year within the benefice as a self-supporting Assistant Minister. Dr Andrew Hicks was licensed to St Ia as a Lay Reader during the year.

Whilst the Youth and Children's Worker is employed at St Ia, most of her work has taken place at St John's in-the-fields. This demonstrates the close partnership and cooperation between the churches in the benefice.

- 6.3 The PCC met six times in 2024. In between those meetings the churchwardens and treasurer met regularly with the vicar and the Pioneer Minister. Time critical decisions were made by circulation.

7.0 Administrative Information

- 7.1 St Ia Church is situated in St Ives, Cornwall in the centre of the old town on the harbour edge. It is part of the Diocese of Truro within the Church of England.

- 7.3 The PCC is a body corporate under the Parochial Church Council Powers Measures (1956) as amended and Church Representation Rules that came into force on 2 Jan 1957 and is registered as a charity with the Charity Commission (number 1201438).



My examination was carried out in accordance with the General Directions given by the Charity Commission.



1.0 Introduction

- 1.1 The Parochial Church Council (PCC) of the Ecclesiastical Parish of St la, St Ives (Diocese of Truro) is a registered charity (number 1201438). It is known as St la or St Ives PCC and manages the day to day working of St la Parish Church in St Ives.
- 1.2 St la is one of two churches in the St Ives Anglican Benefice and works closely with its sister church, St John's in-the-fields, to fulfil its aims and purposes.

2.0 Aims and Purposes

- 2.1 Our primary purpose as a church is the promotion of the Gospel of our Lord Jesus Christ, according to the doctrines and practices of the Church of England. Our main charitable purpose is therefore the advancement of religion. The PCC is required by the Parochial Church (Powers) Measure 1956 to co-operate with the parish priest (vicar) in promoting in the parish the whole mission of the church, pastoral, evangelistic, social and ecumenical.
- 2.2 The parish church of St Ives is dedicated to St la, and is part of the Diocese of Truro within the Church of England. It is a grade I listed Medieval church with a capacity of 300. The PCC has maintenance responsibilities for this church and thereby preserves this historic building for future generations.
- 2.3 The PCC is also specifically responsible for the maintenance of number 5 and 6 Redfern Court, St Andrew's Street, St Ives.

3.0 Objectives and Activities

- 3.1 In carrying out their responsibilities, the members of the PCC have had regard to the Charity Commission's guidance on public benefit. As well as having an active church membership, St la is used by the community for key events, with special services held throughout the year, such as the annual Feast Service, and the Remembrance Day service. Special services are also held at Easter and Christmas, which many extra visitors and locals attend. The church also provides a focus for local people at key times in their lives, including baptisms, weddings and funerals.
 - 3.2 The worship at St la is primarily in the Anglo-Catholic tradition. This complements the worship on offer at our sister church, St John's in-the-fields, which offers contemporary services in the low-church, Evangelical tradition. The regular services include said and sung weekly communion services and regular evening services. There are also services on the occasion of major Christian festivals and these are often well-attended by a wide range of people.
 - 3.3 We seek to ensure that the church building is open and staffed for as much of the week as possible. This is made possible by both a committed core of volunteers and through the café that we run in the garden or inside the church. We also provide regular midweek groups such as Christian Meditation, Art and Spirituality, Choir Rehearsals, and more informal worship evenings. Alongside our spiritual activities the church runs a programme of events enjoyed by many of our local community and by visitors to St Ives. These events include live music, live theatre, and our annual Christmas Market, 'Fair Mo'.
 - 3.4 The PCC has decided to make grants to other organisations from income across the year. These organisations should align with our own objectives but normally will be working in a different or across a wider geographical area. They will often be involved in providing relief in situations of extreme poverty or disaster. The PCC aims to make grants amounting to a minimum of £1,000 each year.
-

4.0 Achievements and Performance

- 4.1 The Sunday worship at St Ia continues to attract a committed core of regular members, augmented by regular and occasional visitors, especially during the summer months. There are challenges for the church by virtue of its placement in the middle of a parish with few permanent residents and with limited and expensive parking locally. However, its heritage and setting compensate for some of these disadvantages and the church remains very popular with visitors. Recent growth of the regular congregation has come primarily through the choir and the musical tradition of the church is of a high standard. The voluntary teams on a Sunday morning (the choir, the servers, the sidespeople, and the churchwardens) make the services possible but also provide meaningful opportunities for service for our congregants.
- 4.2 Our other events, café, and large services see many thousands of people coming through the church each year for reasons other than worship. This allows many to make use of the beautiful building and fosters a deeper connection between St Ia and the wider community.
- 4.3 By keeping the church open throughout the year there has been opportunity for local residents and visitors to St Ives to come into the building and to appreciate it as a place of peace, quiet prayer, and rich history.

5.0 Financial Review

- 5.1 The financial performance for the year is as outlined in the attached accounts and has been subject to a review by the Independent Examiner.

Total receipts were £180,992 (2022: £219,575) and total payments were £171,525 (2022: £257,094) leaving a surplus for the year of £(9,467). Payments included significant amounts toward the fundraising activities (the café and Fair Mo in particular) and also for the MMF (£46,967).

The overall operating position is considered to be acceptable and viable.

Turnover was significant again in the year reflecting the operation of the café (although the summer trading of that moved into a separate trading subsidiary during the year), September Festival concerts, and donations received against the employment of our administrative team.

- 5.2 The level of reserves currently held by St Ia is at a historic high due to the sale of the former Parish Rooms (the Sunday School building) and donations for salaried posts. There is an active project to begin to invest some of this money into the maintenance and development of the church building to better allow us to continue and grow our mission and ministry including works to make the church more accessible. The minimum level of reserves will be reviewed when a decision is made on the scope and cost of this project.
- 5.3 At year end the PCC had £55,019 of free cash in hand. There is £137,617 held as restricted reserves, restoration funds and in escrow from donations against future salary payments. A further £313,783 is held as restricted funds for redevelopment of the church following the historic sale of the former parish rooms
- 5.4 The PCC operates as a going concern.
-

6.0 Structure, Governance and Management

- 6.1 St Ia PCC is an unincorporated charity. The method of appointment of PCC members (who are the trustees of the charity) is set out in the Church Representation Rules. All Church attendees are encouraged to register on the electoral roll and stand for election to the PCC. PCC members are required to attend safeguarding training and to undergo a DBS check. They are also encouraged to attend relevant training days offered by the Diocese of Truro.
- 6.2 In 2023 the PCC had several employees; a Business Manager (full-time), a café manager (80% full-time), as well as some temporary café staff, a Youth and Children's Worker (part-time), and administrator (part-time), and a Deanery Administrator (part-time and employed on behalf of Penwith Deanery. There was also a regular cleaner and gardener (self-employed). The Reverend Keiren Marwood, has continued to work within the benefice as a self-supporting Assistant Minister. Dr Andrew Hicks is licensed to St Ia as a Lay Reader.

Whilst the Youth and Children's Worker is employed at St Ia, most of her work has taken place at St John's in-the-fields. This demonstrates the close partnership and cooperation between the churches in the benefice.

- 6.3 The PCC met six times in 2023. In between those meetings the churchwardens and treasurer met regularly with the vicar and the Business Manager. Time critical decisions were made by circulation or through the standing committee.

7.0 Administrative Information

- 7.1 St Ia Church is situated in St Ives, Cornwall in the centre of the old town on the harbour edge. It is part of the Diocese of Truro within the Church of England.

- 7.3 The PCC is a body corporate under the Parochial Church Council Powers Measures (1956) as amended and Church Representation Rules that came into force on 2 Jan 1957 and is a registered as a charity with the Charity Commission (number 1201438). Registration was applied for in 2022 (the year of this report) and confirmed as such in December 2022.



- 1 It is again really positive that this figure has grown again reflecting regular giving from Congregation members. The figure continues to increase each year.
- 2 Gift Aid reclaim remains at strong levels though down on 2022 due to fewer large gifts
- 3 Collections in Church have dipped slightly in the year.
- 4 Sundry donations are lower than in 2022, though the 2022 figures included money raised for Ukraine.
- 5 Rents received at Redfern Court have been stable through the year with no increased arrears or tenant changes. Total arrears from Covid-19 lockdowns remains at £3,792.
- 6 Income from fundraising sources including bookstall, boxes in church, café, concerts & September festival. Thank you to everyone who works hard to achieve those results. Clearly income is offset by costs which are shown elsewhere in the accounts.
Café (to 31 July 2023 only) £82,203.69 (2022:£75,214.47, 2021: £11,698, 2020: £2,203, 2019: £7,381).
September Festival (and other music) £17,735.07 (2022: £19,565.22, 2021: £9,358, 2020: £0, 2019: £2,922).
As usual these incomes are offset by costs shown elsewhere.
Fair Mo and concerts/art £2,628.84 (2022: £2,427.15, 2021: £2,156, 2020: £0, 2019: £3,031)
Bookstall/gift receipts have increased again in 2023 to £3,171.24 (2022: £2,449.09, 2021: £1,256.87)
- 7 Fees paid to the PCC have decreased in the year reflecting less weddings and funerals. They remain well below historic levels.
- 8 Non recurring grants is made up of a grant for Warm Spaces of £3,375 and a grant for the Youth Worker of £500.
- 9 The figure for 2023 is that from the restoration box plus a donation of £600.
- 10 Donations to charities for the year were as listed below:

- 11 The Ministry and Mission Fund (MMF) quota of £46,967 was made in full again.
- 12 Church running expenses have increased on those in 2022, and would have been even higher, but no bill was issued for electricity used for most of 2023. A bill finally arrived in February 2024 of £3,660.89.
- 13 Wages represent those costs which are paid by the PCC, so exclude Café wages after the trading subsidiary started on 1 August 2023 and the Manager and Youth & Children's worker which were covered by CAF. The wages covered by grants received for Deanery and Parish Administration are shown on the page of Notes to PCC Designated Accounts
- 14 This represents costs and expenses of our SWYM worker.
- 15 Fundraising costs have dropped slightly and include Café running costs (up to 31 July 2023), and the music & concert costs
- 16 The costs of painting the Lady Chapel was paid from the Parish Hall Funds. In the 2022 accounts, major Repairs included £15,900 is for the new boiler, £3,180 for the storage shed, £31,400 for the repayment of the loan made in 2021 to underwrite the clock repairs and the balance is for the works to the clock



