### **Structure, Governance & Management**

#### **Constitution**

##### **Annual General Meeting.**

##### **Sunday worship:**

Immanuel Pentecostal Ministries is a Malayalam fellowship of about 80 people including children and mainly consists of medical staff and their families from India. We meet every Sunday for Worship at Catherine Street Baptist Church

**Sunday school:**

We have divided the children into different classes according to their age. All our teachers are CRB checked as they are mainly nurses who work with NHS.

**Weekly Activities**

Our weekly activities feature dedicated times for spiritual growth and community connection. On Wednesday and Thursday nights, from 9:00 PM to 10:00 PM, we gather for Intercessory Prayers via Zoom. These sessions provide an opportunity to join in collective prayer from the comfort of your own home. It is a time to uplift one another, seek guidance, and pray for various needs, fostering a sense of unity and support within the community.

**Ladies Meeting:**

The ladies of our church gather every second and fourth Friday mornings in a month in different homes to pray and encourage each other. These gatherings provide a warm and welcoming space for women to connect, share, and grow together in faith and fellowship. These meetings are under the leadership of a sister in our church.

**Spiritual Empowerment Meeting**

Every Saturday evening, a Spiritual Empowerment Meeting is held from 6:30 PM to 8:30 PM at the Scout Hall, 1st Roberough Scouts. This gathering is a time for spiritual growth, worship, and fellowship, offering an opportunity to be uplifted and inspired.

**Church Council:**

The church council consists of four members who are elected by the general body. The church accounts are handled by the treasurer. The accounts are checked and audited every year by our auditor. Audited accounts statement is enclosed for your reference.
