Achievement and performances

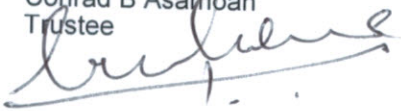

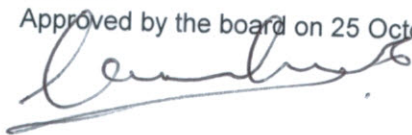
