Trustees Report Period ended 30 April 2025

The primary aim of the Sawbridgeworth Evangelical Congregational Church is to fulfil the role of a Christian Church in Sawbridgeworth and the surrounding area and to help others in supporting and promoting the Christian faith in the United Kingdom and overseas.

Aims and Objectives

The aims and objectives of the Church are the advancement of the Christian faith in accordance with our Basis of Faith, in Sawbridgeworth and the surrounding areas.

As a collection of people of different ages and backgrounds whose lives have been changed by Jesus Christ, we seek to fulfill the calling of Jesus in our lives.

This is done through worship as a community but also in the application of our faith for the benefit of others, through teaching and pastoral care, prevention and relief of need, and provision of facilities in the interests of social interaction.

We seek to live out the faith as contained in the Bible and be a blessing to those within the Church and those outside of it, desiring to see the people of Sawbridgeworth come into a relationship with Jesus Christ as their Lord, Saviour and friend.

Trustees and People

The Managing Trustees are collectively responsible for the spiritual leadership and administration of the Church and are comprised of the Minister and other members of the church leadership team who are appointed by the Members of the Church. The members of the Church, through the guidance of the Holy Spirit and under the Lordship of Christ have the final decision on all policies and important decisions that affect the life and witness of the Church.

Though the Church employs a full-time minister, and a part-time Office Manager it is reliant on and benefits from the active participation of volunteers from members and others connected with the Church to help achieve its objectives. This means presenting the Christian message among people they meet, being involved in teaching, public worship, pastoral care as well as in practical ministries, maintenance and administration. The Church is grateful for the dedication and enthusiasm of those who give their time & resources, often in ways that cannot be easily quantified.

The period ended 30th April 2025

The main ways the Church sought to achieve the calling of Christ upon it and its charitable activities for the public benefit by the advancement of religion has been as follows:

- Fulfilling its objects in the teaching and preaching in the weekly services on Sundays which are open to all people.
- Sunday services are live-streamed to enable greater access to the Church community and complement our in-person services. These services are planned with the aim of making them multigenerational, welcoming, thought provoking through clear Bible teaching.
- Midweek teaching groups are held at the Church, various private homes. These groups have been a lifeline for many in the Church family, providing support and friendship but ensuring Church



members study the Bible and pray together. Our 'Connect Groups' provide a sense of dynamic community within the wider congregation and enable members to grow together, form close friendships and provide much needed peer to peer discipleship. We have three 'youth Connect Groups' running that are ensuring our children and youth develop valuable friendships and a sense of belonging.

- Groups for children and young people are held on Sunday mornings during the service.
- A group for Carers and Toddlers, Open Door, runs every week during school terms helping families with young children and babies find friendship and much needed support.
- Friday Zone is a youth group for children in school years 4-10 run on a weekly basis during school terms. This club gathers together a number of local and Church children and is highly thought of.
- During this year the Church continued our youth provision from RBF who have helped us continue all areas of our youth work, ensuring deeper friendships and a greater understanding of their faith. Sadly, RBF ceased to operate as of September 2024.
- The 'Alpha' course - a series of sessions exploring the Christian faith that is available to all.

Activities which involve the wider community include-

- Participating in the 'Make Lunch' program to provide hot lunches to families. Members of the Church gave their time sacrificially and helped many families who have found life harder and harder.
- Our 'Food Hub', continues to provide much needed practical and social support to local residents, as they shop for free. We have forged greater links with the CAB and the Bishop's Stortford food bank.
- We continue to show our support for areas of need and conflict in the world, via financial support to Lifeline Romania and one-off collections for Churches, Christians experiencing hardship across the world.
- We are continuing to progress our building project plans and this has enabled us to reach out to the local community and understand local needs better, as well as creating new relationships. Our buildings will be in keeping with the local area, sensitive to the 'look' of the town and a benefit to local charitable groups. We are looking forward to being able to expand our impact on the local community. We were very pleased to receive full planning and listed building consent and look forward to starting Phase 1 in due course.



Financial Review

For the 13 months ended 30 April 2025 the church accounts have changed from a receipts and payments basis to an accrual basis in line with Charity Commission rules that specify this approach must be applied when gross income exceeds £250,000. In addition, the accounts have been prepared for a 13 month rather than the normal 12 month due to incorporation of the Church as a CIO being effective from 30 April 2025. The 31 March 2024 comparative figures have been adjusted to the accruals basis.

The financial resources received during the year amounted to £317,075 (2024(restated) £183,328) the expenditure however totalled £185,341, (2024 £239,369), on the activities and ministries of the Church. The increase in income levels is attributable to the fund-raising activities for the building fund, specifically the giving days in May 2024 and April 2025.

We can give thanks to God for the generosity of the members and attendees of the Church. The long-standing policy of the Church is not to take collections for the on-going work of the Church but rather to rely mainly on regular donations paid direct to the Church's bank account with additional gifts made through offering boxes.

Donors are encouraged to use Gift Aid schemes so that additional tax refunds can benefit the Church. On some occasions specific collections may be made for the special appeals of external organisations or projects which are compatible with the ethos of the Church.

The Church has a policy of allocating a proportion of its general income for designated purposes:

- 10% is devoted to the support of mission work outside of the local area
- 10% is allocated to the anticipated costs of major maintenance tasks, upgrading and expanding the Church buildings.

The Managing Trustees have set a policy of retaining sufficient reserves to provide for the foreseeable needs of the Church. These free reserves are available to meet the costs of normal running and to ensure that the Church can meet the commitments it has entered into. The minimum amount is anticipated to be equivalent to six months expenditure + scheduled transfers (the relevant figure for 12 months was £114,022). This indicates a minimum reserve figure of £57,011. This is considered appropriate in view of the current economic environment (taking into account increasing costs) and based on actual expenditure and future changes to the Church property.

Risks

All major insurable risks are subject to normal Church and employer insurance. Risks and other areas of activity and premises are subject to periodic review. The premises are professionally inspected every five years; the last inspection was conducted in 2023. Electrical fixed wiring inspections are also carried out on a regular basis.

Minor repairs are carried out several times a year as required. In the coming year a major refurbishment of the sanctuary and hall will be undertaken to address the required updates to



heating, lighting, electrical wiring, baptistry and other general maintenance items, (such as plasterwork patching). major work on the churchyard trees was done in 2021

The Church has a policy on the Safeguarding of children and vulnerable adults which is reviewed periodically.

Statement of Trustees Responsibility

As a member of the Fellowship of Independent Evangelical Churches, the Church is currently an "excepted charity" under the provisions of the Charity Act 2011. Now that income is in excess of £100,000 the Church is required to register as a charity in its own right and will be structured as a Charitable Incorporated Organisation (CIO), this process was started in January 2024 and completed on 30 April 2025.

Charity law requires the trustees to prepare accounts for each financial year which give a true and fair view of the state of affairs of the Charity and of the resources during that period. In preparing these accounts, the Trustees are required to:

- Select suitable accounting policies and then apply them consistently;
- Make adjustments and estimates that are reasonable and prudent;
- Prepare the accounts on a going concern basis unless it is inappropriate to presume that the Charity will continue in operation.

As gross income exceeded £250,000 in this accounting period, the accruals basis of accounting has been applied in accordance with Section 132 of the 2011 Act.

The Trustees are responsible for keeping adequate accounting records which disclose with reasonable accuracy at any time the financial position of the Charity and to enable them to ensure that the accounts comply with the Charities Acts. They are also responsible for taking reasonable steps for the prevention and detection of fraud and other irregularities. The Trustees confirm that the accounts comply with current statutory requirements and the Charity's trust deeds.

No payments were made to trustees other than the ministers salary & pension and approved payments for expenses legitimately encountered in the running of the church.

- Please note the expenditure for 23/24 is for a twelve month period, however for 24/25 this is a period of thirteen months, this is driven by the date of incorporation as at 30 April 2025 which required a longer accounting period, consequently expenditure comparisons are for differing periods. Annual expenditure has been changed to reflect the accruals basis of accounting.



Notes on Accounts

Total income in 2025 was £317,075, (2024 restated: £183,328) and expenditure £185,341, (2024: £239,369).

The increase in income received was as a result of two focused "giving days" in May 2024 and April 2025, aimed at raising additional funds for the building fund, through the generous donations by the Congregation the building fund stood at £177,860 at the end of the financial year.

For the 13 months ended 30 April 2025 the church accounts have changed from a receipts and payments basis to an accrual basis in line with Charity Commission rules that specify this approach must be applied when gross income exceeds £250,000. In addition, the accounts have been prepared for a 13 month rather than the normal 12 month due to incorporation of the Church as a CIO being effective from 30 April 2025. The 31 March 2024 comparative figures have been adjusted to the accruals basis.

One-Off or Capital Expenditure

Legal Fees - the only area which saw an increase in expenditure this year related to Legal Fees. The FIEC solicitors, Edward Connor, have done considerable work to assess and prepare the church trusts and constitution for charity registration. The complexity of this has increased costs by £6,932 to a total of £12,156, given the success of CIO status for the church on 30 April 2025 this level of expenditure will not be required on an ongoing basis.

Building Fund – Expenditure on building project reduced from £48,334 in 23/24 to £13,613 this year reflective that the costs relating to the architects fees and required surveys have now been met, these costs will however be financed from the general fund.

Youth Work – The formal partnership with Red Balloon foundation providing assistance for youth work came to an end in the summer of 2024, thereby reducing costs from £15,071 to £9,068.



Fund Summary Descriptions

- General Fund:** Covers the majority of ongoing running costs and income
- Designated Funds** Funds that the church establishes to receive designated income and pay for specific projects or activities:
- Benevolent Fund:** For gifts to assist church members in financial need.
Funded from specific gifts which have to be given without gift aid.
- Building Project:** To cover the new building project (Set up March 2019), a designated bank account was opened in December 2023.
- Community Fund:** The Community Fund acts as an umbrella fund for all costs associated with the community including the pop-up shop, parenting courses, Open Door, Make Lunch, the Hailey Centre and Zone. (set up April 2022)
- Missionary Fund:** Supports work by other Christian organizations outside of the local area. Funded by 10% of general income (see below for details of missionaries we support)
- PA & AV:** Re-activated to cover a major PA and Video upgrade.
- Property:** Major building maintenance and capital expenditure costs.
Funded by 10% of general income (Set up Nov 2010)
- Legacy RF:** The restricted and endowment funds were closed in 2021, going forward graveyard maintenance costs will be funded from general income.



Missionaries and Organizations We Support

- Colin & Bron Cleaver, Operation Mobilization, Novosibirsk, Siberia: Lead OM team and run a discipleship center which trains and equips young Russian Christians to discover and use their gifts effectively. They also work alongside Baptist churches in and around the city.
- Martin & Hazel Frost:, Latin Link, City of San Francisco, Argentina: Involved in bible teaching, web-authoring, prison visiting, school support and rural community projects.
- Yulia Notkin, Operation Mobilization, Novosibirsk, Siberia: Tutor at the discipleship center run by Colin & Bron Cleaver who are involved in teaching, counselling and organizing trips for students to gain experience in ministry.
- Dr. Shirley Heywood, International Nepal Fellowship, Surkhet District, Nepal: A gynecologist working with district hospitals and mobile camps performing surgery on women with obstetric fistulas.
- Regular giving was established in 22/23 for both Christian Solidarity Worldwide and Stephen Pointing who is involved with missionary work.
- Stort Valley Trust: Christian youth work in schools in and around Bishop's Stortford, Members agreed to recommence support for this group in March 2025.

The primary aim of the Sawbridgeworth Evangelical Congregational Church is to fulfil the role of a Christian Church in Sawbridgeworth and the surrounding area and to help others in supporting and promoting the Christian faith in the United Kingdom and overseas.

Aims and Objectives

The aims and objectives of the Church are the advancement of the Christian faith in accordance with our Basis of Faith, in Sawbridgeworth and the surrounding areas.

As a collection of people of different ages and backgrounds whose lives have been changed by Jesus Christ, we seek to fulfill the calling of Jesus in our lives.

This is done through worship as a community but also in the application of our faith for the benefit of others, through teaching and pastoral care, prevention and relief of need, provision of facilities in the interests of social interaction.

We seek to live out the faith as contained in the Bible and be a blessing to those within the Church and those outside of it, desiring to see the people of Sawbridgeworth come into a relationship with Jesus Christ as their Lord, Saviour and friend.

Trustees and People

The Managing Trustees are collectively responsible for the spiritual leadership and administration of the Church and are comprised of the Minister and other members of the church leadership team who are appointed by the Members of the Church. The members of the Church, through the guidance of the Holy Spirit and under the Lordship of Christ have the final decision on all policies and important decisions that affect the life and witness of the Church.

Though the Church employs a full-time minister, a part-time Office Manager and a formal partnership with the Red Balloon Fellowship to lead on our youth and children's work, it is reliant on and benefits from the active participation of volunteers from members and others connected with the Church to help achieve its objectives. This means presenting the Christian message among people they meet, being involved in teaching, public worship, pastoral care as well as in practical ministries, maintenance and administration. The Church is grateful for the dedication and enthusiasm of those who give their time & resources, often in ways that cannot be easily quantified.

The 15 month period to 31st March 2024

The main ways the Church sought to achieve the calling of Christ upon it and its charitable activities for the public benefit by the advancement of religion has been as follows:

- Fulfilling its objects in the teaching and preaching in the weekly services on Sundays which are open to all people.
- Sunday services are live-streamed to enable greater access to the Church community and complement our in-person services. These services are planned with the aim of making them multigenerational, welcoming, thought provoking through clear Bible teaching.
- Midweek teaching groups are held at the Church, various private homes. These groups have been a lifeline for many in the Church family, providing support and friendship but ensuring Church



members study the Bible and pray together. Our 'Connect Groups' provide a sense of dynamic community within the wider congregation and enable members to grow together, form close friendships and provide much needed peer to peer discipleship. We have three 'youth Connect Groups' running that are ensuring our children and youth develop valuable friendships and a sense of belonging.

- Groups for children and young people are held on Sunday mornings during the service.
- A group for Carers and Toddlers, Open Door, runs every week during school terms helping families with young children and babies find friendship and much needed support.
- Friday Zone is a youth group for children in school years 4-10 run on a weekly basis during school terms. This club gathers a number of local and Church children and is highly thought of.
- During this year the Church continued our youth provision from RBF who have helped us continue all areas of our youth work, ensuring deeper friendships and a greater understanding of their faith.
- The 'Alpha' course - a series of sessions exploring the Christian faith that is available to all.

Activities which involve the wider community include-

- Participating in the 'Make Lunch' program to provide hot lunches to families. Members of the Church gave their time sacrificially and helped many families who have found life harder and harder.
- Our 'Food Hub' (formerly known as the Pop-Up Shop), continues to provide much needed practical and social support to local residents, as they shop for free. We have forged greater links with the CAB and the Bishop's Stortford food bank.
- We continue to show our support for areas of need and conflict in the world, via financial support to Lifeline Romania and our continued care for Ukrainians in the town by letting our hall be used to host language lessons, fund-raising events, prayer, the Food Hub and special events to make significant occasions.
- We are continuing to progress our building project plans and this has enabled us to reach out to the local community and understand local needs better, as well as creating new relationships. Our buildings will be in keeping with the local area, sensitive to the 'look' of the town and a benefit to local charitable groups. We are looking forward to being able to expand our impact in the local community.



Financial Review

The financial statements for the 15 month period to 31 March 2024 have been prepared on a Receipts and Payments basis.

The financial resources received during the year amounted to £228,830 the expenditure however totalled £277,862, on the activities and ministries of the Church. The main reason for the increase in expenditure related to expenses associated with the architects' fees and planning application.

We can give thanks to God for the generosity of the members and attendees of the Church. The long-standing policy of the Church is not to take collections for the on-going work of the Church but rather to rely mainly on regular donations paid direct to the Church's bank account with additional gifts made through offering boxes.

Donors are encouraged to use Gift Aid schemes so that additional tax refunds can benefit the Church. On some occasions specific collections may be made for the special appeals of external organisations or projects which are compatible with the ethos of the Church.

The Church has a policy of allocating a proportion of its general income for designated purposes:

- 10% is devoted to the support of mission work outside of the local area
- 10% is allocated to the anticipated costs of major maintenance tasks, upgrading and expanding the Church buildings.

The Managing Trustees have set a policy of retaining sufficient reserves to provide for the foreseeable needs of the Church. These free reserves are available to meet the costs of normal running and to ensure that the Church can meet the commitments it has entered into. The minimum amount is anticipated to be equivalent to six months expenditure + scheduled transfers (the relevant figure for 15 months was £181,267). This indicates a minimum reserve figure of £90,634. This is considered appropriate in view of the challenging economic environment, (considering increasing energy costs) and potential developments and future changes to the Church property.

Risks

All major insurable risks are subject to normal Church and employer insurance. Risks and other areas of activity and premises are subject to periodic review. The premises are professionally inspected every five years; the last inspection was conducted in 2023. The main Church boiler was replaced during 2023 as the old boiler had failed. Other ongoing maintenance work is being carried out by Church members. Replacement of fencing at the Manse has also been undertaken in early 2024. The Church has a policy on the Safeguarding of children and vulnerable adults which is reviewed periodically.

Statement of Trustees Responsibility

As a member of the Fellowship of Independent Evangelical Churches, the Church is currently an "excepted charity" under the provisions of the Charity Act 2011. Now that income is in excess of £100,000 the Church is required to register as a charity in its own right and will be structured as a Charitable Incorporated Organisation (CIO). It has commenced this process and is expected to complete it during 2024.

Charity law requires the trustees to prepare accounts for each financial year which give a true and fair view of the state of affairs of the Charity and of the resources during that period. In preparing these accounts, the Trustees are required to:

- Select suitable accounting policies and then apply them consistently;
- Make adjustments and estimates that are reasonable and prudent;
- Prepare the accounts on a going concern basis unless it is inappropriate to presume that the Charity will continue in operation.

The Trustees are responsible for keeping adequate accounting records which disclose with reasonable accuracy at any time the financial position of the Charity and to enable them to ensure that the accounts comply with the Charities Acts. They are also responsible for taking reasonable steps for the prevention and detection of fraud and other irregularities. The Trustees confirm that the accounts comply with current statutory requirements and the Charity's trust deeds.

No payments were made to trustees other than the minister's salary & pension and approved payments for expenses legitimately encountered in the running of the church.

Notes on Accounts

Total income for the 15 months to 31 March 2024 was £228,830 and expenditure £277,862 producing for the first time a deficit of £49,032, this gap was closed by a request for members to increase their monthly giving together with a transfer of funds from savings to bridge the gap. Income received included Gift Aid of £32,611. During 23/24 there was significant expenditure relating to the building fund as the plans and survey for the new building moved forward.

The increase in expenditure this year arises from the following:

General Fund, On-Going Expenditure

- This was the fourth year that both the administrator costs and increased support contract to Red Balloon (Youth) Fellowship to cover 20 hrs per week of a youth worker were paid for a full year, these costs are now stable and are being covered from general income.
- Supplier contracts have been reviewed and a fixed tariff for gas and electricity has been set for a three-year period, costs have increased in line with energy prices and an accrual remains in place to cover these costs for 23/34 as 24/25.

One-Off or Capital Expenditure

There were a number of special projects that resulted in considerable 'one-off' expenditure.

General Fund, Charity Registration – The FIEC solicitors Edward Connor have done considerable work to assess and prepare the church trusts and constitution for charity registration. The complexity of this has increased costs, about £6,257.

Building Fund – Expenditure on building project amounted to £22,751 which covered the architect's fees and required surveys, in the absence of any specific donations ongoing costs will need to be financed from the general fund.



Fund Summary Descriptions

- General Fund:** Covers the majority of ongoing running costs and income.
- Designated Funds** Funds that the church establishes to receive designated income and pay for specific projects or activities:
- Benevolent Fund:** For gifts to assist church members in financial need.
Funded from specific gifts which have to be given without gift aid.
- Building Project:** To cover the new building project (Set up March 2019), a designated bank account was opened in December 2023.
- Community Fund:** The Community Fund acts as an umbrella fund for all costs associated with the community including the pop-up shop, parenting courses, Open Door, Make Lunch, the Hailey Centre and Zone. (set up April 2022)
- Missionary Fund:** Supports work by other Christian organizations outside of the local area. Funded by 10% of general income (see below for details of missionaries we support)
- PA & AV:** Re-activated to cover a major PA and Video upgrade.
- Property:** Major building maintenance and capital expenditure costs.
Funded by 10% of general income (Set up Nov 2010)
- Legacy RF:** The restricted and endowment funds were closed in 2021, going forward graveyard maintenance costs will be funded from general income.



Missionaries and Organizations We Support

- Colin & Bron Cleaver, Operation Mobilization, Novosibirsk, Siberia: Lead OM team and run a discipleship center which trains and equips young Russian Christians to discover and use their gifts effectively. They also work alongside Baptist churches in and around the city.
- Martin & Hazel Frost: Latin Link, City of San Francisco, Argentina: Involved in bible teaching, web-authoring, prison visiting, school support and rural community projects.
- Yulia Notkin, Operation Mobilization, Novosibirsk, Siberia: Tutor at the discipleship center run by Colin & Bron Cleaver who are involved in teaching, counselling and organizing trips for students to gain experience in ministry.
- Dr. Shirley Heywood, International Nepal Fellowship, Surkhet District, Nepal: A gynecologist working with district hospitals and mobile camps performing surgery on women with obstetric fistulas.
- Roger & Marvyn Amos, Lifeline Romania: Help run Lifeline Romania which provides clothing and domestic goods for poor Romanians and supports several local churches. SECC funds trips to supervise distribution of goods from the UK and helps with pack shipping lorry.
- Regular giving was established in 22/23 for both Christian Solidarity Worldwide and Stephen Pointing who is involved with missionary work.
- In addition, special collections were funded by the Church congregation to support aid for Pakistan via DEC, a contribution for Jews for Jesus, the Ukraine Appeal and support for Matt Fowell's trip to Gambia.
