### **REVIEW OF ACTIVITIES AND ACHIEVEMENTS**

#### **Worship and Prayer**

The End Time Revelation Church Charity is keen to offer a variety of weekly services that our community find both beneficial and spiritually fulfilling. Wednesday evening is our day for evening prayer which provides an intimate time of worship and our Sunday service provides an opportunity for more outgoing worship led by our dedicated choir.

All are welcome to attend our regular Sunday services.

As well as our regular services, we encourage the community to celebrate and thank God for the milestones in life. For example through the celebration of baptism by water immersion in accordance with the Bible. This past year we held our first Baptism on 29 July 2023 for eleven youth members in the church.

#### **Mission and Evangelism**

Helping others in need is a demonstration of our faith and the Charity seeks to advance the Christian faith to the community.

The Evangelism team arranged an evangelism event in the West Bromwich market on 25 November 2023. This was an opportunity to fellowship and share the message of hope with the public.

### **FINANCIAL REVIEW**

The total amount of offerings received in this period was £3,206.61. Offerings are the main source of donations for the Church and Graph 1 shows the offerings received over the period.

The Church premises are rented and 60% of the donations received in this period went towards rent.
