Throughout the year to 31st July 2025 Starlight Youth Theatre has continued against its financial and governance objectives as well as maintaining its focus on membership connectivity to ensure success going forward.

Within the timeframe of this report the society has delivered 2 annual concerts and has been extremely privileged to be able to stage Les Misérables (March 2025) all of which have been great successes.

Membership:

The society membership average through the report year was 36

The society continues to run against the same open auditions principle for new members and show principal parts and are thankful to have seen a rise in voluntary chaperones that help with the flexibility of “time given” through general rehearsals as well as during show weeks.

Financial:

The trustees have continued to concentrate on both overall solvency as well establishing technical equipment self-sufficiency. Great strides have been made against both

Throughout the submission period, the society’s strong financial position has been maintained even though the society accepted higher show overhead costs through the staging of Les Misérables and funded significant equipment purchases aligned to your self-sufficiency goals.

Alongside the society’s well governed income and expenditure model, the society is thankful to have been awarded several grants (funding amounts will appear in the financial statement of the submission) from local business and charitable trusts.

Governance:

Across the report, Starlight Youth Theatre has seen one committee member change due to relocation (Rachel altering role to a Trustee as referenced above) although no new committee appointments at the time of writing.

We held our society AGM which was well attended by the wider membership where all aspects of the society were covered with full visibility and an active Q&A session.

At the time this submission covers, the society are busy finalising rehearsals for the 2026 concert to be staged in June.

The trustees look forward to what the future holds for Starlight Youth Theatre and its continued positive impact through providing youth theatre experiences for the young people in and around the Loughborough area.

Throughout the year to 5th April 2024 Starlight Youth Theatre has made great strides against financial, membership and governance objectives as well as setting up these areas of the society for continued success going forward.

Within the timeframe of this report the society was privileged to be one of the first youth theatres to be given the licence to stage School of Rock (March 2023) performing its annual concert (June 2024) as well as staging Addams Family (March 2024)

Membership:

The society membership average through the report year was 35 (N.B. this differs slightly throughout the year as we do see some members taking a “break” for exams hence these individuals may well participate in our annual concert only in this academic year).

On a governance perspective, the trustees have worked to agree a “soft” membership number cap of 40 that will carry through to subsequent years. This balances simple areas of consideration such as rehearsal and stage space as well as safeguarding ratios etc.

The society continues to run against the same open auditions principle for new members and show principal parts.

As a link from the membership to financial section it is worthy to note that the society has now moved to a simpler membership fee model that ensures that all overheads are covered and done so equally throughout the members with either an annual payment or instalments schedule, which is managed by our treasurer on a 1:1 discretionary basis.

Financial:

The trustees have concentrated on both overall solvency as well as looking to build financial support to establish technical equipment self-sufficiency.

Throughout the year, the society’s financial position has strengthened. The trustees look to ensure a minimum working balance of £5,000 which enable the society to cover yearly liabilities as well as fund the purchase of the license for the following year’s

show. We have been able to ensure that we are constantly above this figure as a result of good budget management through low expenditure on areas such as costumes, set & props, and a focus on ensuring good show income through ticket sales and front of house fund raising. Balancing these elements means that the society has generally broken even on its main show whilst making small profits from the annual concert. This positive financial position has enabled the society to take advantage of signing proactive license agreements and paying rights fees for our 2025 which will be Les Misérables.

Alongside the society's general income and expenditure model, the society is thankful to have been awarded several grants (funding amounts will appear in the financial statement of the submission) from local business and charitable trusts that have enabled the purchase of audio equipment (specifically 11 radio microphones, a speaker set and general connectivity infrastructure) as we build towards the ambition of technical self-sufficiency.

The journey to self-sufficiency will continue as the trustees would estimate the ambition would total approximately £20,000.

Governance:

Across the report, Starlight Youth Theatre has seen a small number of committee member changes as well as new committee appointments. These changes were all completed under the practices outlined in our constitution.
