STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

East Riding Food Poverty Alliance (ERFPA) was established under a Constitution (Association model) and is a registered Charitable Incorporated Organisation (CIO). The Charity was registered with the Charity Commission on 31 January 2023.

If the CIO is wound up, the members of the CIO have no liability to contribute to its assets and no personal responsibility for settling its debts and liabilities.

Appointment of Trustees

The Trustees form the Executive Committee of the charity. The members of the Executive Committee are elected at the Annual General Meeting by the members of the Charity, and usually serve for a three-year term. At the end of this term, they can stand for re-election. All members are circulated with invitations to nominate Trustees in advance of the AGM.

The Constitution states that there must be at least three charity trustees. The maximum number of Trustees is nine.

There is a provision for the co-option of additional trustees by the Trustee Board, provided that the maximum number of trustees is not exceeded. Co-opted trustees must retire at the next AGM after their appointment, and shall not be counted for the purpose of which of the charity trustees are to retire by appointment at the AGM.

Any person retiring as a charity trustee by rotation or by giving notice to the CIO is eligible for reappointment.

For the period ended 30 June 2025**Trustee Induction and Training**

New Trustees undergo induction, provided by the current Trustee Board. The induction includes a discussion about the role and responsibilities of Trustees, the activities, aims and objectives of the Charity, the structure of the organisation, Board of Trustees, general procedures of the organisation. New Trustees are introduced to members of staff and other Trustees, and are provided with the Charity Commissions 'Roles and Responsibilities of Trustees', the Constitution, the latest statutory financial statements, Annual Report, and financial reports provided to the Board of Trustees. Any additional training required by new Trustees will be identified during induction, and may be requested at any point while they hold the position of Trustee, where it is considered useful to their role as Trustee. Trustees are also invited to attend events and activities in order to develop a better all-round understanding of the organisation.

Organisational Structure

The Board of Trustees manages the Charity but generally aims to consider only strategic decisions at its meetings. Trustees are aware that any conflicts of interest are declared and minuted. The Board meets quarterly. Trustees are aware that any conflicts of interest are declared and minuted.

Risk Management

The major risks to which the Charity is exposed, as identified by the Trustees, have been reviewed and systems have been established to mitigate those risks. The climate within the Voluntary and Community Sector is such, that risks include a dependence on a mixture of income sources including earned income, Service Level Agreements, contracts and grants – a percentage of which covers the core costs of the organisation.

Objects

As set out in the Constitution, the Charity's objects are the prevention or relief of poverty in the United Kingdom by:

- (a) providing grants, items and services to individuals in need and/or charities or other organisations working to prevent or relieve poverty.
- (b) Undertaking and supporting research into factors that contribute to poverty and the most appropriate ways to mitigate these.

Main objectives for the following year

Our main objectives for the following year are:

- Continue working towards the three course collaborative strategy to increase food security in the East Riding of Yorkshire this can be accessed at <https://www.erfpa.org.uk/about/food-poverty-strategy-2021/> and develop a new 5 year strategy to increase food security in the East Riding of Yorkshire.
- Continue to reduce reliance on emergency food parcels by increasing use of sustainable food provision, improving household income through advice and employment support, increasing community participation and reducing social isolation.
- Explore the relationship between poverty, health and wellbeing. ERFPA will promote joined-up support within food hubs, linking food provision with health, advice and social connection.
- Continue to provide support, advice and guidance to members of the alliance.
- To grow the membership of the East Riding Food Poverty Alliance and develop new relationships with strategic partners.
- Continue to identify appropriate funding sources to support the work of ERFPA, and other members of the alliance.

Public benefit

The Trustees confirm that they have complied with the duty, contained in Section 4 of the Charities Act 2011, to have due regard to the guidance on public benefit issued by the Charity Commission. The charitable purpose of the charity within the meaning of the act is contained within its objects stated above.

ACHIEVEMENTS AND PERFORMANCE

Review of Activities 2024-25

The East Riding Food Poverty Alliance (ERFPA) is an alliance of Voluntary, Community, Faith and Social Enterprise (VCFSE) organisations supporting individuals and families who have, or are at risk of, food insecurity across the East Riding of Yorkshire. Through a coordinated and collaborative approach, ERFPA works to meet immediate need while supporting longer-term pathways towards financial resilience and food security.

During 2024–25, ERFPA member organisations collectively provided residents with 28,717 food provisions, providing emergency food, access to affordable food pantries, practical support, and onward referrals across the East Riding.

In January 2025, ERFPA members began recording the individual beneficiaries who received support each month, with 38,248 people recorded from January to June 2025, many of these being repeat users of the services. During this 6-month period approximately 509 new individuals accessed the service.

The members of ERFPA made 977 referrals to other support agencies in the East Riding, providing collaborative working across the sector and ensuring those facing poverty are able to access the additional support needed.

The partners of ERFPA during 2024–25 were: East Riding Food Bank (East Riding wide), Beverley Cherry Tree Centre (Beverley), The Hinge (Bridlington), Hedon Community Food Bank, Hessle and Anlaby Food Bank, Love Driffield, The Moorlands (Goole), The Peoples Pantry (Market Weighton and Pocklington), Two Rivers Food Bank (Goole and West), and South Holderness Resource Centre (SHoRes) (Withernsea), East Riding Hygiene Support, St Augustine's Pantry (Hedon), Easington Pantry and Aldbrough Food Bank.

Over the year 24-25 the monitoring of food support has developed to collect additional data which is vital in understanding the need of residents in the East Riding. These developments will be highlighted further in the Trustee report 2025-26.

Governance and Organisational Development

This year marked the second full year of operation of ERFPA as an independent charity, following its previous operation as a project of Community VISION (previously ERVAS). During 2024–25, the charity continued to strengthen its governance arrangements, financial controls, and operating procedures, ensuring the organisation is well-placed for sustainable growth.

Community VISION continued in its role as the Locally Trusted Organisation (LTO) for ERFPA, providing governance, financial administration, and strategic development support. This arrangement enabled ERFPA to maintain effective oversight while benefiting from established systems and specialist expertise, contributing to increased organisational capacity and resilience.

Strategic Aims and Impact

ERFPA continued to work towards delivery of its Food Poverty Strategy for the East Riding of Yorkshire, which sets out a collaborative, three-course approach to increasing food security. The strategy promotes:

- A consistent, joined-up and coordinated strategic approach to tackling food poverty
- Prevention of food waste and improved use of surplus food
- Access to healthy, affordable and sustainable food for all

Through collective working, ERFPA member organisations strengthened coordination across local food provision, reducing duplication and improving access for residents. During the year, 15 registered members of the alliance operated across the East Riding, ensuring geographically accessible support for communities experiencing the highest levels of need.

Funding and Programme Delivery

During 2024-25 ERFPA was successful in several funding bids, that have allowed the charity to continue supporting residents in the East Riding. These include Sir James Reckitt Charitable Trust, Hull & East Yorkshire Charitable Trust, Two Ridings Community Foundation and Scurrah Wainwright Charitable Trust.

We also received unrestricted grants from trusts to contribute to the core costs of our operations from Cranswick Charitable Trust and the Sylvia and Colin Shepherd Trust. Building on the successful award from the National Lottery Community Fund, ERFPA continued the delivery of a Food Bank Development Officer role. The post supported food banks across the East Riding to strengthen governance, improve service quality, and increase collaboration. Key areas of impact included:

- Support provided to 15 food banks, community pantries and social supermarkets.
- Development of shared policies, procedures, or tools.
- Improved pathways for beneficiaries to access advice, debt support, or income maximisation services through member organisations

- Supported work to explore a shift away from long-term food bank dependency, with the development of a community pantry in Bridlington.
- Continued to identify appropriate funding opportunities for the development and sustainability of the charity.
- Provide support to the ERFPA Trustees.

ERFPA was successful in securing funding for a Pop-Up Community Pantry through Two Ridings Community Fund for 3 years. As the funding start date was from April 2025, the project remained in the research and information gathering stage for the timeframe for this specific report.

Locally Trusted Organisation Activity and Wider Impact

Alongside ERFPA's own charitable activity, Community VISION, as LTO, continued to receive funding and contracts to support the wider ERFPA network. Income and expenditure relating to this activity are included within the Community VISION accounts.

This support included:

- Ongoing delivery of Food Bank Development support, benefitting 15 organisations across the East Riding.
- Operation of the White Goods Scheme, providing essential household items to residents experiencing financial hardship through the Household Support Fund (HSF)
- Management of the Emergency Food and other essentials grant through the HSF
- Operation of the Heat the Person project, providing items to keep residents warm through winter as fuel costs continue to rise, through the HSF.

Partnerships and Acknowledgements

ERFPA continued to benefit from strong partnership working across the VCFSE sector and with statutory partners. The trustees would like to express their ongoing thanks to East Riding of Yorkshire Council for their continued support of the ERFPA network and their commitment to collaborative approaches to tackling food poverty across the region.

The financial statements have been prepared in accordance with the accounting policies set out on page 11 and comply with the Constitution, the Charities Act 2011, and Charity Commission Guidance for Charities preparing their accounts on the Receipts and Payments basis.

Financial results

Total income for the year was £36,874 (2024: £20,836), the majority of this came from grants. Total expenditure was £22,628 (2024: nil). The surplus for the period was £14,246 (2024: £20,836).

Policy on reserves

The Executive Committee regularly review the Reserves policy of the charity to ensure it meets the needs of the Charity. As we are in the second period of operation, we are working on building up sufficient unrestricted reserves to ensure a sufficient buffer to enable effective financial decision-making, rather than short term decisions and to ensure effective financial stewardship of the Charity.

FUTURE PLANS

The Trustee Board will continue to work towards the three course collaborative strategy to increase food security in the East Riding of Yorkshire this can be accessed at <https://www.erfpa.org.uk/about/food-poverty-strategy-2021/> and develop a new 5 year strategy to increase food security in the East Riding of Yorkshire.

The alliance will focus on reducing reliance on emergency food provision through sustainable food access, improved household income, and stronger community participation, while promoting joined-up support linking food, health, advice and social connection. ERFPA will also continue to support and grow its membership, strengthen strategic partnerships, and secure funding to sustain and develop alliance activity.

The alliance will continue to work with members and increase membership to ensure that options for collaboration, peer support and sharing of learning is available to those members that need it.



1. ACCOUNTING POLICIES

Basis of preparation

The charity have prepared their accounts on the Receipts and Payments basis in line with Charity Commission guidance. This is an acceptable format for a non-company charity with an income below £250,000.

This is the second accounting period of the charity and covers the year 01 July 2024 to 30 June 2025, the first accounting period of the charity was from the date of registration 31 January 2023 to 30 June 2024.

Organisation status

The Charity is a Charitable Incorporated Organisation. The members of the Charity are the Trustees named on page 3.

Going concern

The trustees consider the charity to be a going concern and the accounts have been prepared on this basis.

Fund accounting

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors. Restricted funds are accounted for separately to each other and to the core funding of the Charity.

General funds are unrestricted funds which are available for use at the discretion of the trustees in the furtherance of the general objectives of the charity and which have not been designated for other purposes

A brief description of the restricted funds are shown below:

The Albert Hunt Trust

Restricted funding was received from the Albert Hunt Trust to develop and provide recipe packs for four food banks.

East Riding of Yorkshire Council – DIFEY

Restricted funding was received from East Riding of Yorkshire Council, Do It For East Yorkshire grant, for energy vouchers for people in need.

Hull and East Riding Charitable Trust

Restricted funding was received from the Hull and East Riding Charitable Trust to develop the role of the Food Bank Development Officer in rural areas.

National Lottery Community Fund

Restricted funding was received from the National Lottery Community Fund to employ a food bank development officer and associated costs to deliver the outcomes of the Food Poverty Strategy, which considers three areas for development: Promote a consistent, joined-up and coordinated strategic approach to tackling food poverty, prevent food waste and make better use of surplus food to ensure healthy, affordable and sustainable food for all. The project will work with new and existing food banks across the East Riding to explore the movement from food bank dependency and economic inactivity of beneficiaries to financial stability no longer requiring food banks.

Ridge Clean Energy

Restricted funding was received from Ridge Clean Energy for energy vouchers for people in need.

Scurrah Wainwright Charity

6. GOING CONCERN

The Trustees consider the Charity to be a going concern for a period of at least 12 months beyond the date of the Independent Examiners report.

In 2024, The Charity received a grant of £19,875 from the National Lottery Community Fund for 18 months to employ a food bank development officer and associated costs to deliver the outcomes of the Food Poverty Strategy, which considers three areas for development: Promote a consistent, joined-up and coordinated strategic approach to tackling food poverty, prevent food waste and make better use of surplus food to ensure healthy, affordable and sustainable food for all. The project will work with new and existing food banks across the East Riding to explore the movement from food bank dependency and economic inactivity of beneficiaries to financial stability no longer requiring food banks.

In addition, during the current year the Charity has received grants from a range of funders to support in the continued development of the East Riding Food Poverty Alliance.

7. RELATED PARTY TRANSACTIONS

During the period the Charity had related party transactions with Community VISION (Voluntary Infrastructure Support Involving Organisations and Networks) CIO previously East Riding Voluntary Action Services (ERVAS) Ltd. Prior to the registration of East Riding Food Poverty Alliance (ERFPA) as a separate charity, it operated under ERVAS Ltd.

Community VISION was appointed the LTO of the Charity and has provided support to ERFPA. As the LTO, Sian Broughton, Chief Executive of Community VISION was appointed as one of the first Trustees of the Charity. Due to Sian Broughton being a Chartered Management Accountant the Trustees made the decision to appoint her to the Treasurer position.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

East Riding Food Poverty Alliance (ERFPA) was established under a Constitution (Association model) and is a registered Charitable Incorporated Organisation (CIO). The Charity was registered with the Charity Commission on 31 January 2023.

If the CIO is wound up, the members of the CIO have no liability to contribute to its assets and no personal responsibility for settling its debts and liabilities.

Appointment of Trustees

The Trustees form the Executive Committee of the charity. The members of the Executive Committee are elected at the Annual General Meeting by the members of the Charity, and usually serve for a three-year term. At the end of this term, they can stand for re-election. All members are circulated with invitations to nominate Trustees in advance of the AGM.

The Constitution states that there must be at least three charity trustees. The maximum number of Trustees is nine.

There is a provision for the co-option of additional trustees by the Trustee Board, provided that the maximum number of trustees is not exceeded. Co-opted trustees must retire at the next AGM after their appointment, and shall not be counted for the purpose of which of the charity trustees are to retire by appointment at the AGM.

Any person retiring as a charity trustee by rotation or by giving notice to the CIO is eligible for reappointment.

Trustee Induction and Training

New Trustees undergo induction, provided by the current Trustee Board. The induction includes a discussion about the role and responsibilities of Trustees, the activities, aims and objectives of the Charity, the structure of the organisation, Board of Trustees, general procedures of the organisation. New Trustees are introduced to members of staff and other Trustees, and are provided with the Charity Commissions 'Roles and Responsibilities of Trustees', the Constitution, the latest statutory financial statements, Annual Report, and financial reports provided to the Board of Trustees. Any additional training required by new Trustees will be identified during induction, and may be requested at any point while they hold the position of Trustee, where it is considered useful to their role as Trustee. Trustees are also invited to attend events and activities in order to develop a better all-round understanding of the organisation.

Organisational Structure

The Board of Trustees manages the Charity but generally aims to consider only strategic decisions at its meetings. Trustees are aware that any conflicts of interest are declared and minuted. The Board meets quarterly. Trustees are aware that any conflicts of interest are declared and minuted.

Risk Management

The major risks to which the Charity is exposed, as identified by the Trustees, have been reviewed and systems have been established to mitigate those risks. The climate within the Voluntary and Community Sector is such, that risks include a dependence on a mixture of income sources including earned income, Service Level Agreements, contracts and grants – a percentage of which covers the core costs of the organisation.

ACHIEVEMENTS AND PERFORMANCE

Review of the financial period

Review of Activities 2023-24

ERFPA is an alliance of VCFSE organisations supporting individuals who have or are at risk of food insecurity across the East Riding. The partners of ERFPA are East Riding Food Bank (East Riding wide), Beverley Cherry Tree Centre (Beverley), The Hinge (Bridlington), Hedon Food Bank, Hessle and Anlaby Food Bank, Love Driffield, The Moorlands (Goole), The Peoples Pantry (Market Weighton and Pocklington), Two Rivers Food Bank (Goole and West) and South Holderness Resource Centre (SHoRes) (Withernsea). ERVAS was appointed the Locally Trusted Organisation (LTO) for ERFPA and has provided a range of support services including accessing funding and collaborative bidding to ensure that individuals in need can be supported.

This was the first period of operation of the East Riding Food Poverty Alliance (ERFPA) as an independent charity. Previously ERFPA has been operating as a project of East Riding Voluntary Action Services (ERVAS) Ltd and all financial arrangements have been managed by ERVAS as part of this. Following on from successfully registering ERFPA as a charity in its own right, time was spent setting up the banking arrangements and the systems and procedures to allow ERFPA to start independent operation with ERVAS continuing to provide support as the LTO.

ERFPA continued working towards the three course collaborative strategy to increase food security in the East Riding of Yorkshire this can be accessed at <https://www.erfpa.org.uk/about/food-poverty-strategy-2021/>.

During the year ERFPA was appointed to receive the Pennies From Heaven donations from East Riding of Yorkshire Council. We were also successful in a bid to the National Lottery Community Fund to employ a Food Bank Development Officer to deliver the outcomes of the Food Poverty Strategy, which considers three areas for development: Promote a consistent, joined-up and coordinated strategic approach to tackling food poverty, prevent food waste and make better use of surplus food to ensure healthy, affordable and sustainable food for all. The project will work with new and existing food banks across the East Riding to explore the movement from food bank dependency and economic inactivity of beneficiaries to financial stability no longer requiring food banks, this post will be recruited to in the next financial year.

Alongside the above, as LTO ERVAS, has received funding and contracts to support the work of ERFPA, the income and expenditure in relation to this is included within the ERVAS accounts. This has included the provision of a Food Bank Development Officer providing support to food banks across the East Riding or Yorkshire and the provision of a White Goods Scheme, which provides both small white goods (microwaves, kettles, air fryers) and larger white goods (cookers, fridges, freezers and washing machines) to residents in need. Referrals for this service are received from ERFPA members and East Riding of Yorkshire Council.

Our ongoing thanks to East Riding of Yorkshire Council officers who have provided continued support to the ERFPA network.

FINANCIAL REVIEW

Financial regulations

The financial statements have been prepared in accordance with the accounting policies set out on page 11 and comply with the Constitution, the Charities Act 2011, and Charity Commission Guidance for Charities preparing their accounts on the Receipts and Payments basis.

Financial results

Total income was £20,836, the majority of this came from a grant received from the National Lottery Community Fund. Total expenditure was nil. The surplus for the period was £20,836.

Policy on reserves

The Executive Committee regularly review the Reserves policy of the charity to ensure it meets the needs of the Charity. As we are in the first period of operation, we are working on building up sufficient unrestricted reserves to ensure a sufficient buffer to enable effective financial decision-making, rather than short term decisions and to ensure effective financial stewardship of the Charity.


