Lighthouse AGM

1. Opening Prayer:

Rev Cassa Messervy opened the meeting with prayer;

2. Welcome and Apologies:

Rev CM welcomed everyone to the first Lighthouse AGM and apologies were received from those who were unable to attend;

3. Chair's Report:

This was the second year of Lighthouse Haddenham and what a fantastic year it was! The first 'thank you' goes to God, who poured out His Spirit on this event and made it such a special way of witnessing the Gospel in Haddenham. With 180 children registered and a high of 150 children on site, we can say that this event had a significant appeal and impact in our local area.

Management Team: Lighthouse Trustees – Cassa Messervy (Chair), Dianne Brackley (Vice Chair) Jonny Fillis, Loraine Milmer, Naomi Foreman-Peck, Cassie Childs (Officer - co-Treasurer) and Alex Reading (Officer – co-Treasurer), Val Walker (Safeguarding officer), Colin Brackley (Site Manager) The Trustees and Officers get the next big 'thank you' for their willingness to step out in faith and ability to hold the vision for this amazing event. We have an able team with a range of skills which came together beautifully over the week. Part of the structure of Lighthouse Haddenham is the support of Lighthouse Central, so ably led by Pat Reading and her team. They have enabled so much of the organisation of this event to run smoothly.

Volunteers: We had over 100 volunteers signed up to help in various ways across the week. They gave up their time to ensure that the children had a great time and the wonderful thing about that, is that they had a great time too! We are incredibly thankful for the cheerfulness, grace and dedication of all our volunteers. Without their willingness to get stuck in, Lighthouse would not happen! It was wonderful to see the range of ages of our volunteers, from 12 to 86! They are all stars! A massive 'thank you'!

Teaching, Activities, Main Stage: Our teaching theme this year had an Olympic flavour with many fun activities and games based on the Olympics. Each day we thought about Bible stories about Peter (the rock) who was willing to 'Change', 'listen', 'trust', 'forgive' and 'believe'. Our Age Group Teachers, Age Group Leaders and Main Stage crew used the resources provided with creativity and flare; the children learned a lot across the week. Our Craft team was superb, creating some wonderful craft activities for the children. The Sport team was also outstanding, creating fun activities for the children from a 'blank canvas'.

Finances: The accounts are available and show a reasonable balance at the end of the year. We are very grateful for the support of organisations like the Haddenham Beer Festival and Aylesbury Deanery and all the churches in Haddenham that have given generous grants. Similarly, we received many donations during the week from the parents of the children attending and generous one-off donations from individuals, for which we are very thankful and without which we would not be able to run such a good event.

Fruits and Next Year: One of the fruits of Lighthouse this year has been two new Churches Together in Haddenham initiatives: a fortnightly club for KS2 (7 -11 yrs) children and a Youth Club called 'Ignite' (11-18 yrs), which is running three times a half term.

Given the success of this year, Lighthouse Haddenham will run again in 2025 from Monday 18th of August to Friday 22nd August.

Cassa Messervy (Chair of Trustees)

The Treasurers reported that the funds stand at just under half-way towards next year's costs. It was questioned as to whether parents should pay a donation at the time of registering as funds came in slowly to start with and then gradually increased. It was found that sometimes people weren't able to contribute by the end of July and some didn't pay until the end of August. It was reported that there have been some large donations from other sources which may or may not continue. One member of the committee reported that last year when her finances were not so good, she was so grateful to be able to send the children. It was agreed that there should always be provision for children whose parents may not be able to make a donation. Feb – Sept 2023 KW held £6,300 and ended the year with £506 in the bank. The cost per child works out at £42 per child and £11 per child was received. In 2024 £16,000+, 17% from organisations, 28% from individuals. The year ended with a balance of £5,140. MJ thanked the Trustees and the team; their hard work was much appreciated. Thanks to Lucy Brighthouse, who has a contact at the local Gym, they are holding a Charity fund-raising day and some of the proceeds will be donated to Lighthouse.

5. General Feedback:

Dianne Brackley was pleased to report that during the whole of the time (29 years) that she has lived in Haddenham, all the churches have worked together under the banner of CTiH and she had noticed that so many who weren't regular churchgoers also wanted to be a part of Lighthouse. Some of the folk who were invited to come and see what was happening, were astonished at the professional quality of the teaching; she expressed gratitude at God's provision. Lucy Brackley felt that it was a very positive experience and that a child who had been away on holiday at the time and heard all about it afterwards from friends, felt that he had missed out. All of the children from the different churches quickly made friends and as a result there has been the formation of 'The Dangerous Club' and 'Ignite' and all those attending have good fun. After Lighthouse 2022 a homegroup 'The Big Question Tea' was formed for smaller children and is led by Tom and Vanessa E in their home. AW reflected on how valuable it had been to be able to pray with the teenagers before their exams.

6. Appointment of Trustees:

All of the Trustees are happy to stand again and the Treasurers are willing to continue in that role. The meeting unanimously appointed the Chair, Vice Chair, Trustees and Treasurers. Val Walker was proposed as Safeguarding Officer by Rev CM and seconded by Colin Brackley.

Trustees Annual Report

Financial Review

In the year to 30 September 2024 Lighthouse Haddenham's income totalled £16,634. 72% donations from organisations and 28% donations from individuals. This is an increase of 144% on FY2023. Expenditure totalled £11,971, an increase of 90% on FY2023, with 68% spend on direct costs, including hire of tents and large equipment and 32% on overheads, including subscriptions, insurance etc. Increased spend on resources, e.g. crafts, was popular with the children and a number of higher value items were purchased for use in future years.

Lighthouse Haddenham ended the year with £5,140 in the bank.

With 180 registered children at Lighthouse Haddenham 2024, the running cost per child averaged £67.

The average donation received per child was £25.

The financial health of Lighthouse Haddenham is reasonable, but Lighthouse Haddenham 2025 will rely on the generosity of donors in the coming months.

Financial Review

In the year to 30 September 2023 Lighthouse Haddenham's income totalled £6,806. 76% donations from organisations and 24% donations from individuals.

Expenditure totalled £6300, with 70% spend on direct costs, including hire of tents and large equipment and 30% on overheads, including advertising, insurance etc.

Lighthouse Haddenham ended the year with £506 "in the bank".

With 152 registered children at Lighthouse Haddenham 2023, the running cost per child averaged £42. The average donation received per child was £11.

The financial health of Lighthouse Haddenham will depend on the generosity of donors in the coming months. Substantial funds will need to be raised to run Lighthouse Haddenham in 2024. However, with 2 large donors in the pipeline prospects are looking positive.
