About Riverway Community

Riverway Community is a faith-based organisation committed to serving the local community through a variety of ministries, services, and outreach programmes. Our mission is to provide practical support, encouragement, and spiritual guidance to individuals and families, with a focus on building resilience, fostering wellbeing, and creating opportunities for positive change. Under the umbrella of Riverway Community, we have developed initiatives that respond to identified needs in the community, including the establishment of Aylesbury Women's Centre, which provides targeted support for women and families.

The Board has continued to provide oversight, guidance, and accountability throughout the year.

Aylesbury Women's Centre (under the covering of Riverway Community)

During the reporting year, Riverway Community established and oversaw the work of Aylesbury Women's Centre, a vital new ministry providing support to women across Aylesbury and the surrounding areas.

The Centre has become a trusted and safe space where women can find encouragement, support, and practical help. Its work focuses on empowering women to overcome challenges, build resilience, and create positive futures for themselves and their families.

Key services delivered include:

- Therapeutic and aftercare support, helping women recover from trauma and rebuild confidence.
- Educational and skills-based courses, improving employability, financial literacy, and personal development.
- Peer support and community groups, reducing isolation and fostering strong, supportive networks.
- Practical support, through the Baby Bank and the provision of food vouchers to families in crisis.
- Signposting and advocacy, ensuring women can access specialist services and additional opportunities for growth and stability.

By addressing both emotional well-being and practical needs, Aylesbury Women's Centre takes a holistic approach that equips women with the tools, confidence, and support to move forward.

Staffing

To deliver this important work, Riverway Community engaged three women on a self-employed, part-time basis. Their skills, dedication, and commitment have been instrumental in ensuring that the Centre's services remain high-quality, accessible, and responsive to the needs of women and families in the community.

Pastor's Report and Declaration

Year Ending 31st January 2025

The financial statements for the year ending 31st January 2025 are presented with this report, including details of Income and Expenditure and the Bank Reconciliation as of 31st January 2025. Throughout the year, regular giving, offerings, and donations have just covered the expenditure required to sustain the services and ministries undertaken. While this has enabled us to continue meeting the needs of our congregation and community, it has also highlighted the importance of securing additional sources of income to expand and strengthen our work.

During this period, it was essential to secure alternative funding to support the new ministry of Aylesbury Women's Centre, established under the covering of Riverway Community.

We are pleased to report that the Centre was awarded a grant from the Thomas Hickman Charity, which was received and deposited in February 2024. This funding has enabled the Centre to begin delivering vital services to women and families in our community.

We continue to keep church costs to a minimum whilst ensuring that the needs of the local community are met effectively. However, Riverway Community faces the ongoing challenge of increasing regular giving in order to ensure financial sustainability and support future growth over the coming year.

I would like to take this opportunity to thank all who have faithfully given and supported the work of Riverway Community and Aylesbury Women's Centre. Your generosity, prayers, and service remain the foundation upon which our ministries continue to grow.
