## **Trustees' Annual Report for TARA CARE UK**

Charity Number: 1201898

Period Covered by the Report: 1 April 2024 to 31 March 2025

### **1. Introduction**

TARA CARE UK exists to relieve sickness and preserve health among disadvantaged communities in India, with a particular focus on eye care. The charity provides financial assistance for medical treatment for people suffering from blindness and other eye conditions and supports the provision of eye care facilities and equipment to improve access to treatment.

This Trustees' Annual Report outlines the charity's activities, governance, and financial position for the period from 1 April 2024 to 31 March 2025.

### **2. Trustee Statement**

The trustees confirm that they have acted in accordance with their duties under charity law and have ensured that TARA CARE UK continued to operate in support of its charitable objectives throughout the reporting period.

During the year, the trustees focused on maintaining effective oversight of the charity, safeguarding its resources, and ensuring that funds held were managed prudently and in line with the charity's purposes.

### **3. Objectives and Activities**

#### **Mission and Purpose:**

TARA CARE UK's mission is to support poor and vulnerable individuals in India by enabling access to essential eye care services, including cataract surgery and related treatments, and by supporting eye care infrastructure. The charity also seeks to support the welfare of elderly individuals living in poverty.

#### **Activities During the Year:**

During the reporting period, the charity's activities focused primarily on maintaining relationships with partner organisations, monitoring previously supported initiatives, and planning future programmes.

#### 4. Review of Achievements and Public Benefit

The trustees are satisfied that the charity continued to deliver public benefit by preserving funds for future eye care and elderly support initiatives.

#### 5. Financial Review

The charity adopted a cautious financial approach during the year, with limited expenditure and funds retained for future charitable activities.

# Trustee Report for TARA CARE UK

**Charity Number:** 1201898

**Period Covered by the Report:** 9 February 2023 to 31 March 2024

## 1. Introduction

TARA CARE UK is dedicated to the relief of sickness and the preservation of health for the poor in India, with a focus on eye care. Our mission is to provide financial assistance for medical treatment for those suffering from blindness or other eye conditions. In addition, we support the provision of eye care facilities and equipment to improve access to treatment, especially for the most disadvantaged. This report outlines the activities, achievements, and financial status of the charity for the period from **9 February 2023 to 31 March 2024**.

## 2. Trustee Statement

As trustees of TARA CARE UK, we confirm that we have fulfilled our responsibilities to ensure the charity operated in line with its charitable objectives during the reporting period. We have overseen the allocation of funds, ensuring they were used effectively to support eye care services and other initiatives for the poor in India. This report reflects our dedication to transparency, accountability, and delivering tangible impact in the communities we serve.

## 3. Objectives and Activities

### **Mission and Purpose:**

TARA CARE UK's mission is to support the poor in India by providing financial assistance for eye treatments, including cataract surgery and other necessary eye care, as well as supporting the establishment and maintenance of eye care infrastructure.

### **Key Activities:**

During the reporting period, TARA CARE UK has undertaken the following activities:

- **Eye Camps and Cataract Surgeries:** We organised **10 eye camps** in various locations, where **71 cataract surgeries** were performed on individuals suffering from cataracts.
- **Support for Udalpur Eye Hospital:** In partnership with **Udalpur Eye Hospital**, we funded **292 cataract surgeries** for poor individuals diagnosed at the hospital, ensuring they had access to the treatment they urgently needed.
- **Old Age Home Support:** We also focused on the welfare of elderly individuals by adopting **2 residents for one year** at an old age home in Udalpur, providing them with food, shelter, and care. In addition, we ensured that **40 other residents of the same old age home** were provided with food and daily sustenance.

These activities were made possible through the generous donations and support of our partners, volunteers, and donors, enabling us to address both immediate and long-term needs in the communities we serve.

## 4. Achievements and Impact

TARA CARE UK's initiatives during the period from **9 February 2023 to 31 March 2024** have had a profound impact on the lives of those we served:

- **Eye Camps:** Through the **10 eye camps** organised, we were able to provide free eye examinations, diagnoses, and cataract surgeries to individuals who would otherwise not have had access to care. **71 cataract surgeries** were completed, restoring sight and improving the quality of life for those who were suffering from preventable blindness.
- **Cataract Surgeries at Udalpur Eye Hospital:** At **Udalpur Eye Hospital**, a total of **292 cataract surgeries** were performed, giving individuals from impoverished backgrounds the opportunity to regain their sight and lead independent lives.
- **Support for the Elderly:** Our adoption of **2 residents for one year** at the old age home in Udalpur has provided these individuals with the necessary care and dignity in their later years. In addition, **40 other elderly residents** benefited from regular food provisions, ensuring their basic needs were met.
- **Community Outreach:** By organising these activities, we reached numerous individuals in underserved areas who would not have had access to eye care or elderly support services without the intervention of TARA CARE UK.

## 5. Financial Overview

### Income and Expenditure:

TARA CARE UK's total income for the period was raised through donations and fundraising efforts:

- **Donations and Fundraising Events:** £25,805

**Total income for the period:** £25,805

Expenditures for the period included a grant to Tara Sanstan of £20,000 to fund

- **Eye Camps and Cataract Surgeries:**
- **Support for Udalpur Eye Hospital (292 surgeries)**
- **Old Age Home Adoption and Food Provisions**

In addition to £25 in banking fees

**Total expenditure for the period:** £20,025

### Financial Position:

At the end of the reporting period, TARA CARE UK had a surplus of £5,780. This surplus will be used to support the continuation and expansion of our programs in the future, particularly in providing additional eye care services and increasing the reach of our elderly support initiatives.

## 6. Governance and Structure

### Trustee Board:

The governance of TARA CARE UK is overseen by a board of trustees, who are responsible for ensuring the charity operates effectively and in line with its charitable mission. The following trustees served during the reporting period:

### Governance and Oversight:

The board meets regularly to review the charity's operations, ensuring that funds are used in accordance with our charitable objectives. We also ensure that the charity remains compliant with all regulatory requirements, upholding high standards of governance and accountability.

## 7. Future Plans

Looking ahead, TARA CARE UK plans to expand its impact and continue providing essential services to those in need. Our key objectives for the upcoming year include:

- **Increasing Eye Care Access:** We aim to organise additional eye camps and provide support for **more cataract surgeries** to individuals in need.
- **Expanding Support for Elderly Care:** We plan to adopt more residents at the old age home in Udalpur, extending support for their food, shelter, and health needs.
- **Eye Care Facility Development:** We will continue supporting eye care hospitals and clinics by providing funding for essential equipment and infrastructure.
- **Awareness and Outreach:** We will ramp up awareness campaigns in rural areas, encouraging early detection and treatment of eye conditions to prevent blindness.


