The Trustees submit their report together with the financial statements for the year ended 31 July 2025.

The financial statements comply with the Charities Act 2011, the governing documents and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102).

OBJECTIVES AND ACTIVITIES

The objects of the Orchestra shall be:

1. To provide an inclusive, welcoming and sociable musical environment for young orchestral players.
2. To advance the musical education of young people who live in and/or attend school in the Reading or surrounding areas through the provision of orchestral training and the opportunity to perform in public.
3. To further such community or musical purposes as the Trustees shall think fit.

ACHIEVEMENTS AND PERFORMANCE

Across the year, there were between 40 and 46 members, which is a good level of growth from last year (34-38 members). We provided our young players with termly performance opportunities during the year:

- End of term performance in December 2024, featuring a mixture of orchestral pieces, carols and pieces by soloists and small groups of students.
- Held our formal Spring Concert in March 2025, featuring one of our members performing his own composition as soloist with the orchestra. Alongside this we played a mix of more traditional repertoire by Beethoven and Debussy, and a rarely performed piece by Bourgeois.
- Invited parents and supporters to an end-of-term celebration of our students' work in July 2024, featuring orchestral pieces plus solos and small groups from the young players.

We were also invited to perform in Reading town centre at the opening of the new Station Hill development, which was a great opportunity to perform in a different environment within the community. Our continued relationship with the Aldworth Philharmonic and Reading Symphony orchestras have continued to open doors for several members to play as part of local adult orchestras in several of their concerts.

We continue to build our students musical knowledge and repertoire, providing esteemed local musicians for coaching and support. We seek out works to learn from both traditional classical and modern film and theatre genres, ranging from Beethoven, Debussy, Tchaikovsky and Dvorak to music from the Phantom of the Opera, Star Wars and The Lion King.

We also maintain our ongoing relationships with local schools The Abbey and St Joseph's, the latter providing us with our rehearsal venue for two terms, as well as making a new connection with Loddon Primary School which formed our venue for the Summer term.

Behind the scenes, the rollout of our new Google Workspace took place in September, providing us with more formal email accounts and better storage, allowing for more efficient and smoother operations and communication with members.

FUTURE PLANS

This coming year will feature end of term performances for parents in the Autumn and Summer, and our formal Spring Concert planned for March 2026. We are continuing with our successful format of inviting orchestra members to form small ensembles for the Autumn and Summer performances, and are looking into how we can support their rehearsal process further. We are in conversations with another local school about a joint concert with them, which would celebrate the music of a RYO alumnus.

We will continue to organise social events throughout the year, and have established a Social Committee as a sub-group of the main committee for this purpose, including representation from our young members.

PUBLIC BENEFIT

The Trustees have considered the guidance notes provided by the Charity Commission on "Charities and Public Benefit" when deciding on the activities for the year. In assisting develop both the musical talent and self-confidence of young people, the Charity hopes to improve their lives and their contribution to Reading society.

RISKS

The Trustees are continuing to review the major risks to which the Charity is exposed and consider systems to mitigate those risks

RESERVES POLICY

In the development period of the Charity reserves must be held to ensure that sufficient funds are available to commit to the hire of rehearsal venue space costs as well as being able to meet any shortfall in the event that a concert performance fails to attract sufficient ticket sales. The Trustees are aware that significant inflation will erode these reserves, and as the orchestra grows, the demands for larger space to operate should increase the level of reserves put aside to manage the Charity in a responsible and resilient way. The Trustees consider a reserve level of up to £25,000 appropriate at the current time. Our reserves at the balance sheet date of £23,414 go a long way towards achieving the £25,000 target level previously set by the Trustees.

FINANCIAL REVIEW

Income for the year totalled £12,164 (2024:£10,767). Our concert made a small surplus of approximately £270 (2024:surplus £380). Although membership subscriptions rose slightly, this was more than offset by increased venue hire costs resulting in a slightly lower surplus than last year. The funds available increased from £17,789 to £23,414.

INVESTMENT POLICY

The Charity holds insufficient reserves to hold them in any other form than cash. Short term surplus cash is placed in an interest-bearing deposit account.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Reading Youth Orchestra can trace its roots back to before the end of the war in 1944. The Orchestra was registered as a Charitable Incorporated Organisation with the Charity Commission on 2 March 2023 with Charity number 1202139.

The current constitution was amended by EGM special resolution dated 6 April 2022.



1. CHARITY INFORMATION

The principal activity of the entity is the operation of Reading Youth Orchestra. The Orchestra is registered with the Charity Commission England and Wales. The principal address of the entity is 27 Gipsy Lane, Wokingham, Berkshire, RG40 2BN.

2. ACCOUNTING POLICIES

a) Basis of Accounting

The accounts have been prepared in accordance with the Charities SORP (FRS102) applicable to charities preparing their accounts in accordance with the Financial Reporting Standards applicable in the UK and Republic of Ireland and the Charities Act 2011 and UK Generally Accepted Practice as it applies from 1 January 2019.

The accounts have been prepared to give a 'true and fair' view and have departed from the Charities (Accounts and Reports) Regulations 2008 only to the extent required to provide a 'true and fair view'. This departure has involved following Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102).

Reading Youth Orchestra meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy note.

The Trustees have considered the current financial reserves and anticipated cash flows for the coming year and believe it appropriate to adopt the going concern basis of accounting in preparing the financial statements

b) Critical accounting judgements and key sources of estimation uncertainty

In the application of the Charity's accounting policies, which are described in note 2a, Trustees are required to make judgements, estimates and assumptions about the carrying value of assets and liabilities that are not readily apparent from other sources. The estimation and underlying assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an on-going basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of revision and future periods if the revision affects the current and future periods.

In the view of the Trustees, no assumptions concerning the future or estimation uncertainty affecting the assets and liabilities at the balance sheet date are likely to result in a material adjustment to their carrying amounts in the next financial year.

2. ACCOUNTING POLICIES (continued)

c) Financial Instruments

The Charity only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value.

d) Income

All incoming resources are included in the statement of financial activities when the entity is entitled to the income, receipt is probable, and the amount can be quantified with reasonable accuracy.

Donated services and facilities are included at the value to the Charity where this can be quantified. Gifts-in-kind have been included at market value. The value of service of volunteers has not been included in these accounts.

e) Expenditure

Resources expended are accounted for on an accruals basis.

f) Value Added Tax

The Charity is precluded from registering for VAT as its activities are exempt under legislation. Expenditure is stated inclusive of VAT.

g) Debtors

Debtors are recognised at the settlement amount due. Prepayments are valued at the amount prepaid.

h) Creditors and provisions

Creditors and provisions are recognised when the Charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably.

2. ACCOUNTING POLICIES (continued)

i) Cash and cash equivalents

Cash is represented by cash in hand and deposits with financial institutions repayable without penalty on notice of not more than 24 hours. Cash equivalents are highly liquid investments that mature in no more than three months from the date of acquisition and that are readily convertible to known amounts of cash with insignificant risk of change in value

j) Taxation

HM Revenue & Customs has agreed that the entity is entitled to exemption from income tax, being established for charitable purposes only. Accordingly, no tax liability arises on any surplus derived from the entity's activities.

3. ACCUMULATED FUNDS

The fund and its income and expenditure are unrestricted within the boundaries of the objectives as shown in the Trustees' Report.

The Trustees have established a designated fund of £1,000 to support students develop their musical talent, or provide musical opportunities which they may not otherwise be able to afford.

4. TRUSTEES' REMUNERATION

No Trustees received any remuneration for services as a trustee during the year (2024: none).

One trustee was paid £2,000 (2024: £1,200) for her role as artistic director and conductor to the orchestra. This payment was authorised in accordance with strict rules associated with such payments set out in accordance within the constituting documents.

ACHIEVEMENTS AND PERFORMANCE

Across the year, there were between 34 and 38 members, which is a good level of growth from last year (31-32 members). We provided our young players with termly performance opportunities during the year:

- End of term performance in December 2023, featuring a mixture of orchestral pieces, carols and pieces by soloists and small groups of students.
- Celebrated our 80th Anniversary in a prestigious concert alongside Reading Symphony Orchestra in April 2024. Our orchestra played music from Lord of the Rings, then joined the adult orchestra on stage for a huge performance of Elgar's Enigma Variations.
- Invited parents and supporters to an end-of-term celebration of our students' work in June 2024, featuring orchestral pieces plus solos and small groups from the young players.

In addition to performing, our members also benefit from social events such as watching the Royal Philharmonic Orchestra perform, and games and quiz nights. Our continued relationship with the Aldworth Philharmonic Orchestra, and our new relationship with Reading Symphony Orchestra, have continued to open doors for several members to play as part of local adult orchestras in several of their concerts.

We continue to build our students musical knowledge and repertoire, providing esteemed local musicians for coaching and support. We seek out works to learn by both well-known and lesser-known composers, such as Verdi, Elgar, Von Suppe, and De Beriot, as well as performing works by our RYO alumni.

The Trustees consider a reserve level of up to £25,000 appropriate at the current time.

FINANCIAL REVIEW

Income for the year totalled £10,767 (2023:£9,091). This includes £500 share of income from the joint concert (2022: concert ticket sales £1,032). Our concert generated a surplus of £380 (2023:£462) which has been added to our reserves. The funds available increased from £11,980 to £17,789.

The charity holds insufficient reserves to hold them in any other form than cash. Short term surplus cash is placed in an interest-bearing deposit account.

Charity law requires the Trustees to prepare financial statements for each financial year in accordance with United Kingdom Generally Accepted Accounting Practice (United Kingdom Accounting Standards) and applicable law. Under charity law the Trustees must not approve the financial statements unless they are satisfied that they give a true and fair view of the state of affairs of the charity and of its net incoming resources for that period. In preparing these financial statements, the trustees are required to:

- ensure that the most suitable accounting policies are established and applied consistently;
- make judgements and estimates which are reasonable and prudent;
- state whether the applicable accounting standards and statement of recommended accounting practice have been followed, subject to any material departures disclosed and explained in the financial statements; and
- Prepare the financial statements on a 'going concern' basis unless it is inappropriate to presume that the charity will continue in operation.

The Trustees have overall responsibility for ensuring that the charity has appropriate systems and controls, financial and otherwise. They are also responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity and enable them to ensure that the financial statements comply with the 2011 Charities Act. They are also responsible for safeguarding the assets of the charity and for their proper application as required by charity law, and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities and to provide reasonable assurance that:

- the charity is operating efficiently and effectively;
- all assets are safeguarded against unauthorised use or disposition and are properly applied;
- proper records are maintained and financial information used within the charity, or for publication, is reliable;
- the charity complies with relevant laws and regulations.

1. CHARITY INFORMATION

The principal activity of the entity is the operation of Reading Youth Orchestra. The Orchestra is registered with the Charity Commission England and Wales. The principal address of the entity is 27 Gipsy Lane, Wokingham, Berkshire, RG40 2BN.

2. ACCOUNTING POLICIES

a) Basis of Accounting

The accounts have been prepared in accordance with the Charities SORP (FRS102) applicable to charities preparing their accounts in accordance with the Financial Reporting Standards applicable in the UK and Republic of Ireland and the Charities Act 2011 and UK Generally Accepted Practice as it applies from 1 January 2019.

The accounts have been prepared to give a 'true and fair' view and have departed from the Charities (Accounts and Reports) Regulations 2008 only to the extent required to provide a 'true and fair view'. This departure has involved following Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102).

Reading Youth Orchestra meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy note.

The trustees have considered the current financial reserves and anticipated cash flows for the coming year and believe it appropriate to adopt the going concern basis of accounting in preparing the financial statements

c) Critical accounting judgements and key sources of estimation uncertainty

In the application of the charity's accounting policies, which are described in note 2, trustees are required to make judgements, estimates and assumptions about the carrying value of assets and liabilities that are not readily apparent from other sources. The estimation and underlying assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an on-going basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of revision and future periods if the revision affects the current and future periods.

In the view of the trustees, no assumptions concerning the future or estimation uncertainty affecting the assets and liabilities at the balance sheet date are likely to result in a material adjustment to their carrying amounts in the next financial year.

2. ACCOUNTING POLICIES (continued)

d) Financial Instruments

The charity only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments are initially recognised at transaction value and subsequently measured at their settlement value.

e) Income

All incoming resources are included in the statement of financial activities when the entity is entitled to the income, receipt is probable, and the amount can be quantified with reasonable accuracy.

Donated services and facilities are included at the value to the Charity where this can be quantified. Gifts-in-kind have been included at market value. The value of service of volunteers has not been included in these accounts.

f) Expenditure

Resources expended are accounted for on an accruals basis.

i) Value Added Tax

The Trust is precluded from registering for VAT as its activities are exempt under legislation. Expenditure is stated inclusive of VAT.

j) Debtors

Trade and other debtors are recognised at the settlement amount due after any trade discount offered. Prepayments are valued at the amount prepaid after taking account of any trade discounts due.

k) Creditors and provisions

Creditors and provisions are recognised when the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably.

l) Cash and cash equivalents

Cash is represented by cash in hand and deposits with financial institutions repayable without penalty on notice of not more than 24 hours. Cash equivalents are highly liquid investments that mature in no more than three months from the date of acquisition and that are readily convertible to known amounts of cash with insignificant risk of change in value

m) Taxation

HM Revenue & Customs has agreed that the entity is entitled to exemption from income tax, being established for charitable purposes only. Accordingly, no tax liability arises on any surplus derived from the entity's activities.

3. ACCUMULATED FUND

The fund and its income and expenditure are unrestricted within the boundaries of the objectives as shown in the Trustees' Report.

During the year the trustees have established a designated fund of £1,000 to support students develop their musical talent, or provide musical opportunities which they may not otherwise be able to afford.

4. TRUSTEES REMUNERATION

No trustees received any remuneration for services as a trustee during the year (2023: none).

One trustee was paid £1,200 (2023: £1,200) for her role as artistic director and conductor to the orchestra. This payment was authorised in accordance with strict rules associated with such payments set out in accordance within the constituting documents.
