The Trustees present their report and the financial statements for the year ended 31 March 2024

Governing Instrument:

The charity's objects and regulations are regulated by the constitution adopted in 1994 and the charity is an unincorporated association.

The objects of the charity is to provide the following activities:

For the public benefit, (a) the prevention and relief of poverty in the UK and overseas by providing grants, items and services to individuals in need and/or charities, or other organisations working to prevent or relieve poverty, including but not limited to supporting themes in areas such as food, education, water and sanitation, and health. (b) the advancement of health or the saving of lives in particular, but not exclusively, through financial support to medical facilities in the UK and elsewhere in the world. (c) to advance the Islamic faith and religious practice through the provision and maintenance of mosques and religious centres in the UK and overseas.

The charity is organised with a committee (Board of Trustees) elected by the members to oversee the overall activities and one of the committee member is nominated as chairperson, to monitor the day to day running of the charity.
