The charity raises funds and distributes them directly or via other charities to provide water wells/pumps, food packs, education and clothing to those in need in the UK and around the world.

The main focus is for 3rd world countries, especially Pakistan.

The charity does not hold any reserves. All money that is left over at the year end is for upcoming projects.

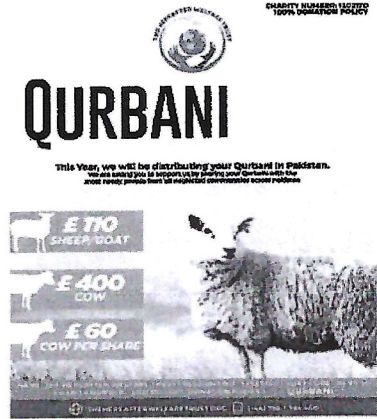
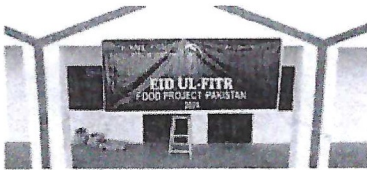


