### Trustees' annual report for the period ending 31 March 2025

The Trustees present their report together with the financial statements for the period ending 31 March 2025.

#### Introduction from the Chair

We are delighted to present to you the 2025 Report and Accounts for Spencer Dayman Meningitis Research, which showcases our charity's progress and achievements in our 2nd financial year 2024-2025. The continued dedication of our supporters, volunteers and trustees resulted in exceeding our financial targets again and we are proud to share this achievement with them, so many of whom are families who have been affected by meningitis and other associated diseases. The financial support of grant giving Trusts and Foundations, community organisations, companies and individuals was truly appreciated.

We also extend our gratitude to our Scientific Medical Advisory Panel for their general advice and guidance, giving their time to monitor our first preventative vaccine development research project entitled: **Group A Strep Aviator Study** which commenced in October 2023. In addition, they evaluated and approved our 2<sup>nd</sup> preventative research study entitled: **Gold bionanoconjugates for the rapid detection of bacteria causing sepsis and meningitis**. This is a 12-month study to provide evidence to develop a diagnostic kit to detect sepsis, meningitis and other associated diseases in five minutes. This study commenced in November 2024. Their invaluable support ensures this charity funds relevant, meaningful preventative research of the highest quality.

Despite our successful year, the heart-breaking reality remains that there are still many infections that cause meningitis and other associated diseases that are not vaccine preventable. Since the end of the Covid pandemic, we have seen a rise in the number of infectious diseases including meningitis and other associated infections.

This confirms the continuing importance of our vital work, to fund preventative research, improve diagnosis into meningitis, sepsis and other associated diseases, support families affected and raise awareness regarding the signs and symptoms.

#### Objects

Spencer Dayman Meningitis Research was registered with the Charity Commission for England and Wales on 6 March 2023, and with the Office of the Scottish Charity Regulator on 7 August 2023.

The objects of the charity are:

1. To advance the education of the public in general (and particularly amongst scientists) in the prevention and treatment of meningitis and other associated diseases by promoting and funding research for the public benefit in all aspects of that subject and to publish the useful results.
2. For the public benefit, to relieve the needs of those affected by meningitis and other associated diseases, and their families by means of:
  - a. the provision of peer-to-peer support and practical advice;
  - b. raising public awareness.

The Trustees confirm that they have had regard to public benefit guidance published by the Charity Commission in determining the activities undertaken by the charity.

The charity does not employ any staff and relies entirely on volunteers, including our Principal Officer, Dr Steve Dayman MBE who also provides the office, rates, heat and light at no charge to the charity.

#### Achievements and Performance

The charity was registered on 6th March 2023 to support preventative scientific research into meningitis and other associated diseases, provide peer support to families affected by these diseases and raise awareness regarding the importance of recognising the signs and symptoms of meningitis and other associated diseases.

The charity's website ([www.spencerdaymanmeningitisresearch.org](http://www.spencerdaymanmeningitisresearch.org)) highlights our important work including providing diseases facts. We are grateful for the support of the Starfish Trust who continue to sponsor the maintenance of the website. We are also active on social media platforms including Facebook, Instagram and LinkedIn.

#### **Supporting preventative research at the Spencer Dayman Meningitis Laboratories, Bristol Vaccine Centre, University of Bristol.**

Progress continues regarding the development of safe and effective vaccines which Spencer Dayman Meningitis Research wholeheartedly supports.

We take great pride in ensuring that the preventative research we fund is of the highest quality. To achieve this, we rely on the expertise of our eminent Scientific Medical Advisory Panel, renowned for their knowledge and experience in infectious diseases. Their vast understanding in their respective fields is invaluable to us and we are grateful to them for giving their time to support our work.

#### **Research Project: Aviator Group A Strep Vaccine Study: October 2024 – October 2027**

Our first research project, **Aviator Group A Study**, commenced on 1st October 2023. Group A Streptococcus (GAS) or "Strep A" is a bacterium which can cause a range of diseases from mild infections affecting the throat and skin to severe infections including meningitis, pneumonia, rheumatic fever and sepsis. It is estimated that GAS causes over half a million deaths each year worldwide, many of whom are children.

The diseases caused by GAS have been increasing in recent years, despite the availability of antibiotics to treat these infections. GAS bacteria are usually transmitted through the throat, mouth and nose. A vaccine which could prevent GAS from infecting the throat, mouth and nose would greatly reduce the impact of GAS diseases. There is no vaccine available for GAS and it is unclear which parts of the bacteria (called antigens) to include in a vaccine.

Lead scientists for this research project are:

- Dr Anu Goenka - Clinical Lecturer & Honorary Consultant in Paediatric Immunology & Infectious diseases
- Dr Alice Halliday – Lecturer in Infectious Diseases
- Prof Darryl Hill – Professor in Infectious Diseases

The team have developed an innovative approach that uses a new technique called tonsil organoid model. Tonsils are part of the immune system which help us fight infection. The research involves growing cells from tonsils of patients which were removed during routine surgery. To do this the team will separate out the cells and then grow the cells in the laboratory alongside different parts of the GAS bacteria. They will then measure the immune response of the tonsil cells from different donors to help them make decisions on which parts of the GAS bacteria could be included in a successful vaccine. Due to new findings and after consultation with our Scientific Medical Advisory Panel, the researchers will apply to Spencer Dayman Meningitis Research in the spring of 2025 to extend the project for a further two years. Scientific merit permitting, the extension will run to October 2027.

The Expected outputs are:

1. Peer-reviewed paper(s) within 2 years
2. Project grant or fellowship award with industry partnership to utilise findings

During the year, Dr Goenka presented his findings at Imperial College London and the University of Cardiff, with acknowledgements to Spencer Dayman Meningitis Research.

#### **Research Project: Gold bionanoconjugates for the rapid detection of bacteria causing sepsis and meningitis: November 2024 – October 2025**

This 12 month project aims to provide the evidence to develop a diagnostic kit to diagnose meningitis, sepsis and other bacterial disease in five minutes.

Early onset of meningitis and sepsis is very difficult to detect and delay in medical treatment can often be catastrophic. In order to inform the most important type of treatment, it is essential to identify if the infection is caused by bacteria or a virus and specifically which bacteria.

At present, Identification can be slow, inaccurate and often leading to death and disability. The introduction of a rapid diagnostic kit has the potential to be rolled out not only in hospital environments but also health centers and GP surgeries. It will also reduce the deaths from meningitis and sepsis, and lifelong disability.

Lead scientists for this project are:

- Prof Darryl Hill - Professor in Infectious Diseases
- Dr Sean Davis - Senior Lecturer

Both the research teams have world-renowned reputations and have hosted investigators from around the world. These visits enhance the global scientific knowledge of meningitis and other associated diseases.

#### **Raising Awareness and Peer-to-Peer Support**

The charity promotes awareness of the important signs and symptoms of meningitis and other associated diseases on its website together with other disease information. Many families who have experienced the trauma that meningitis and other associated disease cause share their stories on our news pages to help raise awareness.

Disease awareness is also promoted through social media platforms. News items were also distributed to the print media nationally. Symptom cards and leaflets are distributed by volunteers to various locations local to where they live. During the year founder Dr Steve Dayman visited 26 families who have experienced meningitis and other associated diseases to provide peer-to-peer support, and other families were supported by phone.

#### **Fundraising Activities**

The driving force behind our fundraising activities are families that have been affected by meningitis and other associated diseases. Supporter fundraising has included:

- Sam Virgo Memorial Walk and Family Fun/Rounders Day in Gloucestershire raising over £3,000
- Golf Days in Nottingham organised by Colin Wagner and his son, Burt, in memory of Dylan Stott raising £2,100
- Neville Green's Golf Day in Cheshunt in memory of his niece, Alexandra, raising £1,200
- In Londonderry friends of Darren and Emma Cowie raised £1,100 from a sponsored football match

- Family and Friends of Andrew and Elaine Zographou raised £2,450 in memory of their son George
- Donations in memory of Chris Jackson raised over £2,000

- Lynne Dodgson donated £1,200 from her aborted trip to the Great Wall of China in memory of her son Michael.

Many of our supporters and trustees made personal donations, helped with collections throughout the country and taken on their own fundraising event.

### Financial Position

During the year the charity raised £120,009. Expenditure was £43,029. Our prudent management of funds donated by our supporters kept our fundraising expenditure to just under £0.03 for every £1 raised.

Our surplus was £76,980, with £72,501 in restricted funds, £22,894 in designated funds (the amount committed but not covered by restricted funds), and £84,752 in our unrestricted fund. Cash held on 31 March 2025 was £181,437.

Full details of both Income and Expenditure can be found in the notes accompanying the Accounts.

The trustees are satisfied the charity is a going concern and fit for purpose. In the Trustees view, the reserves should provide the charity with adequate financial stability and the means for it to meet its charitable objectives for the foreseeable future. With no paid staff or premises, the trustees aim to hold sufficient funds to meet its primary expenditure commitments which is its research funding.

### Reserves

The Trustees review the amount of reserves regularly. As at 31 March 2024, all the funds required for the remainder of the existing research commitment are held in restricted (£72,501) and designated (£22,894) funds, and unrestricted reserves are £84,752.

#### **Pay and Expenses**

Spencer Dayman Meningitis Research is a voluntary organisation with no paid staff. Although the trustees can claim travel expenses, none were claimed during the year. Similarly, the Scientific Medical Advisory Panel were not remunerated nor did they claim expenses.

#### **Plans for 2025-2026**

Spencer Dayman Meningitis Research will continue to build on the success of its first 2 years to provide financial support towards innovative preventative research into meningitis, sepsis and other associated diseases. After discussions with our Scientific Medical Advisory Panel, we have invited scientists with track records into the prevention of infectious diseases at the Spencer Dayman Meningitis Laboratories, Bristol Vaccine Centre, University of Bristol to apply for research grant aid in the first quarter of the financial year 2025-26 with the aim of commencing the funding of new preventative research projects during the latter part of 2025 and beyond.

We will also continue to raise awareness about these diseases and provide peer-to-peer support and practical advice to families affected.

There are no plans to employ paid staff and we will continue to rely on our volunteers and supporters to help us deliver our objectives.

#### **Structure, Governance and Management**

Spencer Dayman Meningitis Research was registered with the Charity Commission on 6th March 2023 and with the Scottish Regulator (OSCR) on 7th August 2023. The charity is controlled by its governing document: Constitution of a Charitable Incorporated Organisation (CIO). The strategic direction of the charity is determined by the Board of Trustees in consultation with the Principal Officer, Dr Steve Dayman.

The Trustees meet at least 4 times a year to ensure effective governance and delivery against plans and budgets. A system of delegation is in place and day to day responsibility for the operation of the charity rests with the Principal Officer. Working closely with the Board, the Principal Officer is responsible for ensuring that the work of the charity is carried out in line with the strategic direction determined by the Board of Trustees.

The charity trustees are mindful of suitably skilled persons to join the Board and, through their networks, they are watchful for potential candidates.

Spencer Dayman Meningitis Research is a voluntary charity with no paid staff.


#### Independent examiner's statement



**1. Accounting Policies**

The following accounting policies have been used consistently in dealing with items which are considered material in relation to the charity's accounts.

**(a) Basis of Accounting**

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019) - (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Charities Act 2011.

The charity is a public benefit entity. The financial statements have been prepared on a going-concern basis. The trustees consider that the charity holds sufficient reserves to achieve an orderly closure in the unlikely event of a loss of funding.

The financial statements are presented in sterling which is the functional currency of the charity and rounded to the nearest £.

**(b) Going Concern**

There continues to be a need for the charity. With no paid staff, the only major expenditure commitment is research grant funding, and there are sufficient funds at the year end, held in a designated fund, to fully fund the current research commitments. In addition, the charity holds £84,752 in unrestricted reserves. The trustees are satisfied that the charity is a going concern.

**(c) Fund Accounting**

Unrestricted funds are general funds that are available for use at the trustees' discretion in furtherance of the objectives of the charity.

Restricted funds are those donated for use in a particular area or for specific purposes, the use of which is restricted to that area or purpose.

**(d) Income**

Income from donations, grants and contracts is recognised where there is entitlement, probability of receipt and the amount can be measured with sufficient reliability.

Investment income, trading income and other income are recognised on a receivable basis.

**(e) Expenditure**

Expenditure is recognised on an accruals basis. Expenditure includes any Value Added Tax which is reported as part of the expenditure to which it relates.

- Expenditure on generating funds comprises costs associated with attracting income.
- Expenditure on charitable activities comprises those costs incurred by the charity in the delivery of its research, peer support and awareness raising. It includes both costs that can be allocated directly to each of these and those costs of an indirect nature necessary to support them.
- Support costs are allocated between the expenditure categories of the Statement of Financial Activities on a basis designed to reflect the use of the resource.

**(f) Taxation**

The charity is exempt from tax on income and gains falling within section 505 of the Taxes Act 1988 or section 252 of the Taxation of Chargeable Gains Act 1992 to the extent that these are applied to its charitable objects.

**(g) Cash at bank**

Cash at bank is in a current account and short term deposit accounts.

**(h) Creditors**

Creditors are recognised where the charity has an obligation that will result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably.

**(i) Debtors**

Debtors are recognised where there is an obligation that will result in the transfer of funds to the charity and the amount owing can be measured,

The Trustees present their first report since registration on 6 March 2023, together with the financial statements for the period ending 31 March 2024.

#### **Introduction from the Chair**

We are delighted to present to you the 2024 Report and Accounts for Spencer Dayman Meningitis Research, which showcases our charity's progress and achievements in our first year. The dedication of the supporters, volunteers and trustees resulted in exceeding our financial targets and we are proud to share this achievement with them, so many of whom are families who have been affected by meningitis and other associated diseases. The financial support of grant giving Trusts and Foundations, community organisations, companies and individuals was truly appreciated.

We also extend our gratitude to our Scientific Medical Adversary Panel for their advice and time to evaluate our first preventative vaccine development research project entitled: Group A Strep Aviator Study which commenced in October 2023.

Despite our successful year, sadly there are still many infections that cause meningitis and other associated diseases that are not vaccine preventable. This confirms the significance of continuing our vital work, to fund preventative research, support families affected and raise awareness regarding the signs and symptoms.

#### **Objects**

Spencer Dayman Meningitis Research was registered with the Charity Commission for England and Wales on 6 March 2023, and with the Office of the Scottish Charity Regulator on 7 August 2023.

The objects of the charity are:

1. To advance the education of the public in general (and particularly amongst scientists) in the prevention and treatment of meningitis and other associated diseases by promoting and funding research for the public benefit in all aspects of that subject and to publish the useful results.
2. For the public benefit, to relieve the needs of those affected by meningitis and other associated diseases, and their families by means of:
  - a. the provision of peer-to-peer support and practical advice;
  - b. raising public awareness.

The Trustees confirm that they have had regard to public benefit guidance published by the Charity Commission in determining the activities undertaken by the charity.

The charity does not employ any staff and relies entirely on volunteers, including our Principal Officer, Dr Steve Dayman MBE.

#### **Achievements and Performance**

The charity was registered on 6<sup>th</sup> March 2023 to support preventative scientific research into meningitis and other associated diseases, provide peer support to families affected by these diseases and raise awareness regarding the importance of recognising the signs and symptoms of meningitis and other associated diseases.

The charity's website went live in June 2023 ([www.spencerdaymanmeningitisresearch.org](http://www.spencerdaymanmeningitisresearch.org)) and highlights our important work including providing diseases facts. We are grateful for the support of the Starfish Trust who sponsored the development of the website. We are also active on social media platforms including Facebook, Instagram and LinkedIn.

#### **Supporting preventative research into Group A Streptococcus disease.**

Spencer Dayman Meningitis Research take great pride in ensuring that the preventative research we fund is of the highest quality. To achieve this, we rely on the expertise of our eminent Scientific Medical Advisory Panel, renowned for their knowledge in infectious diseases. Their vast knowledge and expertise in their respected fields is invaluable to us and we are grateful for them giving their time to support our work.

Our first research project, **Aviator Group A Study**, commenced on 1<sup>st</sup> October 2023 and is scheduled to complete in September 2024. Group A Streptococcus (GAS) or "Strep A" is a bacterium which can cause a range of diseases from mild infections affecting the throat and skin to severe infections including meningitis, pneumonia, rheumatic fever and sepsis. It is estimated that GAS causes over half a million deaths each year worldwide, many of whom are children.

The diseases caused by GAS have been increasing in recent years, despite the availability of antibiotics to treat these infections. GAS bacteria are usually transmitted through the throat, mouth and nose. A vaccine which could prevent GAS from infecting the throat, mouth and nose would greatly reduce the impact of GAS diseases.

There is no vaccine available for GAS and it is unclear which parts of the bacteria (called antigens) to include in a vaccine. The research is taking place at the Spencer Dayman Meningitis Laboratories in the University of Bristol. The scientists are:

- Dr Anu Goenka is a Clinical Lecturer & Honorary Consultant in Paediatric Immunology & Infectious Diseases
- Dr Alice Halliday is a Lecturer in Infectious Diseases
- Dr Darryl Hill is an Associate Professor in Infectious Diseases.

They have developed an innovative approach that uses a new technique called tonsil organoid model. Tonsils are part of the immune system which help us fight infection. The research involves growing cells from tonsils of patients which were removed during routine surgery. To do this the team will collect tonsils from 20 donors, separate out the cells and then grow the cells in the laboratory alongside different parts of the GAS bacteria. They will then measure the immune response of the tonsil cells from different donors to help them make decisions on which parts of the GAS bacteria could be included in a successful vaccine. The research study will run from October 2023 to September 2024.

The Expected Outputs are:

1. Peer-reviewed paper(s) within 2 Years
2. Project grant or fellowship award with industry partnership to utilise the findings.

#### **Raising Awareness and Peer-to-Peer support.**

The charity promotes awareness of the important signs and symptoms of meningitis and other associated diseases on its website together with other disease information. Many families who have experienced the trauma that meningitis and other associated disease cause share their stories on our news pages to help raise awareness. Disease awareness is also promoted through social media platforms. The charity's Aviator Group A Strep research project being undertaken at the University of Bristol was also featured on BBC TV. News items were also distributed to the print media nationally. Symptom cards and leaflets are distributed by volunteers to various locations local to where they live. During the year Founder Dr Steve Dayman visited 17 families who have experienced meningitis and other associated diseases to provide peer-to-peer support and supported other families by phone.

#### **Fundraising Activities**

The driving force behind our fundraising activities are families that have been affected by meningitis and other associated diseases. Our supporters started to hold events which included the Sam Virgo Memorial Walk which raised £1,250 and a Tough Mudder event organised by Peter Green Chilled, in memory of Ashley Scrivin, which raised over £2,500. The Charity's Gala Ball in Bristol raised over £11,000 and our grateful thanks go to the Bristol based B & A Group who underpinned the catering costs. Many of our supporters and trustees made personal donations, helped with collections throughout the country and took on their own fundraising event.

Our sincere thanks also go to the following corporate and charitable trust organisations who supported us in our first year: The de Laszlo Foundation, The Charles Lewis Foundation. The Hilda Clark Memorial Fund, The Annonndale Charitable Trust, Kirkpatrick Fraser Charitable Trust, The Oakdale Trust, The Peter Storrs Trust, Hospital Saturday Fund, Dezna Robins Jones Charitable Trust, The Thriplow Trust, The Samuel Scott of Yews Trust, Sylvia Aitken Charitable Trust, Santa Barbara Heights Charitable Trust, Elizabeth Way Charitable Trust, Bryan Guinness Charitable Trust, Wessex Water, Renishaw, The Barrett Foundation, B & A Group, Starfish Trust, and Edison Ford.

#### **Financial position**

During the year the charity raised £132,265. Of this, £47,876 was restricted to our research project and £23,714 was from a legacy. Expenditure was £29,098. Our fundraising expenditure represented just under 7p for every £1 raised.

Our surplus was £103,167, with £39,969 in restricted funds, £20,060 in designated funds (the amount committed and not yet spent on our current research contract), and £43,138 in our unrestricted fund. Cash held on 31 March 2024 was £104,067.

The trustees are satisfied the charity is a going concern and fit for purpose. In the Trustees view, the reserves should provide the charity with adequate financial stability and the means for it to meet its charitable objectives for the foreseeable future. With no paid staff or premises, the trustees aim to hold sufficient funds to meet its primary expenditure commitments which is its research funding.

The Trustees review the amount of reserves regularly. As at 31 March 2024, all the funds required for the remainder of the existing research commitment are held in restricted (£39,969) and designated (£20,060) funds, and unrestricted reserves are £43,138. Full details of both Income and Expenditure can be found in the Notes accompanying the Accounts.

#### **Plans for 2024-2025**

Spencer Dayman Meningitis Research will continue to build on the success of its first year to provide financial support towards innovative preventative research into meningitis and other associated diseases. We plan to invite scientists with track records into the prevention of infectious diseases to apply for research grant aid with the aim of commencing the funding of a new research project during the latter part of the financial year 2024-25.

We will also continue to raise awareness about these diseases and provide peer-to-peer support and practical advice to families affected.

There are no plans to employ paid staff and we will continue to rely on our volunteers and supporters to help us deliver on our objects.

#### **Structure, Governance and Management**

Spencer Dayman Meningitis Research was registered with the Charity Commission on 6<sup>th</sup> March 2023 and with the Scottish Regulator (OSCR) on 7<sup>th</sup> August 2023. The charity is controlled by its Governing document: Constitution of a Charitable Incorporated Organisation. (CIO) The strategic direction of the charity is determined by the Board of Trustees in consultation with the Principal Officer Dr Steve Dayman.

The founding Trustees are Louise Graham (Chair), Stephen Gazard, Quentin Stott and Stephen S Dayman Jnr. Prospective new trustees are recruited via adverts and personal networks. They are interviewed and references taken up prior to appointment. A new trustee, Mr David Booker, was appointed on 19<sup>th</sup> March 2024. After due diligence, the board of trustees agreed to the appointment of Mr Booker and are satisfied he will add value to the board with his sound business background.

The Trustees meet at least 4 times a year to ensure effective governance and delivery against plans and budgets. The trustees give their time free and no expenses were claimed. A system of delegation is in place and day to day responsibility for the operation of the charity rests with the Principal Officer. Working closely with the Board, the Principal Officer is responsible for ensuring that the work of the charity is carried out in line with the strategic direction determined by the Board of Trustees.

Spencer Dayman Meningitis Research is a voluntary charity with no paid staff.

**1. Accounting Policies**

The following accounting policies have been used consistently in dealing with items which are considered material in relation to the charity's accounts.

**(a) Basis of Accounting**

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019) - (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Charities Act 2011.

The charity is a public benefit entity. The financial statements have been prepared on a going-concern basis. The trustees consider that the charity holds sufficient reserves to achieve an orderly closure in the unlikely event of a loss of funding.

The financial statements are presented in sterling which is the functional currency of the charity and rounded to the nearest £.

**(b) Going Concern**

There continues to be a need for the charity. With no paid staff, the only major expenditure commitment is research grant funding, and there are sufficient funds at the year end, held in a designated fund, to fully fund the current research commitments. In addition, the charity holds £43,138 in unrestricted reserves. The trustees are satisfied that the charity is a going concern.

**(c) Fund Accounting**

Unrestricted funds are general funds that are available for use at the trustees' discretion in furtherance of the objectives of the charity.

Restricted funds are those donated for use in a particular area or for specific purposes, the use of which is restricted to that area or purpose.

**(d) Income**

Income from donations, grants and contracts is recognised where there is entitlement, probability of receipt and the amount can be measured with sufficient reliability.

Investment income, trading income and other income are recognised on a receivable basis.

**(e) Expenditure**

Expenditure is recognised on an accruals basis. Expenditure includes any Value Added Tax which is reported as part of the expenditure to which it relates.

- Expenditure on generating funds comprises costs associated with attracting income.
- Expenditure on charitable activities comprises those costs incurred by the charity in the delivery of its research, peer support and awareness raising. It includes both costs that can be allocated directly to each of these and those costs of an indirect nature necessary to support them.
- Support costs are allocated between the expenditure categories of the Statement of Financial Activities on a basis designed to reflect the use of the resource.

**(f) Taxation**

The charity is exempt from tax on income and gains falling within section 505 of the Taxes Act 1988 or section 252 of the Taxation of Chargeable Gains Act 1992 to the extent that these are applied to its charitable objects.

**(g) Cash at bank**

Cash at bank is in a current account.

**(h) Creditors**

Creditors are recognised where the charity has an obligation that will result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably.

**(i) Debtors**

Debtors are recognised where there is an obligation that will result in the transfer of funds to the charity and the amount owing can be measured,
