Open to museums and members of the Hellenic and Roman Societies. Provided an opportunity for museums working with classical collections to promote their work and share their experiences. Evaluation responses were highly positive, with an overall rating of 4.8 out of 5. A write-up of the event is available here: https://classicalcollectionsnetwork.co.uk/2024/02/23/classical-collections-in-scotland/.</p> <p>October 2023: tour of the 'Return of the Gods' exhibition at World Museum Liverpool and workshop on small scale exhibitions and gallery interventions. Opportunity for museums with classical collections to learn from the curator of a major collection and exhibition, and to generate ideas to share their own collections for public benefit. In this period, trustee Ollie Croker drew together his own research on collections of Greek vases in UK museums with the CCN's existing listing of relevant museums, adding to the number of known collections. We began testing Peripleo, a free map visualisation software, as a possible new platform to improve on the Google map currently used on the CCN website.</p>
