Mission of God Conference 2024

We were pleased to host our second full day conference in central Birmingham at Macdonald Burlington Hotel. We had approx. 300 delegates and addressed the topic of understanding Islam and sharing the Christian faith with Muslim friends, equipping UK churches to deepen their understanding. Four speakers lectured on the day including two Christian apologists, a theologian and expert in Islamic culture and our CEO, Dr Joseph Boot. One of the speakers is teaching Fellow of Ezra (ECCT).

We were able to sell our books and provide both digital and print resources for the delegates. We are looking forward to hosting our third annual conference in the autumn of 2025 on the topic of Christianity and Politics.

Review of activities for 2023/2024

CEO's Report

Ministry Report: 2023/2024

During our first year of operation (March 2023-March 2024), Ezra Centre for Christian Thought (ECCT) has engaged widely and effectively in the work of advancing, explaining and articulating the teachings of the Christian faith in a variety of settings and through various media in the UK and Europe. This included planning and executing our first annual Mission of God conference, co-hosted with an aligned Christian organisation.

Mission of God Conference 2023:

We were pleased to host our first full day conference in Daventry at the Mercure Hotel. We had about 200 delegates and addressed the topic of the importance of developing a robust Christian world and life view in the UK churches and learning to articulate biblical Christianity to the wider culture. Four speakers lectured on the day including a Christian lawyer, a theologian, an economist and our CEO, Dr Joseph Boot. One of the speakers, Graeme Leach is a Fellow of the Ezra Centre.

We were able to sell our books and provide both digital and print resources for the delegates. We are looking forward to hosting our second conference in the autumn of 2024.

Keynotes for Other Conferences

The ECCT provided keynote speaking/lecturing for several multi-day major conferences in the UK and Europe during our first year. These included:

- Christian Concern pastors/leaders Conference in Daventry.
- Wesley Academy for Evangelists, in Wembley, London
- The Wilberforce Academy at Roehampton University in London
- The Countess of Huntingdon's Connexion churches network conference, London, Hoddesdon.
- Pro Rege Conference for Christian leaders in, Frankfurt, Germany

Educational Events and Debates

We were also able to provide lectures and addresses at various educational institutions and events during our first year. These included:

- Durham University Christian Union
- Two secondary schools in Aylesbury, including a live and radio broadcast debate on the resurrection of Christ with Premier Christian Radio and their "Reasons to Believe" show.
- A lecture for Christian Mission to Jews on the significance of Torah (conducted remotely)

Preaching at UK Churches

We were also able to preach at a number of churches during our first year of ministry as time and calendar allowed. These included special services at:

- Refresh Luton – a joint event for an Anglican network
- Freedom Church Bristol (Free Methodist)
- New Hope Christian Centre Norwich (Free Evangelical)
- The Filling Station network in both Harrogate and Sussex

Digital and Print Resources

As well as the in-person lecturing and speaking around the country we were able to do the following by way of providing digital and print resources:

- Produce a weekly Podcast for Cultural Reformation in partnership with Ezra Institute.
- Produce a monthly online article dealing with Christian apologetics
- Work on a new book to be published later this year
- Appear on over 25 guest podcasts and interviews around the world.

Trustees' Report

The charity was registered on 14 March 2023. Since its approval as a charity, the trustees have concentrated their efforts in putting in place procedures and practices that will enable the charity to achieve its objectives moving forwards.

Banking and finances

The trustees were not in a position to actively seek donations until the charity's banking arrangements were in place. After some initial difficulties, the trustees were able to secure banking facilities through Lloyds Bank and the account is now open.

Income and expenditure

With banking secured towards the end of the financial year, the charity received its first donations totalling £4095 and receipts for its activities of £691. These donations were received from within the UK and none were secured through professional fundraisers or grants from any third parties.

There was no expenditure in its first year's activity, so the bank balance stood at £4,786 at the end of the accounting period. No trustee received any income or expenses during this period.

None of the funds are restricted and, beyond the cash held, the charity had no assets or liabilities at the end of the accounting period.

Serious Incidents

The trustees are aware of no serious incidents arising in relation to the charity.

Appendix A

EZRA CENTRE FOR CHRISTIAN THOUGHT

Statement of Faith

The Ezra Centre for Christian Thought upholds the apostolic Christian faith, once for all delivered to the saints (Jude 1:3), as faithfully summarized in the foundational Ecumenical Creeds of the patristic church (Apostles', Nicene, Athanasian and the definition of Chalcedon), which we unequivocally believe represent the biblical, historic, orthodox and catholic faith.

The Ezra Centre for Christian Thought's teaching and writing is grounded in a reformational world-and-life-view, gratefully informed by the tradition contained in the evangelical Westminster Standards and the Three Forms of Unity (Belgic Confession, Heidelberg Catechism, and the Canons of Dort). We believe that Holy Scripture (as contained in the canonical Older and Newer Testaments) is the infallible Word of God, inerrant as originally given, constituting the final authority for the Christian's faith and life.

The Apostles' Creed (Circa 2nd Century AD)

I believe in God the Father Almighty; Maker of heaven and earth, and in Jesus Christ, His only begotten Son, our Lord. He was conceived by the Holy Ghost, and born of the virgin, Mary. He suffered under Pontius Pilate, was crucified, died, and was buried. He descended into Hades. On the third day He rose again, ascended into Heaven, and sits at the right hand of God the Father; from thence He will come to judge the living and the dead. I believe in the Holy Ghost, the holy catholic Church, the communion of saints, the forgiveness of sins, the resurrection of the body, and the life everlasting.

Nicene Creed Constantinople (AD 381)

I believe in one God, the Father Almighty, Maker of heaven and earth, and of all things visible and invisible; and in one Lord Jesus Christ, the only begotten Son of God, begotten of His Father before all worlds, God of God, Light of Light, very God of very God, begotten, not made, being of one substance with the Father; by whom all things were made; who, for us men and for our salvation, came down from Heaven, and was incarnate by the Holy Ghost of the virgin, Mary, and was made man; and was crucified also for us under Pontius Pilate; He suffered and was buried; and the third day He rose again, according to the Scriptures, and ascended into Heaven, and sits on the right hand of the Father; and He shall come again, with glory, to judge both the quick and the dead; whose kingdom shall have no end. And I believe in the Holy Ghost, the Lord, and Giver of Life, who proceeds from the Father and the Son; who with the Father and the Son together is worshiped and glorified; who spoke by the Prophets. And I believe in one holy, catholic and apostolic Church; acknowledge one baptism for the remission of sins; and I look for the resurrection of the dead, and the life of the world to come.

Definition of Chalcedon (AD 451)

Following, then, the holy fathers, we unite in teaching all men to confess the one and same Son, our Lord Jesus Christ. This selfsame one is perfect both in deity and in humanity; truly God and truly man, with a rational soul and a body; consubstantial with the Father according to His deity, and consubstantial with us according to the humanity; like us in all respects, sin only excepted. Before the ages He was begotten of the Father, according to the deity, and in these last days, for us and for our salvation, He was born of Mary the virgin, who is God-bearer according to His humanity; one and the same Christ, Son, Lord, only-begotten, to be acknowledged in two natures; without confusing them,

without interchanging them, without dividing them, and without separating them; the distinction of natures by no means taken away by the union, but the properties of each nature being preserved, and concurring in one Person and one subsistence; not parted or divided into two persons, but one and the same only-begotten Son, the Lord Jesus Christ, as from the beginning the prophets have declared concerning Him, and the Lord Jesus Christ Himself has taught us, and the symbol of the fathers has handed down to us.
