THE TRUSTEES SECURED INCOME OF £232,525 DURING THE YEAR. THE EXPENDITURE FOR THE YEAR WAS £56,189 OF WHICH £55,291 WERE GRANTS MADE TO BENEFIT THE NEEDY PERSONS AND SUPPORT ISLAMIC INSTITUTIONS. THIS GENERATED A SURPLUS OF £180,336 WHICH WAS ADDED TO PRIOR YEAR SURPLUSES. THE RESERVES OF £293,197 HAS BEEN KEPT FOR FUTURE CHAIRTABLE EXPENDITURE IN THE COMING YEARS.

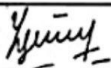

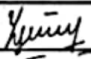
