1 Background

St Pancras church is situated in the rural village of Arlington, East Sussex. It is the benefice of Berwick and forms part of the Diocese of Chichester within the Church of England. The Parochial Church (PCC) is a body corporate established under sections 2 and 3 of the Parochial Church Councils (Powers) Measure 1956. On 21 March 2023 the PCC became registered by the Charity Commission as a registered charity number 1202417 under the name Arlington Parochial Church Council.

2 Our aims and purpose as a charity mission of the church

The primary objective of the PCC is the promotion of the Gospel of our Lord Jesus Christ according to the doctrines of and practices of the Church of England.

The PCC has the responsibility of co-operating with the Reverend Canon Peter Blee, in promoting in the ecclesiastical parish, the whole mission of the Church: pastoral, evangelistic, social and ecumenical.

The main objectives of the PCC are:

- To encourage worship, prayer and learning about the Gospel
- To develop links with the wider community
- To develop youth worship
- To maintain the church buildings and grounds

The councillors have complied with the duty in Section 17(5) of the Charities Act 2011 to have due regard to the guidance issued by the Charity Commission on Public Benefit in deciding what activities the PCC should undertake.

Members of the PCC are either ex-officio or elected by the Annual Parochial Church Meeting (APCM) in accordance with the Church Representation Rules. Casual vacancies are filled by election by the PCC.

4 Committees and Meetings

The full PCC met four times during the year, no standing committee meetings were held.

Christine Skinner continued as Parish Safeguarding Officer, her role is to ensure both national and diocesan policies and procedures are followed that protect children, young people and vulnerable adults. reporting to every PCC meeting on safeguarding matters including regulatory and training compliance. The parish is now using the Parish Dashboard system to record and monitor its activities. It is a mandatory online tool, funded by the diocese, to help parishes manage their safeguarding responsibilities. It stays fully aligned with the latest Church of England policies and procedures and is proving to be a great asset in ensuring Trustees are fully informed and supported with these responsibilities.

In this reporting year no safeguarding concerns or investigations have been recorded and all Trustees have achieved full compliance with both DBS and training requirements, where appropriate.

5 Church attendance and Electoral Roll

Due to the lack of heating, and in consideration of the more elderly members of the congregation, we held services on alternate Sundays in January and February.

The church celebrated every agricultural feast in the church calendar and in December we held a Christmas pageant, reminiscent of the Infant King held regularly more than 30 years ago. Community participation was very encouraging.

At the end of year there were 23 people named on the electoral roll, of whom 9 were resident in the parish. A new roll was completed in 2025.

The average service attendance throughout 2025 was 15. There was 1 funeral recorded in December 2025.

6 Review of the Year

The major fundraising of the year was the annual plant stall at the Arlington Bluebell Walk which raised just over £15,083

We welcomed walkers on the Cuckmere Pilgrim Path and our visitor book records many Pilgrims throughout the year.

The church community works closely with the Friends of St Pancras and acknowledges the tremendous support they give to fundraising with many additional events for the local village community. A tea party was held to acknowledge their work and the hours they give to protect and nurture the churchyard environment.

There was 1 funeral with a burial in the churchyard this year. There were no weddings and no baptisms.

Home Communion was given regularly to one member of the congregation, and quarterly to another. Care home and home visits continued throughout the year.

7 Financial Review - Unrestricted fund

Incoming and outgoing resources

The total receipts on the restricted fund were £24,943 (2024 £26,190) and are detailed in the Notes to the Financial Report. There was a small decrease in Planned Giving and Parish Giving Scheme. And an increase in other donations.

The plant sales and Bluebell Walk income are a major income stream. This year the income was £15,083 (2024 £14,516). Other fundraising income increased £1,649 (2024 £203), with a new income stream of Cook Book sales.

Interest received on funds at the CBF Church of England Deposit Fund was £71. This is lower than the previous year as the funds were used for the allocated purpose of the repairs to the roof and the spire in 2024.

Outgoing resources

Sharing the ministry costs of the Diocese of Chichester

The largest expenditure of the PCC was the sum of £12,422 paid to the diocese for our share of the Parish Ministry costs (2024 £12,422). This amount covers the housing, stipend and pension costs of the clergy and also a standard sum for diocesan central costs, clergy training and a contribution to national church funds. During 2025 the Parish contributed 82.5% of the costs the diocese asked us to cover (2024 £12,422). It is the diocese' intention that the Parish Share should rise to cover 100% of costs in the course of the next few years.

Staff costs

The PCC paid £88 for relief clergy during the year (2024 £65).

Trustee payments and expenses

The PCC supported the incumbent by paying costs in respect of the parsonage, administration expenses and motoring, totalling £350 (2024 £1,544). Also paying in respect of the vicarage, administration and motoring expenses reimbursed to the Assistant Priest during the period were £392 (2024 £2317). There were no payments to persons related to, or connected with, the other PCC members.

Repairs to the fabric of the church building

During the year inspection and remedial work was carried out on the church electrical system costing £3,100. Yearly inspections are carried out for PAT testing and to the condition of the fire extinguishers, costs totalling £411.

8 Financial Review - Restricted fund

Friends of St Pancras Arlington (FOSPA) received £10,650 income for the fabric fund, which included £9,121 in membership and donations. They also raised £1,107 from various events held during the year.

There was amount of £1,000 donated specifically for the churchyard maintenance.

FOSPA spent £21,063 during the year, including the balance for the repairs to the spire £2,534. There was also a sound system purchased and installed at a cost of £8,041. All services and events will benefit from using the sound system and it gives the church the opportunity for future fundraising and concert events.

Administration costs are for bank charges and the domain name.

9 Why we hold some money in reserve

It is PCC policy to maintain a balance on the general unrestricted funds which equates to approximately six months' worth of unrestricted payments as the PCC's income is seasonally affected, plus funding required for repairs to the fabric of the Church. The PCC is also mindful of the policy of the Diocese that the PCC's share of parish ministry costs will be rising continually by ~~25%~~ in the coming years.

10 Risk Assessment

The PCC confirms that the major risks to which the Council have been exposed have been identified and reviewed, and systems and procedures put into place to manage these risks. The health and safety of all who visit our Church is paramount. The PCC confirms it has had due regard to the House of Bishop's guidance on safeguarding of children and vulnerable adults as noted in section 5 of the Safeguarding and Clergy Discipline Measure 2016.

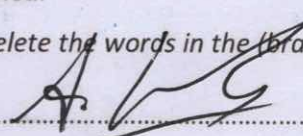

The largest expenditure of the PCC was the sum of £12,422 paid to the diocese for our share of the Parish Ministry Costs (202: £12,422). This amount covers the housing, stipend and pension costs of the clergy, and, also a standard sum for diocesan central costs, clergy training and a contribution to national church funds. During 2023 the Parish contributed 82.5% of the costs the diocese asked us to cover (2022 82.5%). It is the diocese' intention that the Parish Share should rise to cover 100% of costs in the course of the next few years.

Staff costs

The PCC paid £65 for relief clergy during the year (2023: £81).

Trustee payments and expenses

The PCC supported the incumbent by paying costs in respect of the parsonage, administration expenses, and motoring, totalling £1,544 (2023 £2,818). Paying costs in respect of the vicarage, administration and motoring expenses reimbursed to the Assistant Priest during the period were £2,317 (202: £368). There were no payments to persons related to, or connected with, the other PCC members.

Repairs to the fabric of the church building

Repair costs £853 comprised £129 on fire protection, repair to safe lock £120 and £144 on the treatment of mice.

8 Financial Review - Restricted fund

Friends of St Pancras Arlington (FOSPA) received £42,744 income for the Fabric Fund, which included £3,384 in memberships and donations. Grants received in respect of the fundraising for the Spire repairs £20,000. They also raised £2,145 from various events held during the year.

FOSPA spent £102,875 during the year, including £102,794 for spire repairs. Administration costs are for bank charges and the domain name.

The net inflow £5,581 (the amount of FOSPA net transactions without reference to the Spire repair appeal) was added to the fund. A further £2,534 will be paid for the balance of the spire repair in January 2025.

9 Why we hold some money in reserve

It is PCC policy to maintain a balance on the general unrestricted funds which equates to approximately six months' worth of unrestricted payments as the PCC's income is seasonally affected, plus funding required for repairs to the fabric of the Church. The PCC is also mindful of the policy of the Diocese that the PCC's share of parish ministry costs will be rising continually by 25% in the coming years.

10 Risk Assessment

The PCC confirms that the major risks to which the Council have been exposed have been identified and reviewed, and systems and procedures put into place too manage these risks. The health and safety of all who visit our Church is paramount. The PCC confirms it has had due regard to the House of Bishop's guidance on safeguarding of children and vulnerable adults as noted in section 5 of the Safeguarding and Clergy Discipline Measure 2016.

4 Committees and Meetings

The full PCC met four times during the year, no standing committee meetings were held.

Christine Skinner continued as Parish Safeguarding Officer reporting to every PCC meeting on safeguarding matters including regulatory and training compliance. Her role ensured that both national and diocesan policies and procedures are followed that protect children, young people and vulnerable adults. In this reporting year no safeguarding concerns or investigations have been recorded. All PCC members have achieved full compliance with safeguarding training procedures.

5 Church attendance and Electoral Roll

Church attendance remained much the same as the previous year. Due to the lack of heating, and in consideration of the more elderly members of the congregation, we held services on alternate Sundays in January and February.

At the end of year there were 30 people named on the electoral roll. A new roll will be prepared in 2025.

6 Review of the Year

The major fundraising of the year was the annual plant now been stall at the Arlington Bluebell Walk which raised a record amount of just over £10,000. In May we combined it with our Patronal Festival and dedicated the church as 'The Bluebell Church'. Members spent many hours crafting paper bluebells which decorated the church alongside a detailed history of St Pancras for visitors to enjoy.

We welcomed walkers on the Cuckmere Pilgrim Path who were supporting Family Support Work. Our visitor book records many other Pilgrims visiting throughout the year.

After many months of waiting to hear, the PCC was advised that the church has now been accepted on Historic England At Risk Register. Whilst this was not a positive matter it does recognise the condition of the building and acknowledges the issues the church council faces and lack of funds to restore it.

In June, St Pancras was honoured to host a service of celebration for Rev Frank Fox-Wilson, marking 50 years in ministry. This service was well attended.

The church community works closely with the Friends of St Pancras and acknowledges the tremendous support they give to fundraising with many additional events for the local village community. A tea party was held to acknowledge their work and the hours they give to protect and nurture the churchyard environment.

There were two funerals with burials in the churchyard this year, and one service for the burial of ashes. There were no weddings.

There was one baptism, notably a child with 4 generations of worship at this church, which was wonderful. Home Communion was given regularly to one member of the congregation, and quarterly to another. Care home and home visits continued throughout the year.

7 Financial Review - Unrestricted fund

Incoming resources

The total receipts on the unrestricted fund were £26,190 and are detailed in Notes to the Financial Report (2023 £23,932). Donations totalled £7,596 (2023 £9,149). Plant sales and Bluebell Walk income were £14,516. Interest on Funds at the CBF Church of England Deposit Fund was £1,568.

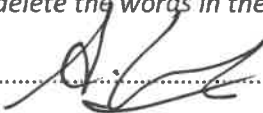

Trustees Annual Report for 2023

1 Background

St Pancras church is situated in the rural village of Arlington, East Sussex. It is in the benefice of Berwick and forms part of the Diocese of Chichester within the Church of England. The Parochial Church Council (PCC) is a body corporate established under sections 2 and 3 of the Parochial Church Councils (Powers) Measure 1956. On 21 March 2023 the PCC became registered by the Charity Commission as a registered charity number 1202417 under the name Arlington Parochial Church Council.

2 Our aims and purposes as a charity

The primary objective of the Parochial Church Council of St Pancras, Arlington is the promotion of the Gospel of our Lord Jesus Christ according to the doctrines and practices of the Church of England.

The PCC has the responsibility of co-operating with the Reverend Peter Blee, in promoting in the ecclesiastical parish, the whole mission of the Church: pastoral, evangelistic, social and ecumenical.

The main objectives of the PCC are:

- To encourage worship, prayer and learning about the Gospel
- To develop links with the wider community
- To develop youth worship
- To maintain the church buildings and grounds

The councillors have complied with the duty in section 17(5) of the Charities Act 2011 to have due regard to the guidance issued by the Charity Commission on Public Benefit in deciding what activities the PCC should undertake.

Members of the PCC are either ex-officio or elected by the Annual Parochial Church Meeting (APCM) in accordance with the Church Representation Rules. Casual vacancies arising are filled by election by the PCC

Membership of the PCC is determined under the Church Representation Rules and consists of the incumbent, ex-officio, the churchwarden and 6 members of the church who are elected at the Annual Parochial Church Meeting (APCM). Members are warmly encouraged to stand for election to the PCC and we try to ensure a balance of skills and experience where possible. New councillors receive training from the existing councillors. There is no formal training programme.

4 Committees and Meetings

The full PCC met four times during the year. The Standing Committee did not meet during the year.

5 Church Attendance

There are 30 parishioners on the Church Electoral Roll, of whom 16 are not resident within the parish. The average Sunday attendance was 15.

6 Review of the Year

During springtime many of the congregation were involved in the Bluebell Walk plant stall, and assisting during the village weekend in the café, kitchen, and with the mobility scooters. These duties are essential to our fundraising, and we remain grateful, as ever, to John McCutchan, and to everyone who helps out.

There was one wedding and one funeral service during the year.

Other activities included the blessing of the annual village tractor run, a garden party in aid of Networx, a memorial service in November for Jessie Levett (held in the village hall), and a pop-up museum about St Pancras at the village market, (thanks to Irene and Wendy) and a table at the Christmas Market in December.

Two members of the congregation received Holy Communion outside of Sunday services, one monthly at home, and one quarterly at the care home in which she resides.

We continue without a churchwarden; these duties are shared between the PCC members, and I am grateful to you all for your commitment and care. I am delighted that Mary Ann Harding has become our new treasurer and am grateful to her for her careful management of the finances.

The year ended on a high note, with the required funding for building work almost reached. FOSPA is a fantastic partner; we owe them, collectively and as individuals, a debt of gratitude, with special mention to Irene Flynn for persevering with grant applications.

7 Financial Review - Unrestricted fund

Incoming resources

The total receipts on the unrestricted fund were £23,932 and are detailed in Note 2 the Financial Report (2022 £24,973). Donations totalled £9,149 (2022 £10,303). Plant sales and Bluebell Walk income were £14,107, sales of the new book In Love & Faith - Arlington Church & Churchyard were £60. Interest on Funds at the CBF Church of England Deposit Fund was £264.

Outgoing resources

Sharing the ministry costs of the Diocese of Chichester

The largest expenditure of the PCC was the sum of £12,422 paid to the diocese for our share of the Parish Ministry Costs (2022: £12,422). This amount covers the housing, stipend and pension costs of the clergy, and, also a standard sum for diocesan central costs, clergy training and a contribution to national church funds. During 2023 the Parish contributed 82.5% of the costs the diocese asked us to cover (2022 82.5%). It is the diocese' intention that the Parish Share should rise to cover 100% of costs in the course of the next few years.

Staff costs

The PCC paid £81 for relief clergy during the year (2022: £60).

Trustee payments and expenses

The PCC supported the incumbent by paying costs in respect of the parsonage, administration expenses, and motoring, totalling £2,818 (2022 £3,637). Administration and motoring expenses reimbursed to the Assistant Priest during the period were £368 (2022: £329). A payment of £171 was made to one PCC member during the year for an expense incurred for the PCC. There were no payments to persons related to, or connected with, the other PCC members.

Repairs to the fabric of the church building

Repair costs £580 comprised £216 Jackdaw nest removal in Spire £171 Lock opening on oak cabinet £121 on fire protection and £72 on portable appliance testing.

7 Financial Review - Restricted fund

Friends of St Pancras Arlington (FOSPA) received £17,769 income for the Fabric Fund, which included £1100 in memberships and donations, a very generous £10,000 legacy, a £3,600 grant from the Benefact. They also raised £3,069 from various events held during the year.

FOSPA spent £14,101 during the year, including £3,830 on a Bat Survey for spire repairs, £10,000 National Lottery Community Fund refund.

The net inflow £4,542 was added to the fund balance brought forward £39,853 to leave the balance carried forward at £44,395.

8 Why we hold some money in reserve

It is PCC policy to maintain a balance on the general unrestricted funds which equates to approximately six months' worth of unrestricted payments, as the PCC's income is seasonally affected, plus funding required for repairs to the fabric of the church. The PCC is also mindful of the policy of the Diocese that the PCC's share of Parish ministry costs will be rising by getting on for 25% in the course of the next few years.

The PCC decided to designate £36,000 of their unrestricted reserves towards funding the roof repair project. Following the transfer of £36,000 to the Designated Fund, the balance on the Unrestricted Fund carried forward is £10,069.

The restricted cash fund is the Fabric Fund managed by FOSPA £44,395. Substantial further funds will need to be raised if the proposals FOSPA are developing for the church are to be brought to fruition.

Respective responsibilities of trustees and examiner

Two members of the congregation received Holy Communion outside of Sunday services, one monthly at home, and one quarterly at the care home in which she resides.

We continue without a churchwarden; these duties are shared between the PCC members, and I am grateful to you all for your commitment and care.

I am delighted that Mary Ann Harding has become our new treasurer and am grateful to her for her careful management of the finances.

The year ended on a high note, with the required funding for building work almost reached. FoSPA is a fantastic partner; we owe them, collectively and as individuals, a debt of gratitude, with special mention to Irene Flynn for persevering with grant applications.

Deanery Synod report for APCM, April 2024.

The meeting in June held in Firle church was one of the more interesting synods.

We heard from Anna Glenton, who is a prison Chaplain at Lewes prison. She spoke passionately about her role and the role that churches could play in welcoming ex-prisoners to worship in their churches. It was a well-informed interesting talk .

Also, we heard from Andrew Jackson who is Chaplain at the University of Sussex, and from Derreck lee-Philpott who as well as being an associate vicar at Seaford is Chaplain to the East Sussex Fire Services, where he was a senior fire service officer before ordination. Both spoke eloquently about their work and the needs of the people that they worked with.

The September Synod held in Seaford was geared towards the finances of the Diocese and Archdeacon Martin spoke on the financial state of the parish share, and of the struggles some had to pay their way due to the cost of living and the recovery from the pandemic. The future seemed uncertain as to whether they could sustain the same levels of parish ministry.

Donald Irvine thanked the treasures and the congregations for their hard work and generosity, urging them to prioritise the Parish share in their Budgets.

Gabrielle Higgins said that the parish share was to go up by 3.4% and the clergy income was to be increased by 5%.

The October Synod was held at Trinity ,Southover, and concentrated on education stating that 1in 4 schools in England were C of E schools. There were 154 C of E schools in this Diocese with 38K children with parents and carers creating a huge mission field. There is a 5-page booklet “growing Partnerships, schools and parish churches“, which offers resources on how the churches can support their local school.

The first Synod of 2024 was held in February at St Leonards Denton. Unfortunately, due to road closures we couldn't attend but joined by Zoom.

The deanery treasurer stated that the PMC for 2024 was £1,281,432. Offers received from treasurers so far amounted to £941,407 with one parish outstanding. There was an important note about the fact that if you weren't a registered charity you must register on the Trust Registration Scheme or accounts may be blocked or fined up to £5000.

Michael Millar spoke on reader training with 6 readers starting so far, but Diocesan financial restraints have resulted in a pause on reader training for the next 2 years. It costs less than £4k to train a reader. This was deemed a helpful saving. The Synod did not agree, and Michael Miller was asked to take the sadness of the synod to the bishop.
