But also, as we grow in financial stability and financial visibility with a 12 months rolling forecast, we believe that the 3 months gross cost can be revised during the next financial year.
Amount of reserves held	Para 1.22	The total reserves at the end of the financial year 24/25 stood at £23,467. This is significantly higher than expected. From an income stand point, the golf and dinner events raised almost £4,000 higher than expected. Cost was lower than planned due to a higher than normal rate of attrition and referral from new sources taking longer than usual. Sources of referrals are now being addressed.




