Report of the Trustees for the Year Ended 31 July 2025

The trustees present their report with the financial statements of the charity for the year ended 31 July 2025. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

The objectives of the Society as set out in its Constitution are to promote and maintain a mixed voice choir and to further the art and science of music by the presentation of concerts and by such other related and ancillary activities as shall from time to time be organised with the approval of the Society.

Significant activities

The Society's main activity is the performance and promotion of public concerts of choral music. During the year under review the Society enjoyed performing at three public concerts.

Public benefit

The Trustees confirm that they have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the aims and objectives of the Society in planning future activities and in setting the objectives of the Society.

The Trustees believe that the Society fulfils these objectives through its presentation of concerts and such other activities organised by or with the approval of the Society.

FINANCIAL REVIEW

Financial position

The result for the year was a deficit of £20,114.

The Trustees have started formulating plans for the Special Projects Reserve and at the AGM in October 2024 the members approved the broad objective of using some of this reserve to support encouraging the appreciation of, and participation in, choral music by children and young people.

Reserves policy

The Trustees consider that the Society should maintain a level of reserves sufficient for the Society to continue to fulfil its objectives in the short to medium term should there be significant reduction in income.

The balance on the General Fund as at 31st July 2025 represented approximately 7 months of normal expenditure which the Trustees consider to be appropriate in the circumstances.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

Basingstoke Choral Society ("the Society") was established in 1948 and registered as a charity. On 1st August 2023 the Society transferred its activities to a Charitable Incorporated Organisation number 1202484 which was registered on 24th March 2023.

Recruitment and appointment of new trustees

Members of the committee are elected for a term of three years at the Annual General Meeting or are co-opted to fill vacancies. It is anticipated that they should have the skills necessary to manage the affairs of the Society.

Decision making

The Trustees are aware of the Charity Governance Code and take into account how relevant matters therein should be applied and implemented by the Society.

Risk management

The Trustees continued to review all of the Society's risks on a regular basis. They are satisfied that adequate insurances have been in place and that adequate steps are constantly taken to ensure that exposure to risk of any sort is kept to a minimum.



1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Stocks

Taxation

The charity is exempt from tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

The Richard Tanner Memorial Fund arose from a legacy in 2020 from a former member of the Society. Although no restrictions were placed on this legacy, the trustees decided that this should be used to fund bursaries and workshops. Part of the bequest may also be used to finance a concert in memory of the donor.

Bursaries for 2024/5 and 2023/4 were awarded to 3 members of the Society from the fund.

A legacy was received in 2022 of £126,627. Although no restrictions were placed on this legacy by the testator, the trustees decided that, given the size of the legacy, this would be designated for use in future special projects of the Society. This amount has therefore been transferred to a designated fund called The Special Projects Reserve. During the year under review the Trustees agreed to use the fund to finance young Soloists performing at the Spring and Summer concerts.







1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Stocks

Stocks are valued at the lower of cost and net realisable value, after making due allowance for obsolete and slow moving items.

Taxation

The charity is exempt from tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Although no restrictions were placed on this legacy, the trustees decided that this should be used to fund bursaries and workshops. Part of the bequest may also be used to finance a concert in memory of the donor.

Bursaries for 2022/3 and 2023/4 were awarded to 3 members of the Society from the fund.

A legacy was received in 2022 of £126,627. Although no restrictions were placed on this legacy by the testator, the trustees decided that, given the size of the legacy, this would be designated for use in future special projects of the Society. This amount has therefore been transferred to a designated fund called The Special Projects Reserve.
