### Report of the Trustees for the Year Ended 30 September 2024

#### **Introduction**

The form and layout of this annual report follows the Statement of Recommended Practice “Accounting and Reporting by Charities” (revised 2005).

#### **Board of Trustees**

The trustees are also the directors of the company. The number of trustees shall not be less than four or more than eleven. The trustees comprise individuals nominated by members of the Scarborough & District Cricket Development Group (the “Nominated Trustees”), together with up to seven individuals co-opted by the trustees (the “Co-opted Trustees”). Generally, trustees are appointed for a three-year term and are eligible for subsequent three year terms if they are authorised by the trustees.

#### **Investments**

The constitution authorises the trustees to make and hold investments using the general funds of the charity. There are currently no investments other than the bank account.

#### **Constitution, objects, and organisation**

The charity is a company without share capital, governed by its memorandum and articles of association. The liability of members in the event of winding up is limited by guarantee to an amount not exceeding £1 per member. The company is a registered charity (registered number 1202510).

The primary objective of the charity is to promote and develop cricket skills/participation in boroughs of deprivation in the Scarborough & Ryedale area and surrounding areas by initially upskilling/training coaches in order to provide cricket coaching and equipment to encourage participation in cricket.

The charity aims to provide excellent cricket coaching for children in the local area. The charity also seeks to increase the number of junior volunteer coaches and cricketers by encouraging them to take up cricket and to use local cricket club facilities and qualified coaches associated with the charity.

The board of trustees is responsible for the governance and day to day running operation of the charity. There are no employees. The trustees consider there is no need for a formal induction and training programme for the new trustees due to the size of the charity.

#### **Developments, activities and achievements**

The charity has helped several young adults to access National Governing Body Qualifications – ECB Level 1 and 2 Certification in Cricket Coaching. These young coaches have since started coaching for S&DCDG in local schools and/or clubs.

The charity has also increased the number of junior participants in cricket by providing coaching courses during the winter months.

The charity fulfilled this aim by raising grants and donations to cover the cost of sending coaches on courses and providing sports hall hire for coaching.

During the year ended 30 September 2024 the charity’s objective was to ensure that this coaching happened and leaves a legacy in the local area.

The charity’s strategy for achieving this objective is to keep local schools and clubs aware of the coaching available to their children so that the legacy continues in the future.

The activities undertaken in the year met the objectives set, with five coaches receiving ECB Qualifications and coaches coaching cricket in 25 schools (coaching over 4,000 children of primary and secondary age).

The funding sources are grants received and donations received. This income is used to pay for Junior Cricket in the Scarborough & Ryedale District.

The principal risks to the charity relate to the reduced participation in the game of cricket within our area.

The charity's position at the year-end is that cricket is thriving in the local area with a large percentage of children having access to coaching and game play throughout the year. The trustees are happy with the position of the charity at the year-end.

**Plans for future periods**

The charity's future plans are to continue to upskill local coaches that can then continue to coach the cricketers of the future. It is also an aim to further links with local schools and clubs, providing cricket coaching for all that are interested. The charity plans to increase the number of qualified coaches that can be used to help with the junior coaching.

**Volunteers and donated services**

All the trustees receive no remuneration or pay from the work undertaken to run the charity. Other donated services including sports hall hire have not been quantified or included in the accounts. Statement of Recommended Practice "Accounting and Reporting by Charities" only requires donated services to be included in the Statement of Financial Activities where the benefit of the charity is reasonably quantifiable and measurable.

**Statement of reserves policy**

A reserves policy has been determined for the Association and the reserve has been quantified as having funds available in the bank account to cover at least six month's expenditure. This reserve has been quantified at £18,000.

**Risk strategy**

The trustees have examined the major strategic, business and operational risks which the charity faces and confirm that systems have been established to enable regular reports to be produced so that necessary steps can be taken to lessen those risks.

**Public Benefit**

The charity's aims for public benefit are that it will provide excellent facilities for the advancement of amateur sport/cricket. The charity will make available coaching for cricketers of all junior ages, and will not restrict the coaching because of, gender, sexual orientation, race, creed, colour or ability. The charity aims to keep its costs of coaching as low as possible, so that it is then accessible to as many children/families as possible.

### Notes to the Financial Statements for the Year Ended 30 September 2024

#### 1. ACCOUNTING POLICIES

##### **Accounting convention**

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective January 2005). They comply with the charity's constitution, current statutory requirements and the Statement of Recommended Practice "Accounting and Reporting by Charities" (revised 2005). The financial statements adopt the following principal accounting policies.

##### **Incoming resources**

All incoming resources are included in the statement of financial activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy. Income of a revenue nature is deferred where it is received in advance to be expended in the following period or it relates to a fundraising event held in the following period. Capital grants are included in the statement of financial activities at the point of receipt or when the charity is legally entitled to the grant. As required by the Statement of Recommended Practice "Accounting and Reporting by Charities" (revised 2005), capital grants are not deferred over the lives of the asset they fund.

##### **Resources expended**

All expenditure is accounted for on an accruals basis. Expenditure included under charitable activities comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both cost that can be allocated directly to such activities and those costs of an indirect nature necessary to support them. Governance costs include those costs associated with meeting the constitutional and statutory requirement of the charity.

##### **Donated services**

Donated services have not been quantified or included in the financial statements. These relate to free work done on a volunteer basis. Statement of Recommended Practice "Accounting and Reporting by Charities" only requires donated services to be included in the statement of financial activities where the benefit to the charity is reasonably quantifiable and measurable.

#### 2. FUND ACCOUNTING

Unrestricted income funds are available for use at the discretion of the trustees in furtherance of the general objectives of the charity. Restricted income funds are funds to be used in accordance with specific restrictions imposed by donors or funds which have been raised for a particular purpose. The restricted fund shown in these financial statements must be used to pay expenses incurred in the schools' cricket income and related work from this work.

#### 3. RELATED PARTY TRANSACTIONS

An opening donation was given to the charity from the Scarborough and District Cricket Development Group amounting to £30,902.

### Notes to the Financial Statements for the Year Ended 30 September 2023

#### 1. ACCOUNTING POLICIES

##### **Accounting convention**

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective January 2005). They comply with the charity's constitution, current statutory requirements and the Statement of Recommended Practice "Accounting and Reporting by Charities" (revised 2005). The financial statements adopt the following principal accounting policies.

##### **Incoming resources**

All incoming resources are included in the statement of financial activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy. Income of a revenue nature is deferred where it is received in advance to be expended in the following period or it relates to a fundraising event held in the following period. Capital grants are included in the statement of financial activities at the point of receipt or when the charity is legally entitled to the grant. As required by the Statement of Recommended Practice "Accounting and Reporting by Charities" (revised 2005), capital grants are not deferred over the lives of the asset they fund.

##### **Resources expended**

All expenditure is accounted for on an accruals basis. Expenditure included under charitable activities comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both cost that can be allocated directly to such activities and those costs of an indirect nature necessary to support them. Governance costs include those costs associated with meeting the constitutional and statutory requirement of the charity.

##### **Donated services**

Donated services have not been quantified or included in the financial statements. These relate to free work done on a volunteer basis. Statement of Recommended Practice "Accounting and Reporting by Charities" only requires donated services to be included in the statement of financial activities where the benefit to the charity is reasonably quantifiable and measurable.

#### 2. FUND ACCOUNTING

Unrestricted income funds are available for use at the discretion of the trustees in furtherance of the general objectives of the charity. Restricted income funds are funds to be used in accordance with specific restrictions imposed by donors or funds which have been raised for a particular purpose. The restricted fund shown in these financial statements must be used to pay expenses incurred in the schools cricket income and related work from this work.

#### 3. RELATED PARTY TRANSACTIONS

An opening donation was given to the charity from the Scarborough and District Cricket Development Group amounting to £30,902.
