Summary of the purposes of the charity as set out in its governing document	Para 1.17	Our charity's purpose as set out in the objects contained within the governing documents (CIO Foundation document) are: • The prevention or relief of food poverty in Market Harborough and the surrounding area by providing food parcels and other access to food to individuals and families in need.
Summary of the main activities in relation to those purposes for the public benefit, in particular, the activities, projects or services identified in the accounts.	Para 1.17 and 1.19	Donations of food and money are made by individuals and organisations such as schools, churches and businesses. At least 3 days of non-perishable food is given to households and individuals referred by reputable organisations such as Citizen's Advice and local churches. Vouchers are given for the fruit and vegetable and meat stall at the indoor market. Hot meal vouchers are also available for people who are homeless (on the street or in temporary accommodation). Food is sorted and then delivered to referral agencies and collection points. The

		foodbank supports people in challenging circumstances such as: homelessness, low income, change in family circumstances or work, benefit delays and difficulty accessing food. An eligibility criteria is used to support referrers in their assessment of need. The trustees meet monthly to ensure that funds and donations in kind are used appropriately and for the public benefit. The trustees review the way the food bank is organised to meet the charitable objects. 2023 was our 2nd highest year of referrals ever, only outdone by the 2020 pandemic year. We used donations and financial reserves, as well as volunteers' time and energy to ensure we were able to meet the demand.

Contribution made by volunteers	Para 1.38	Jubilee Foodbank Market Harborough has a large number of volunteers who contribute time, effort and enthusiasm to support people in need of help due to food poverty. Volunteer roles include: store team, frontline volunteers who receive calls from referral agencies and create and deliver food parcels; collection team, shoppers, administration, social media team and trustees. Jubilee Foodbank Market Harborough has no employees.

Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.	Para 1.20	Jubilee Foodbank Market Harborough seeks to reach as many people as possible in Market Harborough and the surrounding area if they are in food poverty. Our main achievement is providing food for every referral given by reputable organisations in the Market Harborough area. Behind every referral is a family or individual in need of food. Apart from the circumstances already mentioned, Jubilee Foodbank Market Harborough also

		provided food for refugees, a person who was in modern slavery, people who suffered domestic abuse and a family who lost their home to fire. Jubilee Foodbank Market Harborough works with many organisations that support families and individuals. By providing food through these referral agencies, it helps to develop relationships and give opportunities for more support by the appropriate organisation. For example, one of the referrers is Turning Point and another Home-Start. It is hoped that by referring to us a closer link is made between the referral agency and their clients, helping to support the organisation's work. Jubilee Foodbank is conscious of the need for people in food poverty to find ways to improve their situations. Therefore, we signpost wherever we have contact with people needing food support and include information about local and national organisations that can support in food parcels. Social media and the website are also used to guide people towards relevant support.

Financial Review

Review of the charity's financial position at the end of the period	Para 1.21	Jubilee Foodbank Market Harborough is in a strong financial position, total income for the year ending 31 December 2023 was £276,922 generated from grants and donations. This includes both monetary donations and estimated values for the donation of goods. The total resources expended were £257,191 and represented costs incurred to enable the food bank to carry out its operations, as well as food parcels given out in kind to those in need. Jubilee Foodbank Market Harborough made a surplus for the year of £19,730, due to the continued financial support from individuals and businesses within local community.
Statement explaining the policy for holding reserves stating why they are held	Para 1.22	The Trustees consider it appropriate to hold unrestricted cash reserves equivalent to 12 - 18 months of operating expenditure (excluding donated goods) to provide a level of working capital that protects the continuity of the work of the Jubilee Foodbank Market Harborough. The level of reserves will take into consideration future strategy and the potential for unforeseen expenditure or unanticipated loss of income. This is reviewed annually in conjunction with the budget setting process.
Amount of reserves held	Para 1.22	As of 31 December 2023, Jubilee Foodbank Market Harborough had total unrestricted reserves of £101,950 of which £101,379 were held in cash. This represents approximately 36 months of operating expenditure, which is higher than the top end of the range specified in the reserves policy. The Trustees have taken account of this during the budget setting process for the next financial year (ending 31 December 2024) and have considered how the additional funds can be used to further the objective of the food bank without committing to levels of expenditure which cannot be maintained in the long-term.
