The appointment of trustees is managed as required by the management board who identify candidates who have an interest in supporting the CIO and have the skills to complement the existing board members, or can fill any skills gaps on the board.

Objectives and Activities

Purpose

The charitable objectives of the CIO are the promotion of community participation in healthy recreation, for the benefit of all inhabitants of Cullercoats and the surrounding areas, by the provision of facilities for playing association football.

In setting objectives and planning for activities, the trustees have given due consideration to the guidance published by the Charity Commission, 'Public Benefit: running a charity (PB2)'.

Main Achievements of the CIO

2024/2025 was another successful season for the Club, both on and off the pitch.

On the pitch we saw two of our teams, Inter and Ajax, win 'Outstanding Team of The Season' awards in their respective divisions. Following a restructure of the Mens Senior Team, we saw a number of young players successfully integrated into a newly structured Mens team.

The Club was also nominated for a '100% positive' award at the annual Northumberland FA awards night. This reflects the environment created at the Club by all of its volunteers.

Off the pitch, we saw the departure of four trustees, who we give special thanks to their efforts they have given to the Club over the years. We were successful in recruiting a new Treasurer in Gaynor Carle, alongside an Assistant volunteer which has given the Club the capacity required to allow us to monitor the organisations financial health as it continues to grow.

Financially the Club remains comfortable in our financial position. We recorded slightly over a £10K deficit for 2024/2025. However a large proportion of this was the timing of grant funding relating to pitch development work. We saw our 2024 funding arrive early, in 23/24, and our 2025 funding arrive late, in 25/26.

We have continued progress on the development of the Links Avenue site, successfully securing a long-term lease for the site from North Tyneside Council in early May 2025.

Financial Review

Financial Position

The CIO received £100,721 in receipts and made £107,414 in payments in the year, with a deficit of £6,693.


Reserves Policy

The trustees have examined the CIO's requirement to hold reserves in order to continue to operate under unforeseen circumstances. The trustees review the CIO's level of reserves frequently throughout the financial year.

At the end of the financial period, unrestricted reserves were £57,670.



In setting objectives and planning for activities, the trustees have given due consideration to the guidance published by the Charity Commission, 'Public Benefit: running a charity (PB2)'.

Main Achievements of the CIO

In April 2023, the Club established itself as a Charitable Incorporated Organisation. This is a major step forward in the Club's long term development ambitions to obtain a lease on the land at Links Avenue, the key item in being able to redevelop the facilities on the site, with the support of the Football Foundation.

September 2023 saw the Club win the Safeguarding Club of the Year award at Northumberland FA's Grassroots Football awards. This is a major achievement and demonstrates our ongoing effort and commitment to providing a safe environment for all our members to enjoy football.

The success of the Club's mini-soccer development continued and hit new highs, successfully forming two teams at Under 7 which were fully recruited from our 4-6 year old FUNDAYS development sessions. This success was further enhanced by the Club's first ever Female Under 7 team, led by the Club's first all-female coaching team.

This year was the Club's first year operating as a Charitable Incorporated Organisation. We've made great progress in developing the operations of the Club and building resilient processes, especially regarding financial management. The financial year of 23/24 was the first year in which the Club had prepared a budget for the season ahead, and reviewed its performance against the budget at the end of the year.

Financial Review

Financial Position

The CIO received £119,530 in receipts and made £100,377 in payments in the year, with a surplus of £19,153.


Reserves Policy

The trustees have examined the CIO's requirement to hold reserves in order to continue to operate under unforeseen circumstances. The trustees review the CIO's level of reserves frequently throughout the financial year.

At the end of the financial period, unrestricted reserves were £64,362.


