The use machine tools in the Workshop are only open for members with a proven competence to use such equipment.</p> <p>Members Meeting are held monthly were all activities and plans are discussed with the members attending. A record of the meetings is circulated to the wider membership. In addition YMS runs a Website to communicate with the public, plus a member's only page for club information.</p>

To provide a meeting place where members are able to safely work on woodworking projects, for them, the Shed or the Community.
To minimise loneliness and social isolation of members, particularly elderly men, by joint projects and social interaction.

Yateley Men's Shed uses its facilities and equipment for members to come together in a social environment and enhance their woodworking skills and abilities by:-

- Making or repairing items for their own use.
- Repairing items for the General Public
- Undertaking projects for the Local Authority, Schools, and Other Charities etc.
- Making items for sale at local shows and craft markets.
- Refurbishing old tools so they can be put back into use rather than go to landfill.
- Assisting youth groups such as Scouts to develop their skills through training and support.
- Recycling old timber products into usable items, avoiding the wood being sent to scrap.

- Refurbished an ex-building site office into a new Social Area by adding a kitchen, toilets, Wi-Fi, security cameras and large screen monitor. This was formally opened by the Yateley Town Mayor.
- Organised Quiz Nights and Social Events for members.
- Repaired play equipment for a local nursery.
- Assisted the Royal British Legion in making a Poppy Wall for the Remembrance Ceremony.
- Refurbished 15 Picnic Tables and distributed them to local sports groups.
- Designed and constructed Carnival Games to enable a local school and children's charity to raise funds.

Independent examiner's report to the trustees of Yateley Men's Shed

I report to the trustees on my examination of the accounts of Yateley Men's Shed for the year ended 5 April 2025.
