The annual report covers 01 April 2024 to 31 March 2025 and acknowledges SORP 2019 relevant to this accounting period in using its guidance to assist GAND AID UK (registered 12 April 2023) and FRS102 for accounting purposes in compiling the report and meeting its obligations as a registered Charity Incorporated Organisation (CIO) in adopting the 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their financial statements in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (effective 1 January 2019).' It is also noted that future accounting periods will respond to the updated SORP 2026 with regard to reporting updates.

Chair's Report
Gene Shaun Selby

The report recognises that GAND AID UK is set up for the purposes of its primary users, stakeholders and the stewardship and management of funds during and within its fundraising activities. The Charity, within its second year of reporting, has engaged with donors, funders and financial supporters that continue to help raise funds within the early start-up of the charity.

I am satisfied that GAND AID UK has effectively targeted appropriate audiences through the creation of a formal website and associated social media platforms, established a UK database of those affected by the neurodevelopmental condition, and through fundraising activities, providing direct access to GAND AID UK officials both online and-or in person.

I am, therefore, satisfied that GAND AID UK is continuing to build the foundation to meet its charitable obligations and continues to remain financially viable beyond its initial start-up.

The report is compiled by the Charity's Trustees and use of a Company for financial accounting purposes, although the second-year's financial income amount falls short of formal auditing requirements.

Objectives and Activities

The objectives of the Charity remain unchanged and for:

The relief of sickness and the preservation and protection of health for the Public Benefit of people affected by or suffering from GATAD2B-ASSOCIATED NEURODEVELOPMENTAL DISORDER (GAND) and in particular but without limitation by a) providing advice, education and support for such persons and their families including the provision of service dogs b) raising awareness about GAND and providing information and advice to members of the medical profession and c) funding research into GAND and early identification and possible treatment.

In response, the Charity has created a formal website (gandaiduk.org) with associated social media access, 'get involved' contact information and useful resource links in both providing information and raising awareness.

The Charity organised a number of fundraising events in generating further awareness and continues to subscribe to the Global 'Rare Disease' Day campaign using both the UK and European platforms.

The Charity has established a UK database of affected families with some consenting to the use of their data for medical research purposes. The database also provides the opportunity to communicate directly with those affected by the condition and the Charity is increasing its networks to reach those organisations and professions that are able to contribute to its charitable aims and objectives.

Public Benefit Statement

The Trustees meet on a scheduled basis to plan, review and implement the Charity's strategy with the Trustees paying due regard to the guidance on its obligations to deliver activities for the Public Benefit, as those described and issued by the Charity Commission.

The Charity is confident that it has initiated the types of activities that provides a Public Benefit through its actions, and continues to build momentum in which it is able to reach its intended target groups and particularly families.

Achievement and Performance

The Charity has established a close working relationship with US-based Dr Tyler Pierson (Medical Doctor and Primary Investigator of GATAD2B) and has referred a number of UK families to Dr Pierson's research programme. Dr Pierson has committed to attend GAND AID UK inaugural GAND Conference in April 2025 and agreed to one-to-one consultation with all attending UK families.

Website

The Charity continues to add and update its website providing links to activities and events. The website is continually updated with the latest news and features.

The website includes the most recent research update i.e. "Gatad2b, associated with the neurodevelopmental syndrome GAND, and provides open access to article(s) distributed under the terms of the Creative Commons CC BY license.

The Charity continues to use Instagram to promote its activities and subscribes to both the UK and European 'Rare Disease' day platforms and continues to access EURODIS, which offers seminars and webcasts for training purposes.

Financial review

The results for the year ending are shown in the Statement of Financial Activities on page 10 and considered satisfactory by the Trustees

This is the Charity's second year in fundraising activities and it is aligning and accumulating funds in line with charity objectives.

Reserves Policy

At the year end the charity's funds were in credit by £25,511.47 consisting entirely of unrestricted funds generated through donations.

The amortisation of goodwill (£5,000) with regard to the setting-up and maintenance of the Charity in the first twenty-four months will be reflected in its reserve policy with and increase to the above amount being considered annual operating expenses.

Plans for Future Periods

The core objective is (a) delivering the inaugural 2025 UK-based GAND Conference specifically targeting UK families and professionals in the field of neurodevelopment provision and (b) using the conference to fully engage with GAND-affected families and building a database for communication purposes.

To further increase the number of Trustees, as per the Charity's constitution.

Risk Management

The Trustees have reviewed their risk register (Governance, Strategic, Compliance, Operational, Financial, External and Reputational) which in turn shapes and influences the Charity in ensuring that appropriate controls are in place and to reduce exposure to misunderstanding, error and potential fraud.

Recruitment and Appointment of New Trustees

In line with Charity's constitution, the Charity added a fourth Trustee in meeting their obligation to reduce the risk of potential 'Conflicts of Interest' in addition to bringing in a wealth of experience in charity-associated activities.

Trustee Training

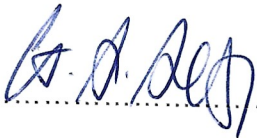

- (b) to which, in my opinion, attention should be drawn in order to enable a proper understanding of the financial statements to be reached.

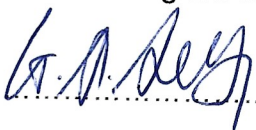

Achievement and Performance

The Charity is continuing with research into GAND Syndrome and other associated neurodevelopmental issues that are impacting UK families. And, using its personal experience and internal motivation to reach its intended audiences it is continuing to build its resource pool to support beneficiaries which in turn will help the Charity to build the necessary skills for delivery purposes.

Website

The Charity has created a formal website that provides in-depth details on (a) the rare genetic neurodevelopmental disorder (b) 'Our Story' detailing a family's GAND journey (c) resources links (d) 'Get Involved' and (e) activities and donation page. The website is continually updated with the latest news and features.

The website provides information on the most recent research i.e. "Gatad2b, associated with the neurodevelopmental syndrome GAND, plays a critical role in neurodevelopment and cortical patterning" and is permitted via open access article distributed under the terms of the Creative Commons CC BY license.

Social Media

The Charity uses Instagram to promote its activities with over 200+ followers. The use of logo-branded clothing images helps generate further communication reach through individual Facebook accounts and associated platforms.

The Charity subscribes to both the UK and European 'Rare Disease' day platforms (<https://www.rarediseaseday.org/friends/gand-aid-uk/>) and uses both platforms to promote its website. The Charity has 'become a friend' of EURODIS, which receives

funding from the European Union's Health Programme (2021-2027) to help promote the 'Rare Disease' day.

Press

The Mirror covered the Charity's founders' story "Girl, 3, gets rare diagnosis after mum noticed 'floppy' baby struggled to close her hand", which was also acknowledged and covered by the Rossendale Free Press.

Merchandise

The Charity has secured free clothing (i.e. hoodies) that carry's the GAND AID UK logo. The clothing was worn during fundraising events and activities in helping raise awareness.

Launch: Yorkshire 3 Peaks Fundraising Event

The Yorkshire 3 Peaks fundraising event was the main event both to launch the charity (media exposure) and generate income which in turn formed part of the largest donations to help kick-start the Charity's income stream. The Charity was further supported by two other UK charities ('Joining Jack' and 'Duchenne UK'), who kindly provided volunteers and promoted the event through their platforms.

Rare Disease Day (February 2024)

This annual event held in February is to promote awareness into rare diseases. The Charity's Trustees delivered a 2-day awareness campaign at their local General Practitioners and Barnsley Football Club created a feature in their match-day programme.

GAND Family Folder

With the support of Duchenne UK, the Charity has drafted a 'family information pack' that will be available both online and print, once completed.

International Networks

The Charity regularly communicates with 'Helping Hands' the United States charity for GAND Syndrome and shares its achievements, knowledge and information that impact on beneficiaries.

EURODIS, aside from the rare disease day campaign, is an organisation providing webinars on GAND Syndrome associated issues and the Charity's Trustees have accessed a number of online webinars, as part of a wider Trustees training approach.

The Charity has registered with the Cedars-Sinai Medical Centre (United States), which includes a focus into the study of rare neurogenetic disorders with an emphasis on the diagnosis of these type of disorders in patients.

Financial review

The results for the year ending are shown in the Statement of Financial Activities on page 10 and considered satisfactory by the Trustees

This is the Charity's first approach to fundraising and it will use this experience to map-out appropriate fundraising activities in achieving its financial goals.

Reserves Policy

At the year end the charity's funds were in credit by £18,781.28 consisting entirely of unrestricted funds generated through donations.

The amortisation of goodwill (£2,000) with regard to the setting-up and maintenance of the Charity in the first twelve-months will be reflected in its reserve policy with this amount being considered annual operating expenses moving forward.

Plans for Future Periods

The core objective of GAND AID UK is to identify and support UK families affected by the genetic disorder. It is continually promoting its charitable cause and establishing itself as a registered organisation and increasing its contacts with those suffering with GAND.

The Charity is committed to organising an inaugural 2025 UK-based GAND Conference specifically targeting UK families and professionals in the field of neurodevelopment provision.

It is the intention to calendar fundraising events and activities to further promote the Charity's cause and raise funds to support beneficiaries.

Inviting small grant bids from GAND-affected patients for support services i.e. physiotherapy that remain outside of mainstream provision.

To have a least one Charity-funded person complete an Animal-assisted Therapy Leader's course, to support and widen the Charity's offer to beneficiaries.

To increase the number of Trustees, as per the Charity's constitution.

Risk Management

The Trustees have reviewed their risk register (Governance, Strategic, Compliance, Operational, Financial, External and Reputational) which in turn shapes and influences the Charity in ensuring that appropriate controls are in place and to reduce exposure to misunderstanding, error and potential fraud.

Recruitment and Appointment of New Trustees

At the point of the CIO registration (i.e. application), it was stated that the nominated Trustees were best suited to initiate the CIO based both on their broader and professional experiences. At the start-up of the Charity, it was stated that no less than three (3) and no more than six (6) would be selected/elected as Trustees.

The existing Trustees are seeking to add a further three Trustees to reduce the risk of potential 'Conflicts of Interest' and will take responsibility for the appointment of Trustees in line with the Charity's constitution.

Trustee Training

The initial Trustees have prior experience of working with Charities; however, the Trustees are familiar with the Government's 'Welcome Pack' (since updated) and in particular guidance documents pertaining to:

- Charity reporting and accounting: the essentials November 2016 (CC15d)
- Internal financial controls for charities: protect your charity from fraud and loss (CC8)
