ACHIEVEMENTS AND PERFORMANCE

Mill End Community trust is in the process of negotiating with the Custodian Trustees for Methodist Church & the Managing Trustees of Berry Lane Church Council, a 10year lease for an agreed plot of land. Subject to planning permission this land is to enable the erection of modular buildings to be used by the community trust in line with its charitable purposes.

FINANCIAL REVIEW

The Trust has been in receipt of donations from supporters and has received interest from its bank account.

STRUCTURE, GOVERNANCE AND MANAGEMENT

The charity is governed by a constitution that was registered on 24th April 2023. The charity's activities are overseen by the committee of Trustees. The Trustees meet at least eight times in the year to monitor the efficient day to day running of the charity. There are no paid staff.


