Chairperson Report for period 01/04/24 - 31/03/25


Good evening and welcome to the second Reachout Birmingham AGM. In the last year Reachout Birmingham has built a strong foundation and was able to capitalise on its registered charity status. We have strengthened our relationship with Fareshare and Neighbourly who both donate surplus ambient food to our charity. We also formed a relationship with Greggs.

As a charity, I believe we are still adding value and delivering a valuable service to the homeless and vulnerable in Birmingham city centre.

During each outreach event we Serve approximately 80 hotmeals (40 vegetarian, 40 meat). We also provide sandwiches, pasties, snacks, cakes & hot/cold drinks as well as Warm clothing & male/female essential toiletries, Sleeping bags and emergency blankets.

In the event we should run out of food and we feel an individual is in need we will provide an emergency Greggs voucher which will provide them a hot drink, sandwich and cake.
