The trustees present their report with the financial statements of the charity for the year ended 31 March 2025. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015).





1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' EFA, the and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings, they have been allocated to activities on a basis consistent with the use of resources.

Tangible fixed assets

Tangible fixed assets are stated at cost or valuation less depreciation and any provision for impairment. Depreciation is provided at the following annual rates in order to write off the cost less estimated residual value of each asset over its estimated useful life.

Fixtures and fittings - 15% on reducing balance basis

The trustees have carried out a full impairment review in accordance with FRS 102, as a result of which no depreciation charge is made in respect of Freehold Property on the ground that the estimated residual value is not materially different from its carrying value in the Balance Sheet.

Taxation

The charity is exempt from tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

Significant activities

Holy Qurbana & Divine Service:

We had regular Holy Services every Sunday and on significant feast days at the Guild Church of St Margaret's Patten in London. Every Sunday, the morning prayers begin at 8.30 a.m., followed by the Holy Eucharist at 9:30 a.m. The Holy Liturgy is celebrated in Malayalam every Sunday, with the exception of the second Sunday, when it is held in English.

General Body Meetings:

In order to discuss and share various church-related issues and activities for the General Body to approve with suitable resolutions, five General Body meetings were held during the year.

Sunday school:

Over 33 kids in grades ranging from Reception to Year 12 attend the Sunday school, which has been operating at a high level. Classes are held on Sundays following the Holy Eucharist, and each class has a dedicated and capable group of teachers. Bible studies, song sessions, quiz contests, yearly exams, and other traditional Christian events are all part of it. The kids also took part in a variety of activities that the church hosted. On September 16 and 17, 2023, the Orthodox Vacation Bible Study (OVBS) was held at St Gregorios IOC, Brockley, with the theme "Abide in God" from St. John 15:4. A number of the kids competed in the Diocesan Level Talent Competition, with several of them winning.

Youth Fellowship

The Orthodox Christian Youth Movement (OCYM) conducted a variety of activities (both in study and worship), as well as church events such as the Senior Citizens and Youth Conference and the Parish Day Out; fundraising events throughout the year included a Cake Sale and a Manna Donation Drive, which partnered with The Trussell Trust (a food donation organisation) by donating items.

MMVS

The Martha Mariyam Vanitha Samajam (MMVS) group is a vital part of the church. They promote fellowship by holding monthly meetings and leading a variety of church activities. They participated in Lenten Bible readings and charitable fundraising events. They also plan the weekly fellowship meals as part of special events throughout the year.

Church Choir:

St George's IOC church choir is an important element of our Sunday worship, with great singers, instrumentalists, and composers stepping forward to represent the church as ambassadors. As a choir, they have represented the church in competitions and participated in many events throughout the year, including Easter, Christmas, and Patrons Day.

Patrons Day:

The feast of our Patron Saint St George was celebrated on April 22nd and 23rd, 2023, with an evening prayer and devotional message. Our Diocesan Bishop H.G. Dr Abraham Mar Stephanos was the chief celebrant, leading intercessory prayers, Holy Eucharist, and a procession outside the church to commemorate the occasion.

Outdoor Fellowship:

This year, we had our Outdoor Fellowship (Sangamam) on July 8, 2023, at St James Mar Thoma church hall in Eltham. The event began with morning prayers and included a variety of outdoor activities for people of all ages to partake in and feel fellowship and unity.

Harvest Festival:

Our Harvest Festival (Annual Thanksgiving) was held at St Margaret's Patten, London on October 1, 2023, following Holy Eucharist, with homemade Indian dishes for sale and items auctioned.

Senior Citizens Forum:

A spiritual well being for our senior members, included the Youth, who joined for a fellowship. Over 60 members attended the event on 23rd Sept 2023 at St Gregorios IOC, Brockley.

Parish Day:

The Parish day of St George's IOC was conducted on 7th Oct 2023 at Barking Cultural Centre where the event opened with a prayer and lighting of the lamp followed by various cultural performances, dances, songs and skits from all the groups both young and old.

Notes to the Financial Statements for the Year Ended 31 March 2024

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' EFA, the and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings, they have been allocated to activities on a basis consistent with the use of resources.

Tangible fixed assets

Tangible fixed assets are stated at cost or valuation less depreciation and any provision for impairment. Depreciation is provided at the following annual rates in order to write off the cost less estimated residual value of each asset over its estimated useful life.

Fixtures and fittings - 15% on reducing balance basis

The trustees have carried out a full impairment review in accordance with FRS 102, as a result of which no depreciation charge is made in respect of Freehold Property on the ground that the estimated residual value is not materially different from its carrying value in the Balance Sheet.

Taxation

The charity is exempt from tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.
