No achievements or performance metrics apply due to dormancy.


**Public Benefit**

**Statement of Trustees' Responsibilities**

They are also responsible for safeguarding the assets of the charity and for taking reasonable steps to prevent and detect fraud and other irregularities.

As a small charity, BEIT EZRA qualifies for exemption from independent examination under section 144(2) of the Charities Act 2011. The trustees acknowledge their responsibilities for ensuring that the charity keeps accounting records which comply with section 386 of the Companies Act 2006 (for CIOs) and for preparing financial statements which give a true and fair view.
