## Trustees' Annual Report

The trustees are pleased to present the Annual Report and financial statements for St. George Jacobite Syrian Orthodox Church Leeds for the year ended 31 December 2024. The Church continues to pursue its mission of advancing the Christian faith through regular worship, education, fellowship, and acts of charity within both the parish and the wider community. All activities during the year were carried out in accordance with the objectives of the Church's constitution and under the guidance of the Charity Commission of England and Wales.

Regular Holy Qurbana services and prayer meetings were held throughout the year, strengthening the faith and unity of parish members. 2024 also marked a special milestone with the celebration of the first English Qurbana on 28 April, offering greater inclusivity for younger members and families. House blessings were conducted in Leeds, York, Bradford, Keighley, Wakefield, Huddersfield, and Pontefract, ensuring pastoral care and spiritual fellowship across the parish community.

The Sunday School grew with the addition of new students, supported by creative learning initiatives. In January, the "Write a Verse a Day" activity encouraged children to engage with Scripture regularly. A Kids' Retreat, led by Fr. Reji Easow on 23 March, offered an inspiring day of spiritual growth and fellowship. The youth of the parish also participated enthusiastically in the MJSSA UK Kalolsavam held on 19 October, representing the Church with pride and commitment.

The Church organized numerous events to build fellowship among parishioners and promote togetherness. Major highlights included the UK Vanitha Samajam Conference on 6 April, the Perunnal Tri-Service celebration on 12 May, Vacation Bible School on 20–21 July, and Family Day on 26 August. The Family Retreat on 12 October provided an opportunity for reflection and renewal. The Christmas season was celebrated joyfully through carol visits held on 15 and 21 December across multiple towns, bringing warmth and unity among families.

As a faith community, the Church remained committed to its charitable mission throughout 2024. Key initiatives included a £1,000 contribution to the Anaah Daniel Appeal on 12 April and a £500 donation to Jayaprakash on 15 July. The Church also supported the Wayanad Appeal through the Onam Payasa Mela held on 8 and 22 September, conducted a Charity Walk on 1 June, a Blood Donation Registration Drive in November, and a Youth Charity Christmas Cake Sale on 8 December. These efforts reflected the parish's continued dedication to compassion and social responsibility.

The trustees extend their sincere appreciation to the Vicar, office bearers, volunteers, and all members of the congregation for their generosity, faith, and service. Their collective efforts enabled the Church to fulfill its mission effectively throughout 2024. With continued guidance from God, the parish looks forward to further strengthening its spiritual life, charitable work, and community outreach in the years ahead.

## **Independent Examiner's Report**

I report on the accounts of St. George Jacobite Syrian Orthodox Church Leeds for the year ended 31 December 2024, which are set out in the accompanying statements. ### Structure, Governance and management

The Church's Bylaw/Governing document is the constitution that has been submitted to the Charity Commission.

The charity is constituted as Charitable Incorporated Organisation.

Board of Trustees are elected by the Annual General Meeting.

Our Church, St George Jacobite Syrian Orthodox Church Leeds, is an integral part of the Universal Syrian Orthodox Church led by the Patriarch, the Supreme Head of Antioch and all the East, currently, His Holiness Mor Ignatius Aphrem II reigning the Apostolic throne of St.Peter. The Church also owes its allegiance to His Beatitude Mor Baselios Thomas I, the catholicos of the east (Malankara/India) and his successors, the regional head of believers. The Patriarchal Vicar (metropolitan in charge of UK) in consultation with the Patriarch governs and guides our church in the matters of faith. The vicar/priest of our church is appointed by the Patriarch through the Patriarchal Vicar. The Vicar for the time being shall automatically, by virtue of holding that office, be a Charity Trustee who chair over the meetings of Board of Trustees. The Annual General Body/meeting elects all the office bearers including secretary, treasurer, internal auditors and other board of trustees. All administrative and financial affairs of the church are managed and administered by the board of trustees. The maximum number of trustees will be 13 . The tenure of the elected board of trustees is 2 years.

The board of trustees meets regularly at least once in two months to deliberate and make decisions regarding the day-to-day affairs of the church including the approval of new membership applications and financial matters. A half-yearly general body meeting is also convened regularly. Strict rules are set out by the trustees for the spending and to regulate the use of funds. All Income and expenditure is budgeted at the beginning of the financial year. The accounts of the church are internally audited by the internal auditors, who are elected by the annual general body meeting.

TO FURTHER SUCH CHARITABLE PURPOSES FOR THE BENEFIT OF THE PUBLIC AS ARE EXCLUSIVELY CHARITABLE ACCORDING TO THE LAWS OF ENGLAND AND WALES AS THE CHARITY TRUSTEES MAY FROM TIME TO TIME DETERMINE.

Our worship services include gatherings of all believers from Leeds and surrounding areas. In these gatherings we pray to God, learn Bible, the faith and traditions of our Church through the informative sermons of our priests and lay leaders. We teach our forthcoming generations about these through Sunday School lessons, youth and women's association meetings. In these worship services the most important sacraments of Holy Eucharist, baptism and wedding are administered as well. Our worship services finish with agape meals offered by families to foster the aspect of sharing between us. The parish members in difficult situations such as sickness, bereavement, depravity, poverty and family problems etc. are given special care through the house visits, counselling and prayers by our priests and trustees. Sacraments such as anointing of the sick are done on such occasions. The poor and needy in the society (of any religion or community), especially in India are given financial support. The collections from Christmas Carol services are reserved for this purpose, in addition to the voluntary contributions or donations to the charity fund. At present the Holy Eucharist is celebrated every 2nd and 4th Saturday of all the months, in addition to the special services of Christmas, Passion Week and Parish day celebrations. The Sunday School lessons, Youth Associations and Vanitha Samajam (Women's Association) meetings are regularly organised after the worship services. Prayer meetings are conducted every Sunday and retreats are organised occasionally.

We give donations to applicants recommended by parish members, only after proper verification of the genuineness and their existing financial status. The applications are placed at the committee/board of trustees meeting and decisions are made after detailed discussions. The amount of payment is decided at the committee meetings. The volunteers sometimes give donations to the church for charity purposes, in certain special cases.

**Achievements and performance**

The Annual General Body meeting was conducted in the month of May, presided by the Vicar/Chair, Fr. Akhil Joy. The meeting had an appraisal of all activities of the church, including the progress of Sunday school, youth association and women's association (Vanitha Samajam). Our church has successfully welcomed many new families as our members and volunteers during the last year. The holy communion services were conducted regularly on every 2nd and 4th Saturday of all the months. Passion Week Services: Two holy week services were held successfully in this financial

year, first one during the Second week of April 2023 with Maundy Thursday services in the night of 5th April 2023 followed by Good Friday and then Easter services in the night of 8th April 2023. The Holy weeks were a great success and hundreds of believers attended the services including church members and people from other Christian denominations.

Parish Day and Crystal Jubilee: Parish Day and crystal jubilee celebrations were conducted in November 2023 led by parish Vicar who lead the holy communion services. The Holy Mass was followed by the holy communion and special devotional message, Prayers with incense, procession, benediction & love feasts.

The Sunday school, Youth and women's association (Vanith Samajam) annual day celebrations were successfully conducted in the evening of 8th July 2023. Christmas Programme: During Christmas celebrations, Carol visited Parishioners' homes on 9th and 16th December 2023. On 24th evening Christmas Mass and the Holy Eucharist were conducted by Vicar, Rev. Fr. Akhil Joy. He gave a Christmas message to parishioners followed by carol singing competitions by the Sunday School Students and youth.

Sunday school: We conducted Sunday School classes regularly after the Holy Mass. The Sunday school takes initiative to educate children with spiritual guidance and moral aspects of life in accordance with the teachings of Jesus Christ and the faith & traditions of the Syriac Orthodox Church. The students are encouraged to attend church regularly and to study the scriptures. Annual arts and cultural competitions were conducted and prizes were distributed to winners.

Vacation Bible School was organised in July 2023 for children to further deepen faith in Jesus Christ.

Youth Association: The Youth Movement members meets after the Holy Mass and have good discussions about issues involving moral ethics leading to personal spiritual development which helps them to be good future citizens. During the year, Youth Association organised payasamela and cake sale to raising funds for the charity.

Vanitha Samajam (Women's Association): The Women's Association is a prayer group of women and they meet after the Holy Mass. It also has a secretary as a leader. Their activities include prayer, singing devotional songs, Bible readings, conducting Bible quiz, chain prayer, Bible presentations and classes. We have made a charity donation of £ 400 to a cancer patient this year

**Financial Review**

The church reserves are held to fund its current and future activities.

Our principal source of fund is the monthly subscription from members and voluntary donations and contributions on special occasions like Passion Week, Christmas and Parish Day. The church is run by volunteers who are not entitled to any remuneration, except the Vicar's/priests' allowances for pastoral services. The church does not have sufficient funds currently to invest in long term investments. The available funds are held as cash in mainstream Bank.

## **1 Accounting Policies**

### **1.1 Accounting Policies**

The principal accounting policies adopted by the Charity, which is a public benefit entity, in the preparation of the accounts are as follows.

### **1.2 Basis of preparation**

These accounts have been prepared under the historical cost convention, as modified by the inclusion of charitable properties and fixed asset investments and investment properties at valuation.

These accounts have been prepared in accordance with "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)" (effective 1 January 2019) - (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Charities Act 2011.

These accounts are presented in pounds sterling and rounded to the nearest pound.

### **1.3 Going concern**

The Trustees have prepared financial projections, taking into consideration the current economic conditions and have, at the time of approving these accounts, a reasonable expectation that the charity has adequate resources to continue in operational existence for the foreseeable future. Thus they continue to adopt the going concern basis of accounting in preparing the accounts.

### **1.4 Income from donations or grants**

Income from donations and grants is recognised when the charity is entitled to the funds, the receipt is probable and the amount can be measured reliably. For donations, this is usually on receipt. For grants, this is usually when a formal offer is made in writing. If a donation or grant contains terms and conditions outside of the charity's control which must be met before the charity is entitled to the funds, or if the donor specifies that the funds must be used in future time periods, then the income is deferred.

### **1.5 Income from charitable activities**

Income from charitable activities is recognised over the period to which the income relates. Membership fees are recognised over the period of the membership. Any amounts relating to future periods are deferred.

### **1.6 Income from membership subscriptions**

Membership subscriptions received in the nature of a gift are recognised in Donations and Legacies.

Membership subscriptions which give a member the right to buy services or other benefits are recognised as income earned from the provision of goods and services as income from charitable activities.

### **1.7 Expenditure**

Expenditure is recognised when a present legal or constructive obligation exists at the balance sheet date as

a result of a past event, it is probable that a transfer of economic benefits will be required to settle the obligation, and the amount can be estimated reliably. It is inclusive of VAT which cannot be recovered. Direct costs are those costs which directly attribute to its activities. Wages and salaries are allocated to direct costs based on an estimate of time spent on charitable activities by staff members.

Support costs include staff costs and are those which do not produce a direct output. Staff costs relate to specific activities and this is reflected in the allocation of payroll costs based on the percentage of time spent.

All costs, including governance costs, are allocated between the expenditure categories of the charity on a basis designed to reflect the use of the resource. Costs relating to a particular activity are charged directly; others are apportioned on an appropriate basis.

Support costs and overheads have been calculated by allocating staff time to the level of involvement in the various activities of the Charity.

**1.8 Provisions for liabilities**

A liability is measured on recognition at its historical cost and then subsequently measured at the best estimate of the amount required to settle the obligation at the reporting date.

**1.9 Fund accounting**

Unrestricted funds are those funds which are available for use at the discretion of the Trustees in furtherance of the general objectives of the charity and which have not been designated for other purposes.

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors or which have been raised by the charity for particular purposes.
