2024 -25 ANNUAL REPORT TO THE CHARITY COMMISSION

1. REFERENCE & ADMINISTRATIVE DETAILS

The Friends of Sandford Parks (FOSP) is a Charitable Incorporated Organisation (CIO) that was registered on 22 May 2023, and its registered charity number is 1203191.

This report covers the accounting period from 1 September 2024 until 31 August 2025.

2. STRUCTURE, GOVERNANCE & MANAGEMENT

The Friends of Sandford Parks (FOSP) was established as an unincorporated membership group in 2014. The members conduct fundraising, litter picking and park maintenance activities. FOSP liaises with Cheltenham Borough Council and campaigns to preserve and enhance the parks' facilities. With revenue exceeding £5,000, it became necessary to register the organisation as a charity and, in May 2023, FOSP was registered as a Charitable Incorporated Organisation (CIO).

FOSP is an independent CIO and is governed by a constitution that closely follows the Charity Commission's Model Constitution for a CIO with a voting membership ('Association Model Constitution'). General Meetings for the membership are held quarterly, and the trustees meet every four to six weeks to manage the charity's activities. The Constitution requires a minimum of four trustees.

In August 2025, FOSP's membership included 86 subscribing members and 11 honorary members.

FOSP has no employees and does not own or lease any land or buildings. FOSP's assets are limited to cash funds plus materials and equipment. The total value of the materials and equipment is less than £200.

As FOSP's gross income is less than £500,000, the charity's accounts have been prepared on a receipts and payments basis and have been subjected to an independent examination.

3. OBJECTIVES AND ACTIVITIES

General

FOSP's objectives are to benefit the residents of Cheltenham and the surrounding area ("the area of benefit"), by providing, or supporting the provision of, facilities for recreation and other leisure activities in the interests of social welfare. The aim is to improve the quality of life for the local community, particularly, though not exclusively, through the preservation, promotion, support, assistance, and enhancement of Sandford Parks.

FOSP raises funds for park infrastructure, including lighting, exercise equipment, seating, table tennis tables, planting and horticultural restoration. Its members help with park maintenance and conduct regular litter picking. FOSP is currently campaigning to raise funds for installing heritage information signs and for upgrading the playground. FOSP liaises closely with Cheltenham Borough Council who own and manage Sandford Parks.

2024-25 Activities

The 2024-2025 financial year was another successful period for FOSP. Membership grew to just under 100, while volunteers continued to work tirelessly on litter picking and gardening, helping to keep both parks well-maintained and attractive. Community feedback has praised the improvements, noting that the two sections of Sandford Parks are looking better than ever.

This financial year has seen a strengthening of FOSP's reputation. Participation in the Mayor's Charities (2024-2025) involved members contributing to many events. Three of these were led by FOSP: Music in the Park, A Champagne Tea with Dame Prue Leith, and a community Celebration of Christmas at a local church. These contributed funds to the Mayor's Charity, from which FOSP benefitted to the amount of £17,775.

For the forthcoming year, FOSP has identified two major projects: upgrading the children's playground and raising awareness of the parks' long heritage. Work on both projects is already underway. As part of this heritage initiative, Heritage England requires FOSP to improve how the public is informed about the history of the parks.

4. ACHIEVEMENTS & PERFORMANCE

In spring 2025, the parks' Green Flag status was awarded for the second consecutive year.

Three events this year illustrate how diverse and successful FOSP can be. In November, the tea with Dame Prue Leith was glamorous, entertaining and delicious. It was run along the lines of a Cheltenham Literature Festival event, with a one-to-one interview, and questions being taken from the audience.

In December, the Celebration of Christmas involved a local primary school, the church and members of the public, sharing music, readings, carols, as well as homemade mince pies with mulled wine.

The greatest achievement was the Summer Festival on one of the hottest days of the year. The event attracted huge crowds and raised nearly £6,000 to kickstart the upgrade of the playground. The festival demonstrated how FOSP has built a reputation for delivering successful, responsible and well organised public events.

These three events show FOSP's diversity of skills and abilities to pull together different, but equally memorable occasions for the benefit of the local community.

5. FINANCIAL REVIEW

The total receipts for the year ended 31st August amounted to £29,823. This figure includes restricted funds totalling £19,365 and £10,458 in unrestricted funds. Restricted funds included £17,775 received from the Mayor's Charity and £1,090 donations for the Playground Project. The Summer Festival contributed £8,301 towards unrestricted income.

The total expenditure amounted to £2,714, of which £2,358 related to the costs of the Summer Festival.

Cash funds at the end of the financial year amounted to £2,802 in a current account, and £27,500 in a deposit account, totalling £30,302. This figure comprises £22,165 in restricted funds and £8,137 in unrestricted funds.

FOSP seeks to ensure that membership subscriptions are sufficient to cover general and marketing costs. For this financial year, subscription income was £589, and total administration costs amounted to £356.

The Reserves Policy is to ensure that there are sufficient unrestricted funds to cover general and marketing costs for at least six months. The Trustees consider that a reserve of £500 is sufficient for this purpose. Expenditure on charitable projects is always limited to the restricted funds that have been received.

6. FUNDS HELD AS CUSTODIAN TRUSTEES ON BEHALF OF OTHERS

Each charity project is separately accounted for, and the details are as follows:

Park Bench Project

In January 2024, FOSP received an £800 grant from Cheltenham Rotary and in May 2024, a donation of £2,000 was received from the Jockey Club's Gold Cup 100 Fund. These donations will be used to pay for two wooden park benches that were installed in late 2024. Payment will be made once all signage is complete.

Twinning Sign

A sum of £500 has been allocated for a Twinning sign, with payment to be made once the sign has been installed.

Playground Update

In July 2025, a donation of £17,775 was received from the Major's Charity, supplemented by individual donations totalling £1,090. At the year end, total funds raised for the project amounted to £18,865.

7. PUBLIC BENEFIT STATEMENT

The purpose of FOSP is to help ensure that Sanford Parks retain their amenity value for the health and benefit of park users and other interested members of the public. Membership of FOSP does not provide any privileges other than what is available to the public. Based upon the Charity Commissions Guidance document (PB1), the Trustees believe that FOSP has complied with section 4 of the 2006 Charities Act.

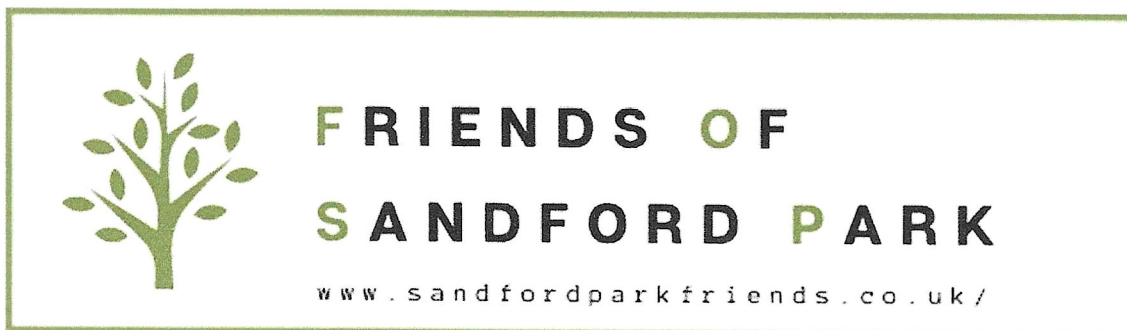

FOSP has no employees and does not own or lease any land or buildings. FOSP's assets are limited to cash funds plus materials and equipment. The total value of the materials and equipment is less than £200.

As FOSP's gross income is less than £500,000, the charity's accounts have been prepared on a Receipts and Payments basis and have been subjected to an independent examination.

3. OBJECTIVES AND ACTIVITIES

General

FOSP's Objectives are for the benefit of the inhabitants of Cheltenham and the surrounding area ("the area of benefit") to provide or assist in the provision of facilities for recreation and other leisure time occupation in the interests of social welfare with the object of improving their conditions of life for the inhabitants of the area of benefit in particular but not exclusively by the preservation, promotion, support, assistance and improvement of Sandford Parks.

FOSP raises funds for Park infrastructure such as lighting, exercise equipment, seating and table tennis tables. We also raise funds for planting and horticultural restoration. Our members help with park maintenance and conduct regular litter picking. We are currently campaigning to raise funds for installing heritage information signs and for upgrading the Sandford Park playground. FOSP liaise closely with the Cheltenham Borough Council (CBC) who own and manage the Sandford Parks.

2023-24 Activities

The Friends of Sandford Parks (FOSP) has experienced a successful 2023-24 financial year. Our membership numbers have increased, as have our local helpers who volunteer for monthly gardening and for fortnightly litter picking. Our local community has expressed thanks and pride in the care of their two local parks. FOSP has raised its profile through regular newsletters and social media, resulting in being a respected voice in the community. It is one of the four chosen charities to contribute to and benefit from the Cheltenham Mayor's fundraising.

Since May 2023, we have seen the installation of Phase One Fitness equipment, consisting of four items of outdoor exercise equipment. This phase was secured via a grant of £2,000 from the CBC Coronation fund and £4,770 from the funds that were transferred from the FOSP Membership Group to the FOSP CIO in May 2023. The success of Phase One was followed by further fundraising for Phase Two, bringing in additional funds of £7,087 which purchased additional mobility and wheelchair accessible items. We wish to express our particular thanks to the Gloucestershire Disability Fund and to Cheltenham Round Table for their grants of £2,500 and £3,200. FOSP provided a further £1,386 using the surplus from our 2022 Jubilee Jolly event.

We responded to a community request, conducted careful research and applied for funds to enable the 'Safer Sandford' lighting project to take place. The award of a grant for £13,000 from the Cheltenham Neighbourhood Community Infrastructure Levy Fund 2023 was matched by a grant of £13,000 for Safer Streets from the Office of the Police Crime Commissioner (OPCC) plus a contribution of £3,000 from Gloucestershire County Council (GCC). The result is six new streetlights which line pathways and make the park routes safer after dark.

A further grant of £7,400 was awarded from GCC's Build Back Better fund for the installation of security bollards at park entrances. These became important after several incursions by travellers who had taken up residence in Sandford Park.

Our thanks also go to the Jockey Club's Gold Cup 100 Fund for £2,000 for new park seats and to Cheltenham North Rotary Club for their £800 donation towards seating. Cheltenham North Rotary Club also donated purple crocus bulbs which were planted by pupils of St John's School in the autumn of 2023. More were added last autumn as part of Rotary's campaign to eradicate polio across the world.

FOSP is one of the Mayor of Cheltenham's (2024-25) charities and as such, is involving our members in several activities. A large music event in the park was held in September 2024 but some of the revenue and expenditure relates to this financial year. Similarly, an event involving Dame Prue Leith is led by FOSP but will be reported next year. It has been an active period for the Friends of Sandford Parks and marks our first accounting year as a registered charity. Our aim is to enhance opportunities for all our

local community, regardless of age and ability, in order that they may benefit from local resources. We are proud to be achieving these aims and bringing added value to our local community.

4. ACHIEVEMENTS & PERFORMANCE

During the 15-month accounting period, we applied for and received restricted grants totalling £30,900. Our other receipts totalled £8,834. We contributed £33,560 to five separate projects within the Sanford Parks. In May 2023, we received £6,758 as the balance of funds from the FOSP Membership Group and at the end of the accounting period we had a balance of £4,797, including £394 in our general account.

During this financial period, our subscribing membership increased from 64 to 74. Our members completed numerous litter picks, monthly park maintenance activities and during the last three months, they were involved in preparing for the Music event that was held in Sandford Park (East) on 8 September 2024.

In 2023, Sandford Parks secured a national Green Flag award, and a new flagpole was erected in early 2025. We now hope to work with Cheltenham Borough Council to secure Green Heritage status in 2025.

5. FINANCIAL REVIEW

The total receipts for the accounting period up to 31st August amounted to £39,734. This figure includes restricted funds totalling £38,575 and £1,159 in unrestricted funds. Included within these figures are £6,157 in restricted and £601 in unrestricted funds received in May 2023 from the previous FOSP Membership Group.

The total expenditure amounted to £34,937, including £33,560 of restricted funds that contributed to five projects within the Parks. £611 of restricted funds were used for fundraising expenses and £766 of unrestricted funds were spent on publicity and administrative expenses.

Cash funds at the end of the financial year amounted to £4,797. This figure is comprised of £4,404 in restricted funds and £394 in unrestricted funds.

FOSP seeks to ensure that membership subscriptions are sufficient to cover our general and marketing costs. However, for this financial year our subscription income was £448, and our total unrestricted costs amounted to £766.

Our Reserves Policy is to ensure that there are sufficient unrestricted funds to cover general and marketing costs for at least six months. The Trustees consider that a

reserve of £200 is sufficient for this purpose. Expenditure on charitable projects is always limited to the restricted fund that have been received.

6. FUNDS HELD AS CUSTODIAN TRUSTEES ON BEHALF OF OTHERS

Each charity project is separately accounted for, and the pertinent details are as follows:

Exercise Equipment Project – Phase I

In May 2023, we received restricted funds for this project from the previous FOSP Membership Group in the sum of £6,157. These funds were comprised of £3,357 raised from the Jubilee Jolly event held in June 2022, a surplus of £1,800 from their Table Tennis project and £1,000 in private donations. In July 2023, we also received a grant of £2,000 from CBC's Coronation Fund.

In September 2023, four items of outdoor exercise equipment were installed in Sandford Park (East) at a cost of £6,770, leaving a balance of £1,387 to help fund Phase II of this project.

Safer Sandford Lighting Project

In August 2023, we were advised that FOSP's grant application to the Cheltenham Neighbourhood Community Infrastructure Levy (CIL) Fund had been successful. FOSP were awarded £13,000 towards the Safer Sandford Lighting project. This project resulted from several years of campaigning for improved lighting within the park and involved the installation of six new lights. The installation work was carried out by Gloucestershire County Council (GCC) in March 2024 at a total cost of about £29,000.

To avoid liability insurance costs, the FOSP award funds were held in trust by CBC until payment was made to GCC in April 2024.

Security Bollards Project

Due to the intrusion of unauthorised caravan campers within Sandford Park (East), a project for installing additional security bollards was quickly arranged and FOSP received a successful grant application from the CBC's Build Back Better fund in the sum of £7,400 in February 2024. This amount was paid to CBC after they had completed the installation work in March 2024.

Exercise Equipment Project – Phase II

Phase II of this project involved the installation of four additional items of outdoor exercise equipment, three of which are designed for disabled users. The contract cost for installing this equipment amounted to £7,829. A total of £7,087 was raised by FOSP for this phase of the project. This sum is comprised of a grant of £2,500 from the Gloucestershire Disability Fund,

a grant of £3,200 from Cheltenham Round Table (CRT) and £690 from the residual funds from Phase I. CBC paid the balance of the invoiced costs in the sum of £742. The CRT grant was paid directly to CBC.

In December 2024, FOSP's remaining balance of Phase I funds, in the sum of £697, was paid to CBC as a contribution towards the cost of providing signs for usage instructions and donor recognition.

Park Bench Project

In January 2024, we received an £800 grant from Cheltenham Rotary and in May 2024 we received a donation of £2,000 from the Jockey Club's Gold Cup 100 fund. These sums will be used to pay for two wooden park benches that were installed in Sandford Park (West) by CBC in late 2024.

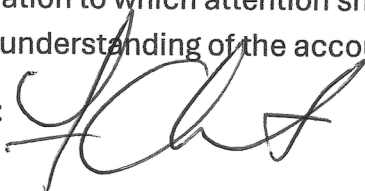
Independent examiner's statement
