We are a community workshop serving Fressingfield and the surrounding villages, dedicated to woodworking, modelling, gardening, crafts, fibre work and repairing. Our mission is to encourage skill-building, well-being and community through traditional crafts and making activities whilst also promoting environmental sustainability through reuse, repairing and gardening.

We encourage our members to participate in a wide range of activities. Members are encouraged to share their knowledge and also to learn from others while working on projects in the community workshop. We run classes for those who want to focus on skills building in a wide range of topics. Where we have to charge for classes, members can often enjoy a substantial discount.

Our shed, located by Fressingfield Methodist Chapel, is being restored and improved by our members and is very well equipped thanks to grants and donations. Facilities include workshop, kitchen and meeting space. Within the coming year we aspire to have all areas accessible to those participants who require disabled access.

Community is at the heart of everything we do and the wellbeing of our members is central to that. In our first year we are delivering at the rate of 2400 hours of care per annum. From community gardening to making and repairing, together, we are creating a vibrant and sustainable community.

We would like to thank all of our members who have participated and worked incredibly hard over the last 10 months to make our shed such a viable and vibrant space.




