## **Activities and achievements**

Gurdwara carries out a wide range of activities in pursuance of its charitable aims

### **Religious activities**

During the year under review we offered a range of religious activities

Prayers: Gurdwara is opened all day everyday. With morning and evening prayers 50-60 people attend during weekdays 350-400 people attend on Saturday and Sunday Free food is provided daily

Festivals: All festivals are celebrated with three days special prayers (Akhand Patth) 300-500 members attend these festivals depending which day of the week main day falls

Funerals Service: Full religious services are provided by the Gurdwara. Special guidance is made available to family needing guidance

Anand Karaj and civil marriage: A full services are provided of Anand Karaj is available taking with civil marriage facilities Fully qualified Priest and Marriage Registrar are provided for thieves services

Sri Guru Granth Teaching: Free teaching of reading and understanding were available by qualified Gyani.

Working with council and local police: Special meetings were held with officers with lengthy discussions on understanding our duties and awareness of our requirements took place
