The Trustees of 'Rebuilding The Flock' present their annual report and unaudited accounts for the year ending 31 March 2025 and confirm they comply with the requirements of the Charities Act 2011, the trust deed, and the Charities SORP (FRS102). The unaudited financial statements have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the Charity's constitution, the Charities Act 2011, the Companies Act 2006 and the Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015).

### **REVIEW OF ACTIVITIES AND ACHIEVEMENTS**

During the year ended 31 March 2025, RTFLOCK continued to advance its charitable objectives through community support, faith-based outreach, and leadership development. All activities were undertaken in furtherance of the charity's mission and in alignment with its strategic pillars of Rebuilding, Restoring, Raising, and Repairing, inspired by Isaiah 58:12.

Trustees have had due regard to the Charity Commission's public benefit guidance in planning and delivering these activities.

### **KEY ACTIVITIES AND OUTCOMES**

#### **1. Relief of Poverty and Support for the Vulnerable**

The charity provided practical and pastoral support to widows and individuals experiencing financial hardship. Assistance included material aid, community support, and ongoing engagement aimed at reducing isolation and improving wellbeing.

These activities relieved poverty, supported vulnerable individuals, and promoted dignity and social inclusion.

## 2. Advancement of the Christian Faith Through Creative Expression

The charity financed music projects that promote the Christian faith and communicate the message of Jesus Christ. These projects were used as outreach tools within the community and during organised events.

The projects advanced the Christian faith through accessible and culturally relevant means, encouraging spiritual engagement and participation.

## 3. Community Evangelism and Outreach

A coordinated evangelism drive was undertaken to engage members of the local community. Activities included outreach initiatives, faith-based events, and personal engagement designed to encourage spiritual reflection and participation in community life.

The programme supported spiritual wellbeing and fostered community cohesion through shared values and positive engagement.

## 4. Promotion of Fellowship and Community Cohesion

The charity facilitated small-group gatherings within members' households, centred on shared meals and fellowship. These gatherings strengthened relationships, encouraged mutual support, and provided informal pastoral care.

These activities reduced social isolation, strengthened community bonds, and supported emotional and spiritual wellbeing.


## 5. Training and Development of Bible Study Teachers

We have been able to develop deeper relationships within the community and with other churches and organisations outside of the community.


Our social media initiatives have also garnered a lot of engagement, and we look forward to further improvements in the coming months and years.


