Independent Examiner's Report to the Trustees of Euro Bangla Welfare Association

I wish to confirm that I have undertaken an independent examination of the Statement of Accounts for the Euro Bangla Welfare Association under section 43(3) of the Charities Act 1993 for 2023/2024.

Respective Responsibilities of Trustees and Examiner
