Despite the decrease in income from the previous financial year, from £19,600 in 2004 to £16,250, there was a significant increase in adherents. We were able to continue our community projects with expenditure totalling £5,480. Although this was lower than the previous financial year's community project expenditure of £8,620, we maintained our commitment to supporting the community.
