The Foundation aims to use cricket and related community activities to improve wellbeing, particularly for older people and those living in care homes in and around Stowupland and Stowmarket.

Achievements and Performance

During the period the charity supported several small-scale community events. Total expenditure on charity-funded events amounted to £420.

Financial Review

Total income for the period was £703.32, consisting of personal donations of £303.32 and corporate donations of £400.00.

Total expenditure was £420.00, resulting in a surplus of £283.32 for the period.

Reserves Policy

The trustees aim to maintain modest reserves to support future charitable activity and manage financial risk.

Plans for the Future

The trustees plan to increase engagement with care homes and community groups, develop fundraising activity, and deliver further cricket-based wellbeing initiatives.
