## **Report of the Trustees**

### **for the Year Ended 31<sup>st</sup> May 2024**

The trustees present their report with the financial statements of the charity for the year ended 31<sup>st</sup> May 2024. #### **Objectives and activities**

##### **Objectives and aims**

The objectives of the charity are to advance the education of school age children in Kenya through the establishment of an educational institution – the provisions for the improvement and maintenance of existing educational facilities.

Directed by the trustees, the charity researched funding sources and building project costs during the period.



